The action I wish the Council/Committee to take:

1. Approve recommendation for free bus provision for pupils travelling from Torry, as recommended by officers in option 2a.
2.
  - a. Instruct further investigation into a dedicated bus provision (and/or)
  - b. Instruct further investigation into extending the proposed supported public service (as recommended in option 2a) to include capacity for ALL children within Torry, where there will be pick up points within Torry community and ALL Torry pupils are transported within Lochside Academy school grounds.
3. Instruct further investigation into funding available for regeneration areas such as: access to leisure/ regeneration budgets/grants to allow an extension to proposed transport provision 2a. to ensure accessibility of school/school community facilities beyond the suggested 7am-6pm provision ie. evenings, weekends and school holidays.
