

REVIEW OF ALLOWANCES

The Committee had before it a paper by the Chief Officer - Finance which (a) provided information concerning (1) the amount of allowances paid from the Guildry fund to Burgesses of Guild, widows and widowers of Burgesses and children of Burgesses from 2007 to 2017; and (2) the number of people receiving allowances for the same period; and (b) proposed that the allowances be increased by either 3% or 5% rounded up to the nearest £5, backdated for 2018/19.

Ms Aileen Duncan, Assistant Accountant, advised the Committee that she had been unable to update the increase in the pension rate due to information being outstanding.
