Agenda Item: 11.2 – Anti Modern Slavery Report Sharing my research on Modern Slavery with commitee members/participants or the meeting planned on 30th May 2024.

The action I wish the Council/Committee to take:

I am a professor of sustainability accounting and transparency at the University of Aberdeen. Currently, I am leading two research projects on modern slavery within global supply chains. I would like to share my research on Modern slavery with members for the meeting planned on 30th May 2024 for Communities, Housing and Public Protection Committee.

Our research would be relevant for the council from the following angles: a) Procurements of any kind such as PC, garments for council staff, catering, industrial materials (wood, bricks, tiles, etc.) from overseas suppliers. It is import that the council ensures that there is no forced labor and exploitation during production/supply chains.

b) The council's policy influence over businesses and partners operating in its jurisdiction. It is important to assure that businesses are free from modern slavery and human rights risks.

Meanwhile, I have submitted 'A Response to The Call for Evidence Launched into The Impact of The Modern Slavery Act 2015' to the House of Lords Committee. They are currently reviewing the impact of the Act so far.

Agenda Item: RAAC Funding Update - May 2024

The action I wish the Council/Committee to take:

1.Acknowledge that Aberdeen City Council (ACC) actively encouraged and guided homeowners to purchase properties in Balnagask under the Right to Buy scheme. Their officers presented this opportunity as a means to create a lasting legacy for descendants and achieve equitable homeownership.

2.Recognize the failure to meet the objectives of the Right to Buy scheme. Acknowledge joint responsibility with the Scottish Government for selling properties that have now become financial and safety liabilities.

3.Commit to implementing a similar process as West Lothian Council, which opened their buy-back system to RAAC homeowners. Additionally, pledge to arrange a meeting with Housing Minister Paul McLennan MSP to seek funding opportunities for affected homeowners. Continue to advocate for Scottish Government funding for homeowners.

4. Introduce rent pressure zones for newly built developments in the Balnagask area. This initiative ensures that prioritized council tenants, who are forced to relocate, can expect rental rates similar to their current payments upon return. Ensure the availability of relocation grants to cover return costs.

5. Increase the grants available to council tenants compelled to move. For instance, Basildon Council currently provides £8,860 in relocation grants, setting a precedent for appropriate financial support in similar circumstances.

#### **Our Purpose**

The Board will develop and monitor the implementation of strategies, policies and plans designed to ensure a housing supply which matches the needs of the city and that the councils own housing stock is energy efficient and well maintained. In doing so the Board will consider all internal and external factors to the Council to fully understand the current and future housing environment and its potential impact on the Council and the place of Aberdeen.

The Housing Board will monitor the delivery of housing related commissioning intentions and overseeing improved performance against agreed service standards and KPIs.

The Group will also lead on the delivery of the Council's response emerging issues e.g. managing the presence of Reinforced Autoclaved Aerated Concrete (RAAC) following the immediate response. The Group will also lead work encompassing both Public Buildings and Council Housing and oversee fire safety arrangements, following the conclusions from the Grenfell Inquiry.

#### **Our Responsibilities**

#### Provide strategic direction and stewardship for all housing related activity.

- Oversee and consider the output from the Housing Needs Demand Assessment (HNDA).
- In collaboration with the Strategy Board, approve the Local Housing Strategy and 30 year HRA Business and Asset Management Plan.
- Develop/commission a performance dashboard.
- Oversee a master programme plan and report progress against milestones

# Scrutinise performance against the Scottish Housing Regulator standards, ACC's service standards and key performance indicators through a Performance Dashboard

- Improve the utilisation of the council housing stock
- Improve allocations
- Monitor delivery of the housing capital programme including new builds.
- Monitor implementation of the planned maintenance programme, including retrofit.
- Decrease voids
- Improve repairs response times
- H&S and cyclical maintenance performance including fire safety

# Provide strategic direction and stewardship to all work relating to the Council's response to RAAC in our estate (following the conclusion of our initial response)

- Manage the budget assigned to support the response to RAAC in the Council's estate.
- Procure and appoint the required consultancy, design and implementation work as necessary.

 Ensure engagement with tenants, owners, and all key stakeholders, and manage their influence and expectations.

Help remove blockages and make key decisions on emerging issues and risks.

Ensure appropriate capacity and capability is in place to deliver, and where necessary, prioritise
resources as required to manage risks to the point of deescalation eg RAAC.
