Deputation request from Alasdair Ross, AVA & ACVO Policy & Consultations Officer, in relation to agenda item 8.2:-

I'm writing to request the opportunity to address the Finance and Resources Committee on 5th November 2024 in relation to item 8.2 "Medium Term Financial Strategy for the Council's General Fund, 2024 - CORS/24/283 - Council of 11 October 2024".

ACVO would like Members to consider the Third Sector's response to Phase 1 of the Council's budget consultation which can be read at this link: Third Sector Response to Aberdeen City Council's 2025/26 Budget Consultation: Phase 1 - ACVO TSI and to acknowledge our recommendations within the Committee's decision on the report before them. Namely:

- 1) Uncomfortable and serious whole-system discussions between the Council, other public agencies and the third sector are required to prevent catastrophic loss of services. A long-term strategy for funding and supporting the third sector is needed, recognising its vital role in addressing social challenges.
- 2) The sector is asking that our work is valued, both in terms of respect for the work we do, but valued financially for the impact it has. Charity is not free.
- 3) Involve the third sector in the decision-making process, not just in the consultation process, to ensure that their needs are built into the outcomes. Organisations who may be affected by proposals should be offered a direct line into the process so that a very clear picture of impact can be understood by the Council in detail.
- 4) Acknowledgment that communities cannot replace public services or mitigate their loss without the financial resources to do so.
- 5) Cuts and service reductions that impact vulnerable communities should not be considered. It is a false economy and will drive even more demand to our stretched and underfunded third sector services.

1. PURPOSE OF REPORT

1.1 To seek approval for travel and attendance at European engagements in November and December 2024, proposed as alternatives to travel previously approved in the International Travel 2024/25 report, COM/24/029, at Finance and Resources Committee on 30 January 2024.

2. RECOMMENDATIONS

That the Committee:

- 2.1 Approves international travel and overseas conference attendance to support City Development and Regeneration activity as detailed below, and subject to the maximum expenditure set out in paragraph 4.1:
 - a) One Elected Member plus one officer to attend European Hydrogen Week in Brussels, Belgium between $17^{th} 22^{nd}$ November 2024; and
 - b) One officer to attend JIVE/REVIVE Demand Aggregation Workshop in Groningen, Netherlands between 3 4 December 2024;
- 2.2 Delegates authority to the Chief Officer City Development and Regeneration to authorise necessary and appropriate travel documentation and associated expenditure for the travel noted in 2.1 above, provided costs do not exceed the budget referred to in paragraph 4.1 of this report and that all arrangements are made in line with current Council travel policies; and
- 2.3 Agrees that the outcomes of the overseas activity proposed in 2.1 will be provided to this Committee by way of the planned annual Service Update in March 2025.

3. CURRENT SITUATION

International Travel 2024/25

- 3.1 International travel deemed effective to support the projects and activity of City Development and Regeneration through the 2024/25 financial year was proposed to Finance and Resources Committee in January 2024, and approved subject to the budget setting exercise in March 2025.
- 3.2 Of this approved travel, officers have since received advice that attendance at the Hydrogen Dialogue Summit and Expo in Nuremberg, Germany is unlikely to align or deliver additionality for Aberdeen City Council and the wider region's hydrogen activity and ambitions. The alternative travel proposed in recommendation 2.1 is more relevant to ACC's current hydrogen activity and attendance offers the opportunity to demonstrate commitment to the Hydrogen Valley bid submitted in April 2024, TH2ISTLE. The European Commission are hosting a week-long event in Brussels - 'European Hydrogen Week'. The Council are members of Scotland Europa who are based in Brussels and have advised that it would be strategically advantageous to be present at the event. Scotland Europa have also prepared an itinerary of meetings with significant partners whilst there. These meetings will be jointly held by the Co-Leader of the Council, Councillor Allard, and the Acting Minister for Climate Action Dr Allan. Strategic discussion and promotion of the region will enable increased engagement with our established European partners and potential partners. Aberdeen City Council, as lead partner along with 30 others submitted a formal bid to the EU Clean Hydrogen Partnership's small valley call for €9 million funding, which is additional to that committed by other private and public sector sources. More than 50 letters of support were provided as part of the bid, demonstrating strong evidence that the TH2ISTLE project is key to the development of a hydrogen market in the region and nationally in Scotland and the UK. The Hydrogen Valley would deliver new and interconnected activities to make, move and use green hydrogen in Aberdeen City and the wider region.

ACC have been invited to present and share findings and insights derived from direct experience of implementing hydrogen technology in the City; particularly deployment of hydrogen fuel cell buses through the JIVE project and a fuel cell waste truck through the HECTOR project. The workshop will focus on the potential for hydrogen vehicles in cities, sharing the lessons learnt from deployments of hydrogen refuse trucks and buses across Europe. The audience will comprise a range of local and European stakeholders interested in hydrogen technologies including local authorities and policy-makers. This workshop will be attended by the Clean Hydrogen Partnership, offering a unique opportunity to present Aberdeen's success directly.

3.3 To appraise the benefits of international engagement and activities, including the overseas travel and conference attendance proposed to support these activities, the following criteria is considered:

- Engagement aligns with and reflects relevant aspects of the Regional Economic Strategy. This may be through the opportunity to promote regional strengths (energy, skills, entrepreneurship and innovation); to address regional challenges (economy diversification; skills and labour supply; city centre redevelopment); to support delivery of objectives; or to progress growth and internationalisation of key and nascent North East industries (energy, food and drink, finance and business services, tourism, creative, digital and life sciences).
- 2. Engagement creates opportunities to attract inward investment to Aberdeen, again in line with the Regional Economic Strategy.
- 3. Where appropriate, overseas travel is supported by Scottish Development International (SDI), Department for Business and Trade (DBT), Scottish or Aberdeen and Grampian Chambers of Commerce and/or city stakeholders (e.g. Opportunity North East, Net Zero Technology Centre, Energy Transition Zone Ltd).
- 4. World Energy Cities Partnership (WECP) attendance at AGM and Board meetings.
- 5. Activity with Memorandum of Understanding (MoU) partners where attendance by Elected Members is requested and has been discussed with Co-leaders.
- 3.4 Based on this criteria, the overseas travel proposed in 2.1 aligns as below:
 - 1. Under criteria 1, 2 and 3: European Hydrogen Week
 - 2. Under criteria 1: JIVE/REVIVE Demand Aggregation Workshop

4. FINANCIAL IMPLICATIONS

4.1 Committee approval is required for the proposed travel at 2.1, with estimated costs totalled below. These costs will be met from within the approved International Trade, City Development and Regeneration budgets for 2024/25 and approved hydrogen project budgets. There is no ask for additional financial support for international travel.

5. LEGAL IMPLICATIONS

- 5.1 Scottish Government guidance details that travel and subsistence expenses may be claimed by Elected Members for approved duties, including "the carrying out of any other duty approved by the local authority, or anything of a class so approved for the purposes of, or in connection with, the discharge of functions of the local authority or any of its committees or sub-committees."
- 5.2 Local authorities have a statutory duty to secure best value as per section 1 of the Local Government in Scotland Act 2003. The Council has travel policies for both members and officers. All travel should be booked in accordance with these policies to ensure cost-effective travel arrangements.

6. ENVIRONMENTAL IMPLICATIONS

6.1 The report recommendations have a negative environmental impact, namely an increase in carbon emissions due to air travel. To minimise this, all meetings to fulfil MoU commitments take place virtually, and where travel is proposed as necessary, the itinerary will be full and valuable. Consideration could also be given to minimising the carbon footprint when booking travel - e.g. booking a train rather than a flight for any in-country connections where possible and the itinerary allows, or booking 'green' airfares only.
