PURPOSE OF REPORT

To inform Council of the options available to expand Aberdeen's Winter Festival into Union Terrace Gardens, to seek approval for recommendations aimed at providing additional programme activities and to confirm plans for Aberdeen's Hogmanay Celebrations.

2. RECOMMENDATION(S)

- 1. That Council notes the content of this report.
- 2. To confirm Council's support for Aberdeen's Hogmanay celebrations in 2013, as detailed in this report.
- 3. That Council approves the inclusion of a Xmas Tree, Santa's Grotto, Temporary Stage and supporting entertainment programme and additional Festive Light Switch-On activity in Aberdeen's Winter Festival programme in Union Terrace Gardens.

3. FINANCIAL IMPLICATIONS

Aberdeen City Council's Finance and Resources agreed that up to £200,000 would be available in 2013 to support the enhancement of Aberdeen's Winter Festival and the delivery of Aberdeen's Hogmanay celebrations.

Following discussions with members, detailed below are outline costs associated with the options identified:

Developing Festive/Community Content in Festive Light Switch On Parade

Inclusion of 5 new additional elements*	£5,000

Costs are approximate and will differ depending on agreed period of installation. Our costs are based on hire from 25 November 2013 – 5 January 2014.

^{**}Costs include transportation, installation and dismantling, power, licences, barriers, storage if agreed to purchase etc.

^{***}Inclusion of a programme of activity in support of the Grotto that will make interaction with the installation an experience for children.

The total of all activities identified is £97,200 before additional essential expenditure on securing the infrastructure in and around the Union Terrace Gardens site and marketing and promotion relating to the additional activities included in Aberdeen's Winter Festival.

4. OTHER IMPLICATIONS

As detailed in the original report, it is essential that monies are invested in Union Terrace Gardens going forward to bring the site into better use in the coming years.

This is not an exhaustive list but the securing of the balustrade and arches, lighting in and around the site, ingress and egress, power supplies, hard standing and toilet facilities need to be addressed so the site can be better used as an event venue.

A separate report from the appropriate service should be provided to committee in the future for consideration.
