#### ABERDEEN LOCAL LICENSING FORUM

#### MINUTE OF FORUM MEETING HELD ON 9 SEPTEMBER 2010

**1.** The Forum had before it the minute of the meeting held on 9 September 2010.

With reference to Article 12 of the minute (Alcohol Awareness Week), the Forum was advised that there had not been a visit from an MSP, but that organising Committee members had been present. "How Much Do I Drink?", a confidential drinks diary, was launched during Alcohol Awareness Week.

#### The Forum resolved:-

to note the relevant updates and approve the minute.

#### STATISTICAL INFORMATION

**2.** The Chairperson asked if the representatives present had any statistical information they wished to share with the Forum.

Inspector John Soutar notified the Forum that he was in a position to obtain certain statistical information for future meetings of the Forum if it was made clear what they were looking for.

Items highlighted by the Forum included:

- Incidents in city centre within or outwith licensed premises.
- Trends / changes for example, new licences granted.
- Number of serious assaults / reviews.
- Information on designated places within the city centre.

Mark Donlevy of UNIGHT provided an update to the Forum. He advised that they had recently contacted both universities to invite representatives to the Group. He also advised that Cocaine Awareness Week was imminent and that they would be working alongside the Crime Prevention Unit and taxi trade over the festive period. UNIGHT have a joint meeting with the Licensing Board on 24 November to discuss members' issues and concerns. He also advised the Forum of the ongoing list of

members of the public who are banned from all UNIGHT premises. Currently there are fifteen individuals on the list, with thirteen bans expiring in October. The scheme is seen to be effective. The membership of UNIGHT was then discussed. Issues raised include irresponsible promotions by non members undercutting members' prices meaning it appears more profitable to not be a member, perceived image of no action by Licensing Board sending wrong signal to premises, and the precedent of deemed acceptable operating standards.

The Clerk advised in terms of statistical information from the Licensing Board, that this would only be provided when the Board had requested certain types of information from the Council or another local authority. As such information had not been requested by the Board, there was no information to provide to the Forum at present.

#### The Forum resolved:-

to note the relevant updates.

#### WORKPLAN

**3.** The Forum had before it the workplan of the Local Licensing Forum. The Convener went through each issue on the workplan and updates were noted.

#### The Forum resolved:-

- (i) for the Clerk to update the workplan as agreed; and
- (ii) to note the relevant updates.

#### UPDATE FROM LICENSING BOARD

4. The Forum had before it a list of decisions of the Licensing Board in respect of licenses which had been granted over the last period. Questions were once again raised as to whether there was scope for the Forum to receive further information. The Clerk advised that the Licensing Board published their agendas and minutes on the Aberdeen City Council website, <u>www.aberdeencity.gov.uk</u>. The Forum agreed to include these public documents in the Forum's agenda next time.

#### The Forum resolved:-

to include the most recent agenda and minute of the Licensing Board in the agenda for the next Forum meeting for information.

#### UPDATE FROM LICENSING STANDARDS OFFICER

**5.** This item was withdrawn due to apologies from the Licensing Standards Officer.

#### **MEETING DATES FOR 2011**

**6.** The Forum had before it a list of proposed meeting dates and times for 2011 for approval.

#### The Forum resolved:-

to agree the proposed meeting dates and times.

#### CHANGES TO THE CONSTITUTION

**7.** The Forum had before it a copy of the Constitution with proposed changes highlighted. It was advised that the changes were mainly administrative in function.

#### The Forum resolved:-

to agree the proposed changes.

#### AVAILABLE INFO FROM OTHER FORUMS

8. With reference to item 11 of the minute of the meeting of the Forum of 9 September, 2010, the Forum had before it a report highlighting the work that other licensing forums are undertaking. It was noted that Moray Council operate an online discussion forum for licensing issues. The Forum felt it may be worthwhile considering whether our Licensing Board should be operating a similar system. The Clerk advised the Forum that Aberdeenshire Council had been in discussion with Linda Bowie of Alcohol Focus Scotland regarding sharing information. Subsequently, they are currently investigating the possibility of having all of the different Scottish forums' agendas available on the local licensing forum site. It was advised, however, that this was still in the early stages of discussion.

#### The Forum resolved:-

to note the update and information given.

#### ALCOHOL LAW – MINIMUM PRICING

**9.** With reference to Article 12 of the minute of its meeting of 9 September, 2010, the Forum had before it a copy of the letter sent to Aberdeen's local MSPs supporting the proposal for minimum pricing on units of alcohol. Also attached were copies of the responses received.

The Alcohol (Scotland) Bill was passed on 10 November, 2010, without plans to bring in minimum alcohol pricing. The Forum expressed general disappointment at this.

#### The Forum resolved:-

to note the information given.

#### SAFER ABERDEEN FORUM ACTION PLAN

**10.** The Forum had before it a copy of the Safer Aberdeen Forum Action Plan, produced by the Safer Aberdeen Forum. This report, along with the minutes from the most recent Safer Aberdeen Forum meeting were initially issued at the Licensing Forum's meeting of 9 September, 2010, but had been received too late to be officially part of the agenda. Subsequently, it has been placed on this agenda so the Forum can officially note the proposed Action Plan.

#### The Forum resolved:-

to note the information given.

#### JOINT MEETING WITH THE LICENSING BOARD / LOCAL LICENSING FORUM

**11.** The Forum were reminded that there was a joint meeting with the Licensing Board scheduled for 1 December, 2010 and asked if there were any issues they would wish to discuss.

Items which the Forum highlighted included:

- Addressing the five licensing policies.
- Number of review hearings.
- Prevention of violent behaviour.
- Criteria used in determining licenses.
- Statistical information.
- Understanding of night time economy.

The Clerk agreed to discuss these items with the Depute Clerk to the Licensing Board for inclusion on the agenda.

#### The Forum resolved:-

to allow the Clerk to discuss the highlighted issues with the Depute Clerk to the Licensing Board with a view to compiling an agenda for the joint meeting scheduled for 1 December, 2010.

#### ANY OTHER COMPETENT BUSINESS

**12.** The Forum were advised that Alcohol Awareness Week had taken place in October and the online drinks diary, "How Much Do I Drink?", had been launched. Sandy Kelman advised the Forum that Fraser Hoggan (Alcohol and Drugs Partnership) would be able to talk them through the ADP strategy and campaign. To facilitate this, it was decided that the next meeting of the Forum should be held at Summerfield House.

#### The Forum resolved:-

to note the update and to schedule the next meeting to take place at Summerfield House.

#### DATE OF NEXT MEETING

**13.** It was confirmed that the next meeting of the Forum would be held on Friday, 25 February, 2011.

#### ABERDEEN CITY COUNCIL JOINT MEETING OF ABERDEEN CITY LICENSING BOARD AND ABERDEEN LOCAL LICENSING FORUM

Wednesday, 1 December, 2010

- <u>Apologies</u>: Allan McIntosh, Mary Crawford, Mark Donlevy, Ian Donaldson, Derek Murray, and George Wyatt.

#### DVD PRESENTATION

**1.** The joint meeting of Aberdeen City Licensing Board and Aberdeen Local Licensing Forum started with an informal presentation of a training DVD produced by Alcohol Focus Scotland,for Local Licensing Forum members.

Following the DVD there was some informal discussion relating to the Forum. They discussed the membership and remit of the Forum, underlying attitudes towards licensing and alcohol, and the relationship between the Licensing Board and the Licensing Forum. There was a particular focus on the extent of community representation on the Forum, and it was noted that this could be discussed by the Forum at its next meeting.

#### WELCOME AND APPOINTMENT OF CHAIRPERSON

2. Sandy Kelman as a member of Licensing Forum welcomed everyone to the joint meeting and it was agreed that he should chair the meeting in accordance with the approved rota and the apologies from both the Convener and Vice-Convener of the Licensing Forum.

#### UPDATE FROM DEPUTE CLERK TO LICENSING BOARD

**3.** Eric Anderson, Depute Clerk to Aberdeen City Licensing Board addressed the meeting.

The Board's Statement of Licensing Policy must be reviewed every three years. This review was approved on 16 November 2010 and published on 30 November 2010. As part of the review, the policy was put out to consultation with key stakeholders, notably the Licensing Forum. As part of the consultation process some of the Forum's suggestions were accepted and some were rejected. As per the Licensing (Scotland) Act 2005, the Board are obligated to feedback to the Forum reasons why some of their suggestions were not accepted. Mr Anderson

stressed that this would be available to the Forum before their next meeting in February.

The joint meeting was advised that the Statement of Licensing Policy, even after publication, was still a working document and, as such, was still open to amendment if necessary. This could also be done with the publication of a Supplementary Statement of Licensing Policy.

Two provisions that were incorporated into the Policy are:

- First Aid qualification required for late-night operations. If premises intend to stay open past 1am, they must have someone on the site trained in First Aid to a standard deemed acceptable by the Board. The minimum standard adopted by the Board is the Health and Safety Executive First Aid qualification.
- Premises ceased to be used for sale of alcohol i.e. if closed. The Act describes this as ceased to have effect but there was no clear definition as to what this may entail. As such, the Board have set out a balanced approach to this. For example, if the premises are closed for more than 30 days, the Board would seek advice within 14 days as to when they would be expecting to reopen. If the premises continued to be closed for over 6 months, there would be a review and action taken if necessary. If the premises were closed and their annual licence fee was not paid, the assumption would be made that they were not trading and the licence would cease to have effect. At the very minimum, there would need to be ongoing communication with the licence holder.

With regards to the new Criminal Justice and Licensing (Scotland) Act which was now in place, Mr Anderson advised the joint meeting that the Act must be fully bedded in and any initial issues identified before looking at any major new strategies. The Act will take effect over numerous stages as it covers a number of fields, some of which will affect Licensing Committee. Subsequently, this may require further consultation.

There have been 12 amendments, including adjustments to the Licensing (Scotland) Act 2005, which will take effect on 13 December 2010. In summary, these amendments cover:

- Anti Social Behaviour Reports Police are no longer required to provide an anti social behaviour report for every new licence. Now, the Licensing Board can request one and the Police can offer to provide one if it is felt necessary.
- The Police now have greater scope to provide objections in relation to the 5 Licensing Objectives.
- Various amendments have streamlined the Appeals procedure, making it more efficient and less bureaucratic.
- Various changes relate to the Police. Mr Anderson will discuss these direct with Grampian Police at a later date.

The Alcohol Etc. (Scotland) Act was passed on 10 November, 2010. The joint meeting was advised that it wasn't ratified yet but would be before the end of the year. The Act contains more strategic provisions which will require more consultation as to how they will be workable. Minimum pricing on Alcohol was not included this time around. It is dependent upon Scottish Government elections whether it will be included at a later date. The Act contained provisions for

restricting promotions on offsales, for example, alcohol display areas, and a quantity discount ban to be brought in line with onsale provisions. The Act also contains an age restriction policy known as 'Challenge 25' as opposed to the previous Age 21 policy which was only targeted on certain areas of the city.

In conclusion, Mr Anderson noted the annual Chief Constable's report which will be due at the end of the financial year, and some discussion was held regarding Social Responsibility Levy, which will aid the cost of the aftermath of revellers. He stated that there was still a lot of work to be done within a complex legislative picture.

Sandy Kelman thanked Mr Anderson for his informative update on the Board's Statement of Licensing Policy.

The joint meeting discussed many of the points above, and an issue regarding door stewards was raised. It was recognised that the biggest cost to premises is having door stewards in place. It was asked if some sort of guidelines could be drawn up perhaps for smaller, quieter premises wherein door stewards would not be necessary. The Board informed that there were no such guidelines in place and, indeed, if it were possible to do so, it would have been done in the past, although a guidance note in this vein could be considered. It is imperative that door stewards are utilised in overprovision areas as they are the first line of 'policing' for premises. The meeting expressed disappointment that door stewards are no longer provided with First Aid training, feeling that this would be appropriate. UNIGHT are currently working on risk assessments for all of their members with regards to door stewards. They offered to show this to the Board once complete.

#### FORUM WORK PLAN

**4.** The joint meeting considered the Work Plan and noted updates on actions / decisions taken by the Forum. Sharing information and statistics was identified as a useful two way process between the Board and the Forum.

The Depute Clerk to the Licensing Board confirmed that statutory information on liquor licensing will be shared with the Licensing Forum in accordance with the requirement of the Licensing (Scotland) Act 2005. He confirmed that the Board would scrutinise all relevant statistical information at the appropriate time when reviewing the impact of its policies and conditions. In explanation, he advised that guidance from the Scottish Government has been slow in relation to the sharing of statistics.

In relation to an item on the Forum's workplan expressing concern over the workload of Aberdeen City's only Licensing Standards Officer, Mr Anderson explained that this item was outwith the remit of the Board. The joint meeting did express concern about this but conceded that the only appropriate action the Board could pursue would be to approach the Council with their concerns.

#### ADDRESSING THE 5 LICENSING OBJECTIVES

**5.** The joint meeting then turned to discuss the ways in which the Board were seeking to address the 5 Licensing objectives as set out in the Licensing (Scotland) Act 2005.

Mr Anderson advised the joint meeting that the decisions of the Licensing Board have to be on certain grounds. The grounds of refusal are based on the 5 objectives. In relation to the Health objective (Protecting and Improving Public Health), Mr Anderson conceded that this has been difficult to incorporate in practice in the past, but hopefully the new act will address this with appropriate guidance.

It was felt by the Forum that the Board could take a more focused approach to health issues, perhaps using hospital admission and ambulance call-out statistics to identify hotspots.

In conclusion, Councillor Jaffrey reminded the joint meeting that all Licensing Board meetings are open to the public. The Forum asked to be advised of future Board meetings so that they would be able to attend.

#### NUMBER OF REVIEW HEARINGS

6. In relation to this item, Mr Anderson advised that, with regards to premises licenses, there had been 9 to date (more comprehensive procedure). With regards to personal licenses, it was advised that it was difficult to garner a figure due to them usually being contained within Board meetings. Mr Anderson advised that there were usually 1 or 2 at each meeting. He concluded by stating that the Forum are more than welcome to contact his office to find out this information.

#### PREVENTION OF VIOLENT BEHAVIOUR/CRITERIA USED IN DETERMINING LICENSES/STATISTICAL INFORMATION/UNDERSTANDING OF NIGHT TIME ECONOMY

**7.** The Forum stated that there were concerned about the disposal of review hearings leading to an image or message of reduced standards from the Board. The Board sympathised but reiterated that they can only act on the evidence before them so that they are able to justify any action taken.

The joint meeting discussed issues regarding people hanging around in the streets after closing time, late night food establishments, and statistics on serious and minor assaults. In summary, Inspector John Soutar advised the joint meeting that serious assaults are at a 5yr low while minor assaults are at a 5yr high. He suggested that this may be because premises now feel more comfortable reporting minor assaults to the police. Hopefully, this will lead to further reductions in serious assaults as more are reported and charged.

It was advised that, as per the Criminal Justice Act, personal licence holders can now be reported to the Board before conviction. This should have a considerable impact moving forward.

There was further discussion regarding statistics including the formulation of a 'report card' of key performance indicators which could be the basis for future joint meetings.

Articles **8**, **9** and **10** were also discussed at this time.

#### ANY OTHER COMPETENT BUSINESS

**11.** Brought to the table by Arthur Mustard on behalf of UNIGHT was the issue regarding occasional extensions specifically for events such as Halloween, Monday holidays etc. Mr Anderson advised the joint meeting that the policy covered Christmas, Hogmanay and the 4 local holidays as standard. For any other occasions which UNIGHT felt were important and not covered, they should write to the Board to request an extension.

Councillor Donnelly extended his thanks to the Licensing staff on behalf of the Licensing Board and hoped that the Forum felt the same. Sandy Kelman agreed and extended the Forum's thanks also while advising that it was the Forum's role to ask the difficult questions and hopefully the Forum and the Board can continue to work together.

#### NEXT MEETING

**12.** It was confirmed that the next joint meeting between the Licensing Board and the Licensing Forum would take place in approximately six months time and that the Forum would be consulted on a date and time in due course.

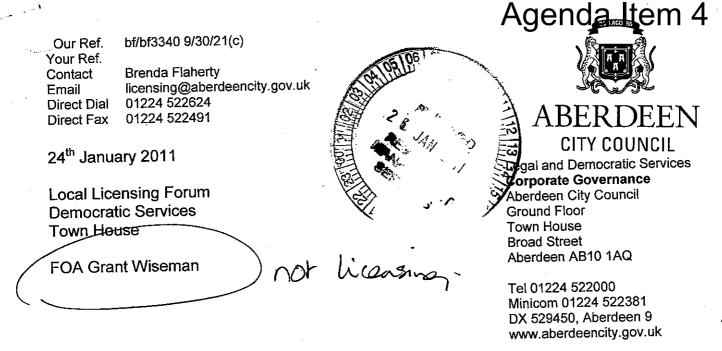

I refer to the Forum's response to the consultation on the Licensing Board's review of its Statement of Licensing Policy. In terms of section 12 of the 2005 Act, where the Board decides not to follow advice or recommendations given to it by the Forum, it must give reasons for not doing so. Where the Forum makes recommendations it would be helpful if it also explained its reasoning as to why the recommendation has been made. This would assist the Board in its assessment of the recommendation.

The Forum provided two responses. The Board, for a variety of reasons, may elect not to adopt recommendations from the LLF. Failure to adopt advice or recommendations does not mean that the advice or recommendation was without merit.

## **Response received Summer 2010**

The first response from the Forum primarily consists of a series of statements. With regard to the few specific comments raised by the Forum, the response from the Board is as follows:

In respect of the report 'Licensing Law and the Public Health Objective' produced in August 2008:

1. Page 28 states that only a small number of Boards link within their public health section an encouragement to provide food on the premises:

Response: See para 27.8 of the Policy Statement which provides that 'applicants are encouraged to provide food on the premises, so that patrons may eat at the same time as consuming alcohol if they wish'.

2. Page 28 states that only a small number of Boards link within their public health section a requirement for adequate ventilation and sanitary provision.

Response: These matters are dealt with under other legislation and therefore are outwith the Board's remit.

3. A small number of Boards request the provision of free tap water for drinking. **Response**: The provision of free tap water fit for drinking is a mandatory condition of a premises licence therefore there is no need to make reference to this in the Policy Statement.

4. The same report suggests that Boards undertake Health Impact Assessments. It is noted that Glasgow Licensing Board has undertaken such an assessment. **Response:** at the present time Aberdeen City Licensing Board is not in a position to undertake such an assessment. There are however many initiatives which the Board is taking forward in partnership with other organisations and the licensed trade which contribute to the licensing objectives and which in turn should have a domino effect on public health.

5. With regard to the letter from Gary Cox (Scottish Government) dated 4 April 2007: Paragraph 102 of that letter states the legal position in relation to review of premises licences.

**Response:** Paragraph 10 of the Policy Statement covers the review of premises licences.

6. It is noted that paragraph 193 of the Guidance makes reference to Closure Orders and that the Policy Statement makes no reference to them.

**Response:** The Board's view is that there is no need to make reference to these Orders in its Policy Statement. The issue of Closure Orders is clearly provided for in the 2005 Act and is a legislative rather than a policy issue.

7. The Forum asks the Board to take the opportunity to canvass views from economic development bodies and tourism bodies as well as the trade if it has not already done so.

**Response:** The consultation process undertaken by the Board was very wide. This recommendation is noted for future reference.

8. The Forum suggests that the Board might like to reflect in the Policy Statement its position with regard to the decision of the Glasgow Board refusing variation applications from large supermarkets to increase capacity of alcohol displays.

**Response:** Any decisions taken by other Licensing Boards must be treated with caution as such decisions may reflect the position in an area which may be quite different to Aberdeen. In any event Glasgow Licensing Board has since changed its position on this issue.

9. With regard to the publication 'Licensing for Public Health' and page 11 'Developing a Licensing Strategy to Promote and Protect Public Health' the Forum recommends that the Board considers producing such a strategy.

**Response:** This issue cannot be considered in terms of the current review of the Statement of Licensing Policy as it requires further discussion. Perhaps the Forum would wish to consider this matter in greater depth and advise the Board how it should proceed and what should be considered in terms of such a strategy?

10. Re the 'Licensing Toolkit' produced by Alcohol Concern and the recommendation that the Board accesses statistical data from the Alcohol and Drugs Partnership:

Response: This issue cannot be considered in terms of the current review of the Statement of Licensing Policy as it requires further discussion. Perhaps the Forum could explain in greater detail how such information could be used in practice and what benefit it thinks can be derived from the outcome?

11. The Forum suggests that the Board lists the tasks/actions that it has endorsed in relation to the Aberdeen Alcohol Strategy 2009-2019 Response: the Board has endorsed the strategy and the policy states this.

# Response received 12<sup>th</sup> October 2010

1) layout of statement

Response: we consider that the layout does refer to the licensing objectives.

2) place licensing objectives earlier in statement

Response: This is a matter of style. Ours follows that adopted by other Licensing Boards

3) specific reference should be made to Aberdeen Alcohol Strategy, Licensing for Public Health (June 2009 and considered by LB 15/12/09), Community Safety Partnership Action Plan, Single Outcome Agreement, and input from Social Care and Wellbeing. Also Council Transportation Strategy and Single Equalities Scheme. Response: The Board does not yet have a single equalities plan to refer to although this is under consideration. Social Care and Wellbeing are consulted on various matters pertaining to the Licensing Board and we would include relevant material as appropriate. Section 2 of the Policy makes reference to this.

4) Misleading to call Section13 Enforcement & Licensing Standards Officers. Should have separate section on role of Licensing Standards Officers as their role is more than enforcement.

Response: Again this is a matter of style. In practice the Licensing Standards Officer's role is mainly enforcement.

5) Add a contacts section.

Response: there has always been a contacts section at the beginning of the document. It is contained in the preamble and has been updated.

6) add glossary of terms or a briefing paper explaining different remits and functions of Licensing Board , Committee and Local Licensing Forum

Response: We do not consider this to be necessary. The Licensing Committee is not involved in liquor licensing matters. Applicants to the Board, by definition should understand the role of the Board. We can add a section of the role of the Local Licensing Forum at a future review if Board Members think it desirable.

7) Use publicity about the Policy to have an alcohol awareness campaign Response: the Board has no resources of any kind to launch a public awareness campaign (presumably on the misuse of alcohol). It is not part of the Board's judicial function to do this.

8) Add procedures to assist the public to make objections/representations. Add complaints procedure eg what triggers a licence review.

**Response**: The neighbour notification and display notices give details of how to object or make representation to the Board. The Board is not in a position to say what triggers a review of a licence. "Any person" can complain to the Board and trigger a review on any relevant issue. In these circumstances the complainer should be taking independent legal advice. The Board has an independent judicial role in review hearings and it would be inappropriate for it to give advice to a party on an issue it would later be adjudicating on.

9) add section on monitoring and evaluation of policy itself and Licensing Board's contribution to other strategies.

**Response**: the Board reviews the policy as necessary and issues supplementary policies as appropriate.

10) 10.4 & 25.7 of the policy regarding Door Supervisors should have their role expanded and discussed in context of risk assessment on employee safety and ratio to occupancy capacity

**Response**: Occupancy capacity is for the purpose of calculating overprovision only and the policy states this. The Board has discussed this issue and is of the opinion that it is too complex and variable to be enforceable as a policy decision. The Board has no power to insist upon risk assessments from licence holders with regard to their employees in licensed premises.

11) Section11 review of premises licence - state what triggers a review and relevant grounds.

**Response**: the relevant grounds for review are contained in the Act and therefore need not be replicated in the Policy. See also Response 8.

12) Section 2.6 mentions Aberdeen Alcohol Strategy and Alcohol and Drugs Partnership + community safety

Response This has been included in the Policy.

13) Section 2.8 expand. Licensing Board to offer advice/ make recommendations to other bodies and invite them to take action or explain why they have not done so. **Response**: We do not fully understand this point. The Board relies on other experts to give it advice eg building standards, environmental health. These bodies have their own enforcement regimes and will make their own decisions as to what actions are appropriate or otherwise in terms of their own remits. If the Board has concerns it will always draw these to the attention of its advisers. We consider that section 2.8 deals adequately with this point.

14)Section 2.10 delete ref to planning permission. **Response** We are unsure what is meant here. We consider that section 2.10 is giving procedural advice to an applicant.

15) Section 6.3 reword to confirm model conditions adopted and state they are to have equivalent of statutory status. Attach conditions to policy. **Response** local conditions are now spelt out in Policy. We do not have any model conditions.

16) Section 8.1 Licensing Board assessing application against licensing objectives should be more positive. Test should be does application promotes licensing objectives.

**Response** the Board do test applications against the licensing objectives when they call before it, and have refused applications as not promoting the objectives when Members consider it necessary.

17) Section 9.6 explain what evidenced complaints are and not just regarding overprovision. Clarify if a member of the public can trigger a complaint. **Response** See response 8.

18) Section 22.5 – add a recommended template for risk assessments. **Response**: the Board has no power to do this.

19) Section 25.3 – what are relevant representations? Add assurance re monitoring/review of compliance with licence conditions and operating plan. **Response** Monitoring is an ongoing joint role undertaken by the police, the Licensing Standards Officer and the Licensing Team.

20) Section 20.10 – change heading as refers to more than hours of trading. Working Group for dispersal

**Response**: headings have been changed. There have been numerous attempts over the years to devise a strategy for dispersal of patrons from licensed premises and many initiatives have been instigated eg night time taxi ranks, taxi marshals, police operations, street pastors. The Council is constantly striving to address this which in any case is a corporate issue and not just one for the Board to solve. We do not see what yet another group will achieve in this area.

21) Adopt similar to Edinburgh's policy condition re ATMs.

**Response** This has not been brought to the attention of the Board hitherto. We are not aware of any licensed premises (apart from supermarkets) which have ATMs and we do not consider this to be an issue which requires a policy to be formulated.

22) Licensing Board to consider its position regarding food & non alcoholic drinks if Dundee wins its case.

Response The Board will take cognisance of any relevant legal precedent.

23) Establish a working group to devise a comprehensive solution to crowd dispersal in city centre at weekends.

Response See response 20.

24) Include conditions on pavement cafes and the Board's own position on irresponsible drinks promotions as per Dundee.

**Response** Pavement cafes, if licensed, may have conditions attached by the Licensing Board on a case by case basis. However, most are unlicensed, the permit being granted by the Council (Roads) and consumption of alcohol being allowed on an off sale basis only. Irresponsible Alcohol promotions – these are set out in the Act. Guidance is required from the Government where new types of promotion challenge the provisions. The Dundee Licensing Board has now lost its court case on irresponsible promotions.

25) Expand the policy to reflect Dumfries and Galloway policy

**Response** It is presumed that Dumfries and Galloway have specific issues they wish to address and have included these in their policy as a result. Should any

issues be drawn to our attention as problems specific to Aberdeen, they will be addressed in future statements.

26) address multiple audiences including citizens who want reassurance the licensing objectives are given prominence in decision making. Add Dumfries & Galloway statement of intent. See response doc.

**Response** (a) this matter may be better addressed when considering the terms of the Social Responsibility Levy which will be introduced later this year in the Alcohol etc Act 2010, following an extensive consultation by the Scottish Government. (b) we consider this to be out with the remit of the Board.

(c) This appears to be a statement rather than a recommendation. The Board already takes a multi agency approach to matters within its remit.

### **Community Representation**

With reference to article 1 of the minute of the joint meeting between the Licensing Board and the Local Licensing Forum of 1 December 2010, it was noted that further discussion was required by the Forum with regards to extending their engagement with the community. One part of this issue is included as a standing item on the Forum's workplan. Item 1 states that we will "Find out from communities what are their areas of concern". This may involve re-engaging with Community Councils across Aberdeen.

Another aspect of this item involves the scope of community representation in the membership of the Forum. At present, the Aberdeen University Student Association have a vacant spot on the Forum. Last October, the Clerk to the Licensing Forum contacted Aberdeen University Student Association to advise them of this. It was noted that Aberdeen University and Robert Gordon's University normally share this spot and it was the turn of a representative of Robert Gordon's to attend for this term. As such, Aberdeen University Student Association forwarded on the Forum's details to Robert Gordon's. At present, we haven't received a response from Robert Gordon's University.

### It is recommended that:

- (i) the Forum write to all Community Councils advising them of the Forum's role in licensing and that representation of concerns can be made for discussion at Forum level; and
- (ii) the Forum contact Robert Gordon's University to source an appropriate student representative to fill the vacant spot currently held by Aberdeen University Student Association.

Extract from the minute of the Enterprise, Planning & Infrastructure Committee of 9 November 2010 in relation to item 6 of the Local Licensing Forum workplan.

### NIGHT TIME BUS IMPROVEMENTS – EPI/10/256

**20.** There had been circulated a report by the Director of Enterprise, Planning and Infrastructure describing emergent proposals under discussion between the Council and public transport operators, proposals designed to improve night-time bus services in Aberdeen by introducing amalgamated bus stop locations (to create fewer dedicated night time stops, to revise stopping times at these locations to minimise potential conflict and maximise passenger numbers, to establish lit pillars and night bus flags on shelters and dedicated stops, to make the stopping places highly visible to customers (these to be lit during operational times, and to be in keeping with the night-time taxi rank pillars), and to establish individualised night-time bus tables at all dedicated stops.

All of this was of course dependent on funding, and expenditure would be greater if possible *extensions* to bus shelters were to be included within the overall plan. Again, the context at the moment was that of continuing discussions with operators, and reports back to Committee were contemplated.

#### The Committee resolved:-

to request the officials to continue discussions with public transport operators on all of these matters, and to report back in due course. This page is intentionally left blank
