Whilst I would not object in principle I would raise a concern regarding location as it is close to the entrance to Lewis's and may have implications with respect to emergency evacuation of the building. As access to George Street is for loading etc only it would be preferable that the cart be located 15 metres from the junction to avoid conflict with turning vehicles and be located on the line of the road kerb. The application details a hand cart and whilst this would not contravene the current traffic orders the possible use of a vehicle at a later date would not be permissible and is something the applicant may wish to be aware of. The proposed application, if approved, will attract a fee for occupation of the road from the Roads Authority and it would be prudent to advise the applicant when a formal response is given.
