We are writing to register our objection for premises licence by Union Spark Ltd for Mastrick Grocer, 9 Greenfern Place, Aberdeen, AB16 6JR. Our Objections are detailed below.

### Overprovision of licensed premises in the locality

The licence proposes that alcohol be sold for consumption off the premises between 10:00 until 22:00 seven days a week. Granting a licence would provide a further source of alcohol within an area already populated by a public house, and four off licenced premises (Spar, a convenience store on Springfield Road and two further stores in Clunnie Place).

### Securing public safety and public nuisance issues


The profile data for Mastrick shows that a large proportion of this community is heavily reliant on a variety of pensions and benefits payments which are accessed through a Post Office. Our elderly customers in particular tell us that they feel "intimated" by the rowdy atmosphere in the shopping precinct and feel that they have to be on their guard when they come to collect their benefits. For example, they will tend to use our internal ATM machine rather than the one sited outside the Clydesdale Bank as they feel it is safer to do so. The link between access to alcohol and crime and disorder is well established and we believe that a licence would serve to dilute community safety.

Aberdeen City Council has invested heavily in regenerating Mastrick Shopping Centre (new paving, benches, lighting etc). Littering, vandalism and other public nuisance issues are likely to result from this grant.

### Protecting and improving public health

The Scottish Index for Multiple Deprivation (SIMD) is the Scottish Governments official tool for identifying concentrations of multiple deprivation. 2009 data, reveals that Mastrick is among the most deprived (combined domain) data zones in Scotland. It is particularly interesting to note that Mastrick scores poorly within the crime and health domains and has emerged as one of Aberdeen City Councils "hot spots" for anti-social behavior and community safety issues including alcohol and drug abuse and youth disorder. Underage drinking outside Lewis Road shops, Mastrick Community Centre and Mastrick Church are issue that are presented to Mastrick, Summerhill & Sheddocksley Community Council time and time again. Making alcohol more readily accessible is likely to fuel this problem further.

In summary, we believe that the premises are unsuitable as they are positioned directly opposite to a Post Office and that a licence could lead to increased public nuisance, increased crime and disorder and may well be detrimental to public health in Mastick.

i would like to say that i am very disappointed in the amount of notices for the application as i've only seen 3 of them around the area.

i'm fighting for all of the small businesses around the area (not directly affiliated with them) areas that this application will affect are Woodend, Summerhill, Sheddocksly, Mastrick and possibly Northfield, Byron and stockethill.

i know from consulting all of the businesses that they are all Very Worried about how having Tesco there will Harm there Business.

I refer to the above application for the variation of a premises licence under terms of Section 29(5) of the Licensing (Scotland) Act 2005.

The variation consists of a request to include a separate existing unlicensed cafe bar/coffee shop situated at unit 6 in The Galleria as an 'annexed' part of the existing premises licence.

The new licensed area will comprise of the floor space within unit 6 along with an outside seating area which will extend into the public concourse of the shopping mall. Both the interior floor space and exterior seating area are to be included within the licensed area, as delineated by a red line within the layout plan accompanying the application. It is proposed that the additional licensed area will operate as a cocktail lounge bar with table service. Non alcoholic drinks and food will be available from unit 6 from 0800 to 1700 hours daily, with alcohol only being served after 1800 hours. Children and young persons are to be allowed entry to the new area from 0800 to 1700 hours only.

In addition, the variation requests that the existing Tonik outside seating area be included within the licensed area as delineated by a red line in the layout plan. Non alcoholic drinks and food will be available from 1200 hours.

For both the existing and sought after new licensed areas, the variation states that patrons will not be permitted to take alcohol from the new licensed area to the existing Tonik premises. It is assumed that this restriction has been proposed to ensure full compliance with the Aberdeen City Council (Drinking in Public Places) Byelaws 2009.

In terms of Section 29(5) of the Act this request can be considered a variation.

In terms of Section 22(1)(a) of the same Act, I make the following objection on behalf of the Chief Constable.

At present the premises licence relates solely to Tonik at Unit 11 The Galleria. The existing layout plan shows that the licensed area, as delineated by a red line, extends only to the perimeter of unit 11 and not beyond the building line. There is no natural curtilage extending into the shopping mall itself. The licensed area does not include the outside courtyard seating area.

The use of the existing unlicensed outside courtyard seating area, and consumption of alcohol by customers within it, has been subject of dialogue between Grampian Police, the Clerk to the Licensing Board and the agent for the premises. In order to avoid patrons of the premises committing an offence in terms of the Aberdeen City Council (Drinking in Public Places) Byelaws 2009 by drinking alcohol in the area, an agreement was reached whereby this could only be done from 1800 hours onwards daily, provided that all other businesses in the shopping mall were closed and that Door Stewards employed by Tonik were in place to manage entry and egress from the mall, effectively making it temporarily a private place and not a 'designated place' as defined in the Byelaw.

The crux of this agreement was the acceptance by the premises licence holder and their agent that without this arrangement that customers would be committing offences at all other times and that the premises licence holder would fall foul of the Prevention of Crime objective as a result.

This agreement has worked well in practice but is not currently specified in the existing premises licence or the variation sought.

The Chief Constable questions the competency of the variation application as a whole, particularly the notion of 'annexing' an existing premises licence to allow the sale of alcohol from another separate premises, location or place.

The applicant premises are also situated in the 'Justice Mill area', which is within an area of overprovision as detailed within the Aberdeen City Licensing Board Statement of Licensing Policy. The Chief Constable therefore notes the terms of section 23(5)(e) of the 2005 Act.

For the reasons detailed in this letter, and in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005, the Chief Constable objects to the variation application specifically in relation to the grounds for refusal at sections 23(5)(c) and (e) of the same Act.

If the variation is to be granted, in terms of section 22((2)(b) of the Licensing (Scotland) Act 2005, the Chief Constable recommends that the variation application, and therefore the operating plan accompanying the application, be modified at section 3(b) as follows:

The addition of the words' Existing outside drinking courtyard area also only to be used for the sale and supply of alcohol after 1800 hours onwards'. This will ensure that both licensed areas operate under the same conditions and will formalise the existing informal agreement allowing the use of this area after 1800 hours.

Deletion of the words 'PLH staff' to be replaced with 'PLH staff, trained bar staff or door supervisors'. This change will allow the premises more flexibility in relation which staff are to be utilised to monitor both the existing and new licensed areas.

As a group, and a voice for a significant amount of the late night licensed venues within the city centre, Unight Aberdeen are interested in the possibility of working with the Licensing Board to re-allocate the extra hours provided for two of the Sundays of calendar Bank Holiday weekends. Normally this extra hour provision is given on the May Bank Holiday weekend and on Christmas Eve. This idea was discussed with Councillor Marie Boulton at a previous Unight Aberdeen Chair meeting at the beginning of this year, Jan/Feb 2012, with a favourable response.

We would like to put forward the motion to change the allocation of these to the St Patricks Day and Halloween weekends instead. Unight Aberdeen are convinced that this alteration would make more business sense and will encourage more people to frequent the city centre on these weekends. The member venues feel they notice that business levels for the weekends of the existing Bank Holiday provision currently only trade at normal business. These levels are regardless of the extra hour put in place. These weekends are also predominantly when people are on holiday and are most likely to be outwith the city centre.

On a positive note, the venues feel they notice that there is more positive customer interaction and less police involvement on the St Patricks' day and Halloween weekends. Unight Aberdeen feel that as a representative group of these member venues, it makes it a more practical decision to re-allocate the hours to the St Patricks' Day and Halloween dates in question.

On another note, Unight Aberdeen is also keen to see the introduction of a condition on venues licences (particularly relevant to the late night opening venues – nightclubs, casinos and other late licensed establishments) stating that they should be an active member of their local alcohol focus community project (of which Unight Aberdeen, Safer Aberdeen and Bar/Pub watch would examples.) Safer Aberdeen have pointed out that it is already an existing clause in the Shopesafe radiolink agreement which all venues will have agreed to in order to obtain their security radios.

By active, we feel that a 60% attendance rate in any given year is not an insurmountable objective. (This equates to 7 meetings out of 12 in any calendar year.) Unight Aberdeen feel that this condition would encourage the current members of such schemes who are only members in name and currently do not actively participate. These venues gain all the benefits of being a member however, never or very rarely attend meetings to contribute to the efforts of the group. This is with particular reference to any information needed to be uploaded via Grampian Police or Safer Aberdeen to the SIRCs database. (The SIRCs database is the information sharing protocol that we currently utilize in association with Safer Aberdeen, Aberdeen City Council and Grampian Police to track criminal offenders within the city centre.)

Unight Aberdeen would welcome any feedback on these issues, as well as any alternative suggestions from the Licensing Board in both how these ideas could be feasibly introduced or alternatively achieved.
