DETERMINATION OF EXEMPT BUSINESS

2. MINUTE OF PREVIOUS MEETING

3. The Sub Committee had before it the minute of its previous meeting of 4 December, 2013.

The Sub Committee resolved:-

to approve the minute as a correct record.

REDUCTION IN GENERAL WASTE CONTAINER SIZE FOLLOWING INTRODUCTION OF MIXED RECYCLING COLLECTIONS

4. With reference to article 5 of the minute of meeting of the Sub Committee of 4 December, 2013, the Sub Committee had before it a report by the Waste and Recycling Manager which provided an options appraisal with recommendations on general waste capacity and waste bin sizes.

The Head of Environment Services and the Waste Strategy Manager talked the Sub Committee through the report.

The report recommended:-

that the Sub Committee -

- (a) approves the reduction in general waste bin capacity from 240 litres to 180 litres for residents receiving existing kerbside recycling collections; and
- (b) that this reduction in capacity is implemented in conjunction with the roll out of mixed recycling collections with glass.

The Sub Committee resolved:-

- (i) to approve the recommendations contained in the report; and
- (ii) to refer the report to the Housing and Environment Committee for consideration.

RECYCLING SERVICE CHANGES AND IMPLICATIONS FOR MIXED MESSAGING (H&E/14/022)

5. The Sub Committee had before it for its information a report by the Waste and Recycling Manager which provided an update on existing recycling services, proposed pilot schemes over the next year and the impact these had upon the effective messaging of increasing recycling performance, before the report goes to the Housing and Environment Committee for consideration.

The Head of Environment Services talked the Sub Committee through the report.

The report recommended:-

that the Housing and Environment Committee note the implications of this report and instructs officers to arrange a members' briefing session to explain the changing services.

Councillor Finlayson requested that Officers make reference in the report to the collection of recyclate from Council facilities. The Head of Environment Services agreed that this would be done.

INSTALLATION OF FOOD WASTE AND RECYCLING FACILITIES ON PRIVATE LAND (H&E/14/024)

1. PURPOSE OF REPORT

The report provides an update on the Zero Waste Project.

2. RECOMMENDATION

That the Sub-committee:

- i. Notes progress made to date
- Notes that an additional ZWMSC meeting may be scheduled in August/September 2014 to receive a further progress report and recommendations.

3. FINANCIAL IMPLICATIONS

There are financial implications arising from the acquisition of the ransom strip adjacent to Altens OP70 site, estimated to be £500,000 including legal and agents' costs; these are included in the capital plan, Zero Waste Project allocation.

4. OTHER IMPLICATIONS

Legal: The internal Legal Team is supporting this Project along with specialist external advisors.

Resource: The Asset, Finance, Waste and Recycling and Energy Teams have input into the project. All are operating within existing budget allocations. Input from each team will vary over time.

Personnel: none from this report.

Environment and Sustainability. The facilities to be developed under the Zero Waste Project will significantly reduce the carbon impact of the Council's and householders' activities. Increased recycling and low landfill will be achieved once all services and facilities are developed.

According to SITA's latest programme, the earliest that processing activity is likely to start on the new site at Altens is August 2016 for residual waste (RDF) and February 2017 for co-mingled recyclables (MRF) and the Waste Collection Depot.

5. BACKGROUND/MAIN ISSUES

5.1 SITA Variation

General Progress

5.1.1 Good progress has been maintained by SITA and a number formal negotiation meetings have been held.

SITA presented their initial formal proposals to the Council on 20th February 2014 and further iterations have been submitted since then.

Technical proposals

5.1.2 SITA's technical proposals for RDF preparation and the MRF have been reviewed by AMEC (the Council's technical advisors) and have been approved, insofar as the technical design is capable of delivering the performance required by the Council.

Preparation Work for Planning Application

5.1.3 SITA has commenced preparation work for a planning application relating to the Altens East site. This will include pre-application consultation activities with the local community. Undertaking this work now will ensure early delivery of the facilities and new collection services.

Programme

5.1.4 SITA have provided an outline construction programme that shows construction work starting on the Altens site around midsummer 2015, with the RDF opening in mid-2016 and MRF and Depot in early 2017.

5.2 EfW Business Case

5.2.1 As anticipated, no further work has been done on the energy-fromwaste (EfW) business case review since the report to the Subcommittee meeting on 4th December 2013.

5.3 Local Development Plan – Sites for Waste Infrastructure

5.4.1 The Waste and Recycling Service made a response to the Local Development Plan Main Issues Consultation as instructed by Subcommittee indicating the need for sites to be identified for a new HWRC site in the Bridge of Don area and an Energy from waste facility within the city boundary.

Colleagues in the Planning service are now coordinating a site selection process in advance of presenting a Proposed Local Development Plan to E,P&I Committee in November 2014.

5.5 Other Zero Waste Project Activity

Food Waste Collections

5.5.1 Phases 1 and 2 of the Food Waste Collection Service are now complete with 16,000 households now having a communal food waste collection. Phase 3 has now commenced and this will focus on social housing areas where the food and garden waste service is not provided.

Mixed Recycling Pilot in Powis, Sunnybank and Sandilands areas.

5.5.2 The first household mixed recycling collection service will commence in the Powis area in early-July 2014. The new service will allow householders to dispose of paper, card, glass, metal cans, aerosols, plastic bottles, pots, tubs and trays. This project will also involve the conversion of general waste collection form individual wheeled bins to communal collections. This is being undertaken in response to requests from the community to change collection method and with extensive support from the Residents' Association.

Existing paper and cardboard recycling collections will be converted to mixed recycling in the Sunnybank and Sandilands areas as well.

6. IMPACT

Corporate - The development of alternatives to landfill and enhanced recycling will help Aberdeen move to become a Zero Waste City - a key action within the Smarter Environment – Natural Resources Strategic Priority of the Five Year Business Plan.

Public - The Zero Waste Project will enable the council to provide recycling facilities to all Aberdeen residents with those in multi-occupancy areas being able to recycle their waste just as easily as using refuse facilities. In addition, more materials will be able to be recycled including plastic pots, tubs and trays and waxed beverage containers.

Any development of waste infrastructure attracts interest from local communities, often centred on nuisance issues such as noise, odour,

vermin and traffic. The Waste and Recycling Service maintains good communications with many community councils and other community groups across the city and will continue to explain the need for new facilities and provide information on their likely impacts and benefits for the city and local communities.
