General Information for the organiser:

We are asking you to fill in this risk assessment form to help us to understand what dangers and risks might be associated with holding your event. This form will take you through the most common areas of risk which we and the Police might want to raise with you. We and the Police may carry out our own assessment of risk and may want to discuss our assessment with you before any meeting is held or at the first meeting itself.

When a risk assessment may not be needed:

We will tell you if you need to fill in this risk assessment form. You may not need to carry out a risk assessment, for example, if we consider your procession is routine or it has already been decided that the procession will carry little to no risk.

Purpose of filling in the risk assessment form:

A risk assessment of the procession will help to -

Identify any dangers associated with holding it;
evaluate the level of any known risks;
decide who is at risk and in what way and how the risk to them could be reduced or removed; and
decide, where other types of risk have been identified, whether it would be possible to introduce appropriate measures to allow the procession to go ahead

Who should be filling this form in:

It would be preferable if you were a suitably qualified person (e.g. someone who is trained in health and safety regulations). If that is not possible, someone else in the organisation with a good knowledge of the area where the march is to be held should fill it in. We will then check the form and compare it to the assessment of risk which we and the Police may be carrying out.

How to fill in the form:

You should work your way through the form section by section. If there are parts to sections which you cannot fill in, you should contact the person named at the end of the form. If your overall assessment shows that there is a high risk associated with holding the procession, you should get in touch as soon as possible to discuss if we can find solutions to reduce or remove the risk. Once we have considered the notification, the risk assessment and all other evidence, we may contact you to hold a meeting.

Who you should send the form to:

You should send your risk assessment form, with your notification form, to the person named at the end of this form at least 28 days before you plan to hold a procession. If you cannot send your risk assessment with the notification, you should do so as soon as possible thereafter.

Next steps:

We will assess the risks associated with holding your procession as early as we can. You should remember to keep a copy of this form for your records and bring it with you for any meeting which we may hold. This is because we and the Police may want to raise issues with you about how your assessment compares to ours. In case there are problems, we may need further meetings.

Recommendations:	 There should be a minimum of 8 dedicated, appropriately qualified stewards in attendance; The organiser must fully brief stewards as to their responsibilities; The stewards must wear high-visibility jackets, at all times when escorting the procession; The Stewards must remain at the Castle gate after the parade for the duration of the Rally; The organiser must arrange a full, Council resourced, road closure over the route of the procession, for its duration; The organiser must inform the local media of the timings of the procession and likelihood of there being disruption to traffic in the City Centre; The organiser must inform the Hackney Licensing Department of the timings of the procession given the potential disruption to taxi ranks in the City Centre; The organiser must inform local bus companies of the street closures and their duration, to enable alternative routes to be implemented; The organiser must inform the Scottish Ambulance Service and Grampian Fire and Rescue Service about the times and movements of the procession; and The organisers should have in place Public Liability Insurance should any legal action or otherwise be forthcoming following an incident during this event

Comments:

This parade is an annual parade and has previously passed without incident.

The route of this parade has been extended this year and will require road closure to be implemented by Aberdeen City Council Roads Department.

The participants will gather at the start at 1100 hours, with the parade commencing at 1130 hours. The Procession will follow a tried and tested route for previous parades and will terminate at the Castlegate, where the TUC will hold a short rally.

A policing presence will be provided during the entire event on the condition it lasts no longer than 2 hours in total. This time restriction is not intended to curtail any political activity but to ensure that police resources are not committed to this event for an extended period.

Police Scotland are aware this event will coincide with a small political recruitment event planned by the National Front Scotland. The National Front Scotland organiser has expressed concerns due to two groups with differing political views being in the same area at the same time. Whilst there is no current intelligence to indicate a risk to public safety, there are likely to be implications for public order in the area. It is assessed that any activity will amount to verbal or protest activity only. Police Scotland are confident they can police these circumstances effectively however the combined effect of the two groups and a proportionate policing presence could result in some disruption to the life of the local community, particularly the regular Saturday market.

Good morning Jacqui.

I note that the parade applied for is the "full-length" Albyn - Union Street - Castle Street march. This is not as held in recent years, when a St Nicholas Churchyard to Castlegate march has been adopted, under police control, thus avoiding traffic management and temporary traffic order costs.

The route as given will incur costs for the Council. The Committee may wish to ascertain where these costs will be met from. It would be a controversial decision to waive these for one organisation without extending this privilege to others (charities, British Armed Forces Day parade, et cetera and potentially to organisations with whose philosophies the Council may disapprove).

Dear Jacqui,

Firstly may I thank you for getting back to me so quickly regarding the Planned Mayday Parade by the Aberdeen Trades Union Council. Yes we are objecting to this parade based on the reasons below.

- 1) The National Front had already announced that they will be holding a "Recruitment day event" in the Castlegate area of the city on the same date and we will not change our plans under any circumstances as we have people from different organisations attending from other areas of Scotland.
- 2) The Planned parade by the TUC is not on the application page on the council's website and therefore no member of the public has had the chance to view the application or object to it as per legal guidelines.
- 3) The chance of public disorder at the castlegate is inevitable due to the mindless thuggery and animosity of left wing organisations in the past towards our party (National Front). Both groups in the same area at the same time would be a recipe for disaster.

 The safety of our members and the public is paramount and would be compromised if the parade is

The safety of our members and the public is paramount and would be compromised if the parade is allowed to end at the Castlegate.

4) Finally, it was revealed in 2012 that the preferred route for any processions/parades held in Aberdeen were to begin at St.Nicholas Church and end at the Castlegate. Has this changed since 2012?

This event has been planned to start at Albyn Place then head down Union street towards the Castlegate. We object to this route being used as it would seriously inconvenience the people of Aberdeen as they go about their business in the city centre on what is the busiest shopping day of the week.

Why has the TUC decided to hold a parade on the Saturday when it is acknowledged that May day parades are to take place on the Bank Holiday Monday which this year falls on the 6th May? We believe that they chose this date as they knew about our event which was already advertised for the 4th May.

If they want to hold the parade on the Monday then would consider allowing this to take place.

Dear Jacqui,

Following on from our objection letter that was received by the council I now attach further information which makes the likelihood of the mayday day parade taking place very slim indeed. I have added links to the last licensing meeting including the minutes, agenda. As you will see the meeting took place on the 26th March at 10am which was a full 20 days after you claim to have received the application from the trades council. Why was it not mentioned in the agenda and why also was the application not even listed in the applications for the whole of the month of March? It still hasn't been added to the latest applications list!

As you know the parade cannot be granted permission unless it is discussed by the committee and ANY objections are heard. As there is no meeting planned for April(meeting on the 17th is officially cancelled) this parade cannot be allowed to take place.

The meeting for April was cancelled and is in the public domain so that the public know that is has been cancelled. Unless the council re-arrange the meeting that would have to include the parade application and the attendance of any objectors the matter is finished with with no parade. If it goes ahead without permission the council are breaking all rules and regulations and this would become a police matter. We will officially complain to the police if this goes ahead without the proper discussions with all parties.
