TAXI LICENCE (RENEWAL): T342

APPLICANT: TONY ADU

VEHICLE: H4 ADU

This item is on the agenda because:

The application requires to be determined by 28 July 2014 and Fleet Services have advised that to date the vehicle has not passed inspection.

Mr Adu applied for renewal of his taxi licence in January 2014.

In addition, Mr Adu later submitted an application to substitute his vehicle.

The Enforcement Officer wrote to Mr Adu on 31 March. Information had been received that Mr Adu's vehicle had been damaged and he was asked to present it at the Taxi Inspection Centre.

The Enforcement Officer wrote further to Mr Adu on 22 May 2014 informing him that the replacement vehicle was already the subject of another taxi licence and it was not possible to have two licences on one vehicle.

Mr Adu was invited to the Licensing Committee of 1 July by letter dated 10 June 2014

Mr Adu attended the meeting and the Committee allowed him a few more weeks to provide a suitable vehicle and have it successfully inspected.

Following the meeting Mr Adu was written to on 2 July and informed that he had to have a suitable vehicle provided and inspected by 21 July otherwise the matter would have to be considered by the Urgent Business Panel.

He failed to do so and hence a meeting of the Urgent Business Committee is arranged.

CIVIC GOVERNMENT (SCOTLAND) ACT 1982 – TAXI & PRIVATE HIRE CAR LICENSING - TAXI LICENCE NUMBER T342 - H4 ADU & PK07 POA

Your application to renew Taxi Licence T342 was submitted on 29/01/14 and has not yet been processed. In addition an application to Substitute vehicle PK07 POA on to Taxi Licence T342 was submitted on 26/03/14.

You have been previously advised on two occasions to present vehicle H4 ADU for inspection at the Taxi Inspection Centre as information was received that the vehicle was accident damaged.

The Licensing Authority had not been notified of the damaged vehicle as required by condition 6 of the Taxi Licence conditions (quoted at the end of this letter) and you had not asked for extended time to repair the vehicle as required by the same condition.

It was also noted that you cancelled the scheduled taxi test for H4 ADU which was arranged for 08/01/2014.

You had confirmed by telephone that the vehicle was accident damaged and had in fact been written-off by the insurance company. At this point you were also advised that under Section 10 subsection 6 of the Civic Government (Scotland) Act 1982 you had 28 days from the disposal date of the vehicle (in this case the date that the insurance company confirmed the vehicle was written-off) to either substitute another vehicle on to the licence or surrender the licence.

Therefore your substitution and renewal applications will go before the Licensing Committee for consideration.

You will be notified of the date and time of the next Licensing Committee meeting in due course.

Condition 6 of the Taxi Licence Conditions states-

"The holder of this licence when the taxi is damaged in a vehicular accident or by any other means shall report the damage to the Taxi Inspector as soon as practicable, and if the taxi is roadworthy he shall present it for examination within the following two working days (being days on which the testing facilities operate) after the occurrence. It shall be at the discretion of the Taxi Inspector if he considers the taxi unroadworthy, to issue an instruction that the taxi shall not be used until the repairs have been completed and the taxi re-examined.

As soon as the repairs to the taxi have been completed (which shall be within a period of twenty-eight days, except in exceptional circumstances) the taxi shall be re-examined. In the event that the repairs cannot be completed within the period specified above, the licence holder shall apply in writing to the licensing authority for an extension thereto."

10 Taxi and private hire car licences

(6)Subject to subsection (5) above, the holder of a taxi or private hire car licence shall within 28 days of his selling or otherwise disposing of the vehicle to which the licence relates deliver to the licensing authority his licence and any licence plate or other thing which has been issued by the licensing authority for the purpose of indicating that the vehicle is a taxi or, as the case may be, private hire car, and if without reasonable excuse he fails to do so he shall be guilty of an offence and liable, on summary

conviction, to a fine not exceeding **[F2**level 2 on the standard scale].

CIVIC GOVERNMENT (SCOTLAND) ACT 1982 – TAXI & PRIVATE HIRE CAR LICENSING - TAXI LICENCE NUMBER T342 - H4 ADU & PK07 POA

I refer to my previous letter of 31/03/2014 regarding your submission of a renewal application for taxi licence T342 and the later submission of a substitution form for the same licence substituting the vehicle from H4 ADU to PK07 POA.

You were advised that your applications would have to go before the Licensing Committee for the renewal of your licence and thereafter the substitution to be determined.

It has since come to light that the vehicle PK07 POA is already subject to a current taxi licence and it is not possible to have two licences on one vehicle.

Therefore it would not be possible for the Licensing Committee to grant the substitution application. This would mean that as the original vehicle is written-off and no longer in your possession there is not a vehicle for taxi licence T342. A taxi licence cannot remain in force without a vehicle once the allowable 28 day period (to obtain a new vehicle) has expired- in your case this was January 2014.

If you still wish the Licensing Committee to determine your applications they will be heard at the next committee meeting on 01/07/14 (you will be sent an invitation to attend). If you wish to withdraw both applications please advise me of this as soon as possible.

Obviously, if you are present, you would be able to respond to any such queries there and then. You are offered the chance to attend to allow you to fully state your case and to ensure that you are provided with a fair hearing.

If you do not attend, the Committee can consider your application in your absence and, if it refuses your application, you would not be entitled to appeal to the Sheriff Court against any such refusal, as you would not have taken up the opportunity provided to you to attend. It is therefore in your best interests to attend.

You may wish to consider contacting your solicitor who can provide you with legal advice. He could also attend the meeting with you and speak on your behalf.

Please note that if the Committee refuses your application, they cannot entertain a similar application by you within a period of one year of the refusal unless there has been a material change in circumstances.
