It further advised that the Licensing Committee had the following guideline in respect of street trader licences: "That no street trading be permitted in Union Street or any pedestrianised area in the City Centre save where a special case can be made out by the applicant or the licence holder as to why the Guideline should not apply".

The applicants were in attendance and spoke in support of the application, advising why this was a special case and therefore why the Guideline should not apply.
