



The above application has been assessed by this Service in relation to noise including music noise breakout from the premises. Consideration has been given to the risk of noise impact on local residences at the proposed times.

As with any such matter it is naturally desirable to avoid a situation that would result in this Service serving formal notices to abate activities that have caused nuisance.

Having carefully considered the matter I am not objecting to this application. However, in relation to the outside seating area, to protect the amenity of residential property near to the proposed location from noise I recommend a condition prohibiting amplified music in the outdoor area and that the outdoor area is not used after 22:00 Hours.

There is also an expectation that Management at the premises would establish and apply suitable and robust noise control measures for all reasonably foreseeable noise sources associated with the business. This is considered necessary to protect the amenity of local residences and reduce the risk of noise impact and disturbance constituting a statutory nuisance. These noise sources may include for example; music noise breakout from the premises, food and beverage delivery and waste disposal along with patron noise from use of the outside seating area.

I would therefore recommend that these noise control measures are formalised in writing to demonstrate and convey to staff for training purposes the specific detail of the required noise controls.

- 2. In Scotland we have robust practice in relation to Challenge 25. What controls will be in place around this. will this be implemented in other areas?
- 3. If successful this licence will be granted in Aberdeen. The Aberdeen City Licensing Board will have no means to monitor deliveries out with its licensing area. Where will complaints regarding any inappropriate deliveries be made, how will this be investigated and how will this process be conveyed to the public?

Protecting and Improving Public Health.

Omar Retail Logistics has applied for a Provisional Premises License for the ground floor retail outlet within Hillhead Halls of Residence. The premises will be open from 07:00 till 24:00 Monday to Sunday for the provision of non-alcoholic goods, groceries, newspapers etc, with alcohol available 10:00 to 22:00 Monday to Sunday.

The local shop was previously located in a stand alone building adjacent to Hillhead Halls of Residence and had an alcohol capacity of 16.94m². The new off-sales capacity for this premises has still to be confirmed but could be in the region of 32m², an increase of 89% in total capacity. The shop is now relocated to within Hillhead Halls of Residence and has been operating for a number of weeks under occasional licenses.

Its location within the student village suggests that its main customer base will be students aged 17 and above. Hazardous alcohol consumption (most commonly binge drinking) is the most common public health issue affecting university students in the UK¹, affecting up to 89% of young men and 77% of young women. Just under a third of students identified themselves as "problem drinking". These levels of consumption are extremely concerning to parents of young people going away to university as well as to staff and students tasked with improving student health and well-being. Aberdeen University recognise that they

are no different from other universities in terms of alcohol problems and have signed up to the National Union of Students "Alcohol Impact Programme".

The health of university students is poorer than that of their non student peers. Emotional health is more of a problem than physical health with worries about finances and study pressures contributing to increased levels of anxiety². Alcohol could be seen by a minority as an easily available coping mechanism, placing them at heightened risk of experiencing harm to their health.

At the SARN (Scottish Alcohol Research Network) meeting held on Tuesday 27th September 2016 at Robert Gordon University, commendable and innovative efforts to tackle binge drinking in the student population were described by the student presidents and welfare officers of Robert Gordon University. They described a typical night out for members of sports clubs. The consumption of alcohol in student flats, bought from local off-sales featured as a defining part of the evening. These heavy drinking episodes might be limited to groups of students on isolated occasions but they are still more common in university students than non students³. The harm that this type of drinking can cause can persist well into later life, recent research from Glasgow University shows that attending university is a risk factor for heavy drinking in middle and older age⁴.

We have a duty of care to young people to ensure their health and wellbeing and provide an environment that does not encourage them to consume more alcohol than they intended or to consume alcohol when they hadn't intended to.

The size of the alcohol display and its position in the shop has all been shown to encourage more alcohol purchasing than was originally intended. Marketing advice to retailers suggests maximising visual impact to encourage sales. Suggested means include placing alcohol at the end of an aisle, increasing the size and appeal of the alcohol display area⁵. The more alcohol that is purchased, the more is consumed.

Non drinking adolescents' exposure to in-store alcohol displays are significantly linked to their onset of alcohol consumption within 2 years⁶.

Whilst I accept that a local shop is an important amenity, I am of the opinion that it serves a population in whom hazardous alcohol consumption is already an important public health problem. It will also serve as a local amenity for young people under the age of 18 who may be living away from home for the first time. Whilst many young people may be emotionally mature and able to handle peer pressure and stress, others may not be so confident or so emotionally mature. It is therefore vitally important that this premises, a facility that they are likely to use on a regular basis, does not pose a risk to the health and wellbeing of our young people by directly or inadvertently encouraging them to purchase alcohol where they had not intended to do so.

To this end I would suggest that the off-sales capacity for the new store is restricted to match what was available in the previous premises.

To compliment this approach I would suggest that the following conditions are applied to the granting of this license:

- 1. That the premises stock and promote a range of "no" and "low" alcohol products. (see attached booklet for examples of products)
- 2. That the premises do not position alcohol at the front of the store or at the end of an aisle.



In terms of Section 22(1)(b)(ii) and (iii) of the same Act, I make the following representation and am of the view that in the circumstances described, the outdoor area should be included in the 'licensed area' if not already so. As statutory consultees, Police Scotland have an undated copy of a site plan relating to the premises, around which a red line, which ordinarily delineates a licensed area, is drawn around the area that appears to be the whole property. This is a matter which perhaps requires clarification by the local authority.

If, however, the area external to the clubhouse or pavilion is not a licensed area but is adopted as such, or in the case that the consumption of alcohol in that area is to be permitted on an 'on sales' basis, I further recommend that this outdoor area be subject to a terminal hour of 2100, in recognition of the premises being largely bounded by residential properties.

I am e-mailing on behalf of Dyce and Stoneywood Community Council re the application for a variation of licence (major) by Dyce Bowling Club.

We object to the off-sales component of this application. Reason: to protect public health and minimise crime and disorder. The bowling club is adjacent to a children's playground and it is not appropriate for alcohol to be consumed there. There are several convenience stores and licenced premises already selling alcohol (off sales) within a few hundred metres of this site.

We object to the provision of restaurant facilities outwith core hours (after 10pm). Reason: to protect nearby residential amenity from the effects of late-night noise and potential antisocial behaviour. There is insufficient car parking space on nearby streets to accommodate large groups.

We have serious concerns re a 'pop-up' (temporary?) restaurant in terms of noise and smells affecting nearby residential amenity. If the 'pop-up' restaurant is allowed, there should a condition prohibiting outdoor amplified television and radio broadcasts, music and other announcements at all times. Reason: to protect residential amenity.

The variation requested consists of amending Question 5 of the Operating Plan to include the provision of outdoor drinking.

In terms of Section 29(5) of the Act this request can be considered a variation.

In terms of Section 22(1)(a) of the same Act, I wish to make the following objection.

This application relates to an area that is approximately eight metres in length, three metres wide and situated to the left of the main door to the premises, thus occupying a considerable section of the delineated pavement. Although the area is predominantly pedestrianised it is still considered a public road to which certain vehicles are permitted access.

St Nicholas Street, Aberdeen is an area that experiences very heavy pedestrian footfall as it is a main thoroughfare which intersects Union Street and a crossing point between large retail areas.

In the past year, there have been several reported crimes of anti-social behaviour involving youths in St Nicholas Street, Aberdeen. Whilst the number of incidents is not significantly high, Police Scotland is of the view that an outdoor drinking

area is not conducive to an area that experiences such heavy pedestrian footfall and youth disorder and is additionally concerned that should this application be granted, it would set a precedent that other premises in a similarly busy area would seek to replicate.

In terms of section 22(1)(a) of the Licensing (Scotland) Act 2005 the Chief Constable is of the opinion that the variation should be refused on the grounds that it would be inconsistent with the licensing objectives of:

- preventing crime and disorder;
- preventing public nuisance.

If, however, the Board are minded to grant this application, in terms of Section 22(1)(b)(ii) and (iii) of the Licensing (Scotland) Act 2005, I make representation in connection with the foregoing concerns and recommend that the following conditions be imposed:

- the outdoor seating area must be clearly demarked by barriers or other form of physical boundary;
- alcohol is to be decanted into plastic containers or safety glass;
- alcohol is only to be sold for consumption in the outdoor area when in conjunction with food;
- alcohol is not to be consumed within the outdoor seating area after 2100 hours daily.





The above application has been assessed by this Service in relation to noise including music noise breakout from the premises. Consideration has been given to the risk of noise impact on local residences at the proposed times.

As with any such matter it is naturally desirable to avoid a situation that would result in this Service serving formal notices to abate activities that have caused nuisance.

Having carefully considered the matter I am not objecting to this application. However, in relation to the outside seating area, to protect the amenity of residential property near to the proposed location from noise I recommend a condition prohibiting amplified music in the outdoor area and that the outdoor area is not used after 22:00 Hours.

There is also an expectation that Management at the premises would establish and apply suitable and robust noise control measures for all reasonably foreseeable noise sources associated with the business. This is considered necessary to protect the amenity of local residences and reduce the risk of noise impact and disturbance constituting a statutory nuisance. These noise sources may include for example; music noise breakout from the premises, food and beverage delivery and waste disposal along with patron noise from use of the outside seating area.

I would therefore recommend that these noise control measures are formalised in writing to demonstrate and convey to staff for training purposes the specific detail of the required noise controls.

Licensing (Scotland) Act 2005 – Application for a Variation of Premises Licence Saltoun Arms, 69 Frederick Street, Aberdeen, AB24 5HY

I refer to the above application and in terms of Section 22(1) (a) of the Licensing (Scotland) Act 2005; I make the following objection under the licensing objective:

Protecting and Improving Public Health.

The Saltoun Arms wishes to amend their operating plan to include:

- off-sales availability between the hours of 10:00 to 22:00, Monday to Sunday
- on-sales availability between the hours of 10:00 to 24:00, Monday to Sunday
- removal of bar meals, club, receptions and film facilities
- add outdoor drinking facilities

The premises intend to incorporate the unused kitchen into a bar area with the creation of seated space and also create a beer garden. The provision of food within licensed premises can be viewed as a protective factor as this slows the absorption of alcohol and also offers patrons the choice of eating. Removing the provision of food is therefore viewed in a negative way. When combined with additional capacity for drinking alcohol, both in customer numbers (additional 16 persons – not including the beer garden) and extended opening times (additional 10 hours on sales and 5 hours off-sales) this gives reason for concern from a public health perspective.

This objection will focus on the following points

- 1. The direct and indirect health effects of alcohol on the local population
- 2. Evidence of alcohol dependence in the local population
- 3. Low risk drinking guidelines

1. The direct and indirect health effects of alcohol on the local population.

The health of the population living around the premises is described in detail below; rates of harm caused directly and indirectly by alcohol consumption are particularly high in the local areas surrounding the premises. Although we compare the local area to the Scottish average, it is important to place our findings in context. Scotland has amongst the highest rates of alcohol related harm in the United Kingdom and fares poorly in comparison with other European nations. Comparing poorly to the Scottish average should therefore give great cause for concern.

Rates of alcohol related deaths for the postcode sector where the applicants premises is located are recorded as red for men and women in the Aberdeen City Traffic Light profiles indicating that they are higher than the Scottish average¹.

During 2015/16, in Aberdeen, 44 people died as a direct consequence of alcohol. Over the past 15 years, there has been no decline in death rates in Aberdeen City. Many of the deaths in the city are due to the toxic effect of alcohol on the liver following years of heavy consumption. People who die as a result of alcohol do so prematurely, the average age of Aberdeen residents who died was 56. The shortened life span of some long term heavy drinkers in Aberdeen City contributes to the health inequalities evident across the city and the poor health outcomes evident in residents of the AB24 5 post code sector area.

In 2014/15, there were 1533 hospital stays as a result of alcohol of which 86% where emergency admissions. Rates of alcohol related hospital admissions for the postcode sector in which the applicants premises is located are recorded as red for men and women in the Aberdeen City Traffic Light profiles indicating that they are higher than the Scottish average¹.

Premature deaths from cancer in this post code area are recorded as red in the ScotPHO profiles indicating that they are higher than the Scottish average¹. Harmful alcohol consumption is one of the top three most preventable causes of cancer².

ScotPHO mental health indicators also give cause for concern with higher than the Scottish average psychiatric hospital patient admissions for the entire post code area. Data zone IZ022, which represents 74.8% of this post code population is recorded as red for deaths from suicide¹. Depression is one of the most common mental health problems in the UK – experienced by as many as one in ten people in any year and it shares a complex, mutually re-inforcing relationship with excessive alcohol consumption. This means regardless of whether heavy alcohol consumption or mental health issues came first, having one condition makes it significantly more likely the other will develop.



2. Referals to Integrated Alcohol Service

In Aberdeen City, people who develop dependence or addiction to alcohol are referred by their GP to the Integrated Alcohol Service for specialist treatment. In 2015, the area surrounding this premises had a higher rate of referral for alcohol addiction treatment than Aberdeen City as a whole. We would infer from these findings that there are likely to be a higher proportion of people living in the local area who are affected by alcohol dependence than other parts of Aberdeen City.



Whilst there is no silver bullet to tackling alcohol problems, it is clear that availability is linked to consumption and consumption is linked to harm. We conclude from the wide range of statistics presented above that the area surrounding the applicants premises has demonstrably higher levels of alcohol related harm than the rest of the city. The applicants proposal to extend the hours during which alcohol can be sold and increase the capacity of the premises serve to increase the availability of alcohol in the local area.

3. Low risk drinking guidelines

Recent changes to the low risk alcohol guidance issued by the Chief Medical Officers for the United Kingdom highlighted that there was "no safe level of drinking". The health harms from regular drinking of alcohol can develop over many years. Whilst the short term harms, such as accidents and violence as a result of alcohol are well recognised, it is less well recognised that repeated exposure to these risks can exert a cumulative long term effect. The guidance also identified a number of long term diseases caused by alcohol, which may take ten to twenty years to develop. These illnesses, include certain cancers, strokes, heart disease, liver disease, and damage to the brain and nervous system. The damage can occur despite drinking for years at apparently normal levels. The Chief Medical Officer recommends drinking alcohol with food to minimise the short and long term health risks from the regular drinking of alcohol. One of the purposes of this revised guideline was to provide information for the public in a clear and open way so that they can make informed choices. We are concerned that the proposed variation prevents people from choosing and adopting low risk drinking behaviour that would protect and improve their health.

From the evidence submitted in this letter signs of significant alcohol related harm are already evident in this local population. I would suggest that granting this variation would contribute to further negative impact on their health and wellbeing. For these reasons, and in terms of Section 22(1) (a) of the Licensing (Scotland) Act 2005, the Public Health Directorate of NHS Grampian submits this objection to the application as the granting of it would be inconsistent with one or more of the licensing objectives, namely Protecting and Improving Public Health.

LICENSING OBJECTIVE – PROTECTING CHILDREN FROM HARM

- 28.1 The Board wishes to see family friendly premises thriving in the city. It welcomes applications from those who wish to operate licensed premises which accommodate children. In determining any such application the risk of harm to children will be paramount.
- 28.2 Where applicants wish to operate such premises, the Board expects them to appreciate that this places additional responsibilities upon them at the same time recognising that parents and other adults accompanying children also have responsibilities.
- 28.3 Children may be adequately protected from harm by the action taken to protect adults but they may also need particular measures to be taken. When addressing the issue of protecting children from harm, the applicant must consider those factors which may particularly impact on children.

- limitations or exclusions by age when certain activities are taking place
- imposition of requirements for children to be accompanied by an adult
- acceptance of accredited proof of age cards with photographs, or passports
- measures to ensure children do not purchase, acquire or consume alcohol
- measures to ensure children are not exposed to incidences of violence or disorder.

The Board requires applicants who submit operating plans which include provision for children to ensure that they are not given access to premises when activities such as adult entertainment are taking place.

I refer to the above application and in terms of Section 22(1) (a) of the Licensing (Scotland) Act 2005; I make the following representation under the licensing objective:

Protecting Children from harm.

Six Degrees North wishes to vary the operating plan to reflect a significant change in the intended character of the premises. The variation is intended to move more of the capacity to seated dining rather than vertical drinking with a greater dining area to be created and restaurant facilities provided in addition to the current "bar meals". It is also intended that Children and Young Persons be allowed to attend the premises on certain terms

Section 6(c) of the operating plan states that "Children and young persons will be allowed access to the premises if they are accompanying a person aged 18 or over and a) that person is present within the premises for the purpose of making an off-sales purchase, or b) that person and the child or young person are both present for the purpose of partaking in a meal."

Section 6(d) of the operating plan states that "Children and young persons will be allowed in the premises until 10pm"

We wish to suggest that Section 6(d) of the operating plan be amended in an effort to limit any potential harm to children and young people to read:

"Children will be allowed in the premises until 21:00 Young people will be allowed in the premises until 22:00"

For these reasons, and in terms of Section 22(1) (a) of the Licensing (Scotland) Act 2005, the Public Health Directorate of NHS Grampian submits this representation to the application as the granting of it would be inconsistent with one or more of the licensing objectives, namely Protecting and Improving Public Health.

I refer to the above application for the variation of a premises licence under terms of Section 29(5) of the Licensing (Scotland) Act 2005.

The variation requested seeks to merge the separate premises at 5 and 9 Union Street, Aberdeen and to include a connecting stairway between the ground and basements floors of the 'new' premises. The application indicates that the terms detailed in both premises' current operating plans are to remain unaltered, thus creating what is referred to as a 'hybrid' premises.

In terms of Section 29(5) of the Act this request can be considered a variation.

In terms of Section 22(1)(b)(ii) and (iii) of the same Act, I make the following representation on behalf of the Chief Constable.

The operating plan that accompanies the application specifies the different 'on-sales' commencement and terminal hours that apply to the two parts of what is to become one premises. However, the latest version of the operating plan does not detail the difference between certain activities: for example, it indicates that 'dance facilities' apply to the premises but does not define that the 'dance facilities' relate to the basement part of the premises and not the ground floor, which would be in keeping with the existing activities. This is similarly the case in the section that refers to the times during which children and young persons will be permitted access to the premises. The new operating plan indicates that children will not be permitted access after 2230 hours, however the times currently in place for that

particular element are 2230 hours for the basement, subject to certain terms, and 1800 hours on the ground floor.

The applicant's agent has confirmed that the existing terms in respect of these two matters remains unchanged. I am therefore of the opinion that the operating plan in its current form should be modified to clarify the matters raised herein.

We act on behalf of Royal Athenaeum Suites ("the Suites") which are operated by Aberdeen Douglas Hotel. Our clients were notified of a major variation in respect of Premises Licence reference AC0602 UnderDog, 5 Union Street, Aberdeen, by letter dated 5 December 2016. The notification letter stated that the deadline to object to the application is Tuesday 27 December 2016. This letter is therefore timeous.

Our clients have operated the Suites since 2014, following refurbishment of the top 4 floors from first to fourth floor level at 15 Union Street, Aberdeen. The Suites comprise 46 serviced studio, one and two bedroomed apartments which can be rented out for short or long term stays. The Suites are served through a 24 hour reception desk accessed from Union Street. The central location overlooking the City's Town House, historic Castlegate square and the city centre views make the Suites attractive to tourists, business clientele and short stay vacationers alike. The major variation application relates to the licensed premises which sit in the basement, beneath our clients' Suites, but also affects the licensed premises at ground floor level immediately beneath our clients' Suites.

We note that the major variation application has been submitted in order that two separate licences can be amalgamated into a single licence. We understand that the premises licence to be altered is reference AC0602 relating to the premises called UnderDog at 5 Union Street, which is a licensed nightclub in the basement of the property which also houses our clients' Suites. Premises licence reference AC0603 in respect of the premises referred to in that licence as The Granite City Fix at 9 Union Street, a bar/restaurant at ground floor/street level, is to be surrendered in due course should

the major variation application for the proposed merger of the licences be granted by the Board. We note that the variation application does not seek to amend the hours of either of the separately licensed premises at this stage and should the variation application be granted the terminal hours will remain unchanged for each of the two different parts of the premises.

Section 22 of the Licensing (Scotland) Act 2005 sets out the grounds on which any person can object or make representations on an application. Detailed grounds of refusal are set out in Section 23(5) and these include where, inter alia, the Board considers that the granting of the application would be inconsistent with one or more of the licensing objectives. Representations can also be made as to modifications which a person considers should be made to the operating plan accompanying the application, or as to conditions which the person considers should be imposed.

Our clients have concerns about the way in which the licensed premises will operate under the proposed amalgamated single licence and accordingly believe that the major variation application is contrary to the licensing objectives of preventing crime and disorder, securing public safety and preventing public nuisance.

Our clients therefore object to the major variation application on the following grounds:

- 1. As the covering letter for the major variation application notes, this is a "novel variation", the result of which will be that the operating plan for the single licensed premises will contain different provisions and separate requirements for both the ground floor and basement levels. Our clients are concerned that this will lead to difficulties in managing the combined premises and indeed for the Police and LSOs in terms of monitoring compliance with the terms of the operating plan and the licensing objectives. Whilst combining the licences will enable a single Designed Premises Manager (DPM) to be appointed for the combined premises, given the layout, the very different nature of the premises and the potential clientele on each floor, it is not clear that the DPM will have the requisite control to ensure that no offences are committed on the licensed premises and hence that the premises are managed in accordance with the licensing principles.
- 2. As the Board's Licensing Policy states, factors which impact on crime and disorder include, but are not exclusively limited to, underage drinking, drunkenness on premises, illegal possession and/or use of drugs, violent behaviour, anti-social behaviour and noise nuisance as a result of those smoking outside premises. The applicant has not demonstrated how the variation will meet the licensing objectives of preventing crime and disorder in light of the factors noted above. It is particularly important that they are able to do that if patrons will be able to pass freely between the different licensed areas.
- 3. The Board's Policy also looks for an applicant to consider those factors which impact on public safety. No such statement is included with the application and the mere inclusion of an internal stair for patrons to use is not sufficient to demonstrate public safety will be maintained.
- 4. The covering letter for the application indicates that the merger of the two Licences is sought in order for "inter-connectivity internally to allow customers to move from one

premises to another". Our clients believe that such movement will potentially circumvent the local condition imposed on Premises Licence AC0602 and the ability of trained door supervisors to make a judgement about whether or not to deny the entry of customers who are drunk or disorderly, as they would normally do in order to uphold the prevention of public nuisance objective in accordance with the Board's Policy which expects door supervisors to be particularly vigilant about numbers entering the premises.

There is no suggestion that the hours of either separate premise licences are to be altered at this stage, but it is of concern that the public may be able to go between the premises freely. There is a significant overlap between the opening hours of the premises as UnderDog opens at 5pm and the ground floor premises do not shut until midnight or 1am. The overlap of hours does not increase the number of hours people may be able to purchase alcohol, but the internal access arrangements will enable free passage between the premises such that the bar staff may not be able to assess the suitability or otherwise of the patrons being served, or monitor the alcohol intake of those patrons, since they will not always be served at the same bar. There is no mention of whether the stair well will be staffed and if drinks will be able to be purchased in one area, but consumed in the other licensed area.

It is not clear whether the combination of the licensed areas with the plans and/or fire escape routes. We trust that Building Standards will review the plans and consider these issues in more detail than our clients are able to. We note that a building warrant application was made on 22 October 2016, which works included the installation of an acoustic corridor, but we have not been able to ascertain if a completion certificate has been issued and therefore whether or not the acoustic corridor has been implemented in accordance with the building warrant. An explanation as to how the safe passage of people may be managed appropriately, having regard to the licensing objectives of preventing crime and disorder, securing public safety and preventing public nuisance is required. The fact that people are not exiting the building does not automatically mean that the objectives will be met.

5. Our clients currently experience noise disturbance in their Suites as a result of the premises being operated by the applicant. Noise is being transferred from the basement level through the works which the applicant has carried out to strip the property back to bear walls and steel beams, which offer no protection or mitigation to sound escaping. The fit out of the premises in fact appears to amplify the noise throughout the building. Our clients have received complaints from those staying in the Suites, as well as staff members working in the reception area, who are all affected by the noise generated from the licensed premises due to the loud music. Our clients wish to work with the applicant to resolve these issues and have written directly to them to discuss matters further, but the Board's policy states that there is a wish to maintain and protect the amenity of occupiers of other businesses and residents from the potential consequence of the operation of licensed premises. Paragraph 26.3 of the Board's Policy indicates that the Board may apply stricter conditions, including restrictions on licensed hours, where the activities may impact on residents or other business premises and where relevant representations have been received.

It should also be noted that our clients are concerned that combining the licences blurs the distinct obligations under each licensed area and will therefore lead to further noise issues, as it will be more difficult to monitor and observe the terms of the separate obligations in a single licensed area. In considering the application for the major variation we would request that, should the Board be minded to approve the application, noise conditions be imposed to ensure that the different parts of the premises, which have different hours of operation, are run appropriately and incognisance of the quasi residential uses above the premises. Our clients have, and will continue to liaise with the applicant in terms of perceived public nuisance from the noise which is currently being generated from the premises. Our clients do not believe that the noise generated is arising from patrons going between the two separate licensed areas.

We trust that the issues raised in this letter of representation will be considered at the Board when the application is determined, which we understand to be scheduled for Tuesday 17 January 2017. We would wish the opportunity to appear with our clients in order to speak to this representation and look forward to receiving confirmation of when the variation application will be determined.
