It wishes to maintain and protect the amenity of occupiers of other businesses and residents from the potential consequence of the operation of licensed premises, whilst recognising the valuable cultural, social and business importance that such premises provide.
- 26.2 The Board will interpret public nuisance in its widest sense and will take it to include such issues as noise, light, odour, litter and anti-social behaviour. In particular the Board will consider that flyposting is both a public nuisance (litter) and anti-social behaviour in terms of its impact on the community.
- 26.3 Applicants should be aware that the Board may apply stricter conditions, including restrictions on licensed hours, where the activities may impact on residents or other business premises and where relevant representations have been received.
- 26.4 The Board believes that the impact of licensed premises on a neighbourhood is significantly influenced by the times when those premises are open. The Board may restrict hours of opening when considering a premises licence application, if it considers this to be appropriate. The Board will consider each case on its merits.

# LICENSING (SCOTLAND) ACT 2005 APPLICATION FOR THE VARIATION OF A PREMISES LICENCE MANZIL INDIAN RESTAURANT, 22-24 KING STREET, ABERDEEN, AB24 5AX

I refer to the above application for the variation of a premises licence under terms of Section 29(5) of the Licensing (Scotland) Act 2005.

The variation requested consists of the following requests, namely;

- 1. Change the Designated Premises Manager;
- 2. Amend the commencement of on sales core hours on Sunday from 1230 to 1100:
- 3. Amend Q4 in relation to seasonal variations to permit the premises to operate until 0200 hours on Hogmanay;
- Amend Q5 to include the provision of Bar Meals, Receptions, Club or Group Meetings, Recorded Music and Live Performances during core hours;
- 5. Amending Q6 in relation to Children and Young Persons access and the terms under which they are permitted;
- 6. Changing the layout of the premises to reduce the restaurant area, include a stage area and include a large area of removable seating;
- 7. Amend the description of the premises from 'Indian Restaurant' to 'Comedy Club'.

In terms of Section 29(5) of the Act this request can be considered a variation.

In respect of points 1, 2, 6 and 7, I have no adverse comment to make.

In respect of the other requests, in terms of Section 22(1)(b)(ii) and (iii) of the same Act, I make the following representation.

The application and accompanying operating plan and layout plan indicates a number of significant changes to how the premises wish to operate. The premises currently operates as an Indian Restaurant and was granted a licence which reflects this environment, particularly in relation to core operating hours and children and young person's access.

I am of the opinion that despite the premises still offering the provision of restaurant facilities, the request essentially seeks to change the nature of the premises from being a restaurant to a hybrid-style premises that offers the provision of live performances and other activities, as listed on the operating plan which accompanies the application. It is unclear whether restaurant facilities would still be offered at the same time as some of the many other activities described.

The premises current operating plan permits them to operate until 0100 hours from Monday to Sunday by virtue of offering restaurant facilities. It is my opinion that the Board should satisfy themselves, as per the aforementioned statement whether the nature of the premises has materially changed and, as such, whether the premises would in fact be entitled to operate until 0100 hours. This will have an impact on whether the Board is minded to grant point 3 above, bearing in mind that in terms of the general direction, the premises would, I believe, be permitted to open until 0200 hours.

In respect of point 4, the applicant has indicated that they wish to include the provision of Bar Meals, Receptions, Club or Group Meetings, Recorded Music and Live Performances during core hours.

The operating plan that accompanies the application states that the premises will primarily operate as a comedy club and will offer other activities such as themed evenings, casino nights, auctions, bingo nights, karaoke nights, race nights, cocktail demonstrations and wine and drinks tastings. It appears that when such activities are to take place, they would be the principal attraction to the premises and therefore not an activity ancillary to a meal. I therefore request that the Board is satisfied that the premises are operating licensed hours consistent with Appendix 4 of the current Policy.

In respect of point 5 relating to Children and Young Persons access, I am of the opinion that given the core function of the premises has materially changed, and as such, in terms of Section 22(1)(b)(ii) and (iii) of the same Act, I recommend that the operating plan in its current form in relation to such terms is modified to reflect the following:

 Young Persons are permitted access until 0100 hours for the purposes of having a meal, or attending <u>an age appropriate</u> function or event, but must be accompanied by an appropriate adult over eighteen years of age after 2200 hours. • Children and Young persons are not permitted on the premises when the principal activity taking place is an activity such as casino nights, bingo nights, race nights, cocktail demonstrations and wine and drink tastings.

This representation is submitted for your attention in considering this application.





#### Licensing (Scotland) Act 2005 Application for Variation of Premises License – 22 – 24 King Street Aberdeen AB24 5AX

Dear Sir/Madam,

The above variation application has been assessed by this Service. The assessment focussed on the introduction of amplified live and recorded music element and a terminal hour of 01:00 Hours. This significant change is considered to have increased potential for impact on neighbouring residences.

It is naturally desirable to avoid a situation that would result in this Service serving formal notices to abate activities that have caused statutory nuisance. I am of the opinion that application of suitable music noise control measures can protect the amenity of local residences and reduce the possibility of disturbance and statutory noise nuisance.

Having carefully considered the matter I am not objecting to this application, an appropriate noise impact assessment to establish the noise control measures is however considered necessary.

I would therefore request a detailed noise impact assessment by a suitably qualified independent noise consultant is carried out to the satisfaction of this Service.

This assessment should identify the likely sources and levels of noise arising from the premises and any noise attenuation measures required to ensure music noise is inaudible (essentially 10 dB(A) below background  $L_{A90}$  noise levels) in the neighbouring residential property during the periods in question.

On the assessment being considered sufficient, any noise attenuation measures identified must be installed, in the interests of protecting amenity of neighbouring residential properties from noise.

- 28.1 The Board wishes to see child safe premises thriving in the city. It welcomes applications from those who wish to operate licensed premises which accommodate children and families. In determining any such application the risk of harm to children will be paramount.
- 28.2 Where applicants wish to operate such premises, the Board expects them to appreciate that this places additional responsibilities upon them at the same time as recognising that parents and other adults accompanying children also have responsibilities.
- 28.4 The following examples of control measures are given to assist applicants.
  - effective and responsible premises management
  - adoption of best practice guidance
  - imitations on the hours when children may be present, in all or parts of the premises
  - imitations or exclusions by age when certain activities are taking place
  - imposition of requirements for children to be accompanied by an adult

- acceptance of accredited proof of age cards with photographs, or passports
- measures to ensure children do not purchase, acquire or consume alcohol
- measures to ensure children are not exposed to incidences of violence or disorder
- appropriate training and supervision of those employed to secure protection of children from harm.

Imposition of reasons for children to be present and/ or accompanied by a responsible person / adult who shall have responsibility for, and supervise such children and young persons will normally only be admitted to licensed premises for the purpose of consuming light refreshments or a meal, partaking in a relevant sporting activity or attending a pre-arranged function

## LICENSING (SCOTLAND) ACT 2005 APPLICATION FOR THE VARIATION OF A PREMISES LICENCE MCNASTY'S, 37 SUMMER STREET, ABERDEEN, AB10 1SB

I refer to the above application for the variation of a premises licence under terms of Section 29(5) of the Licensing (Scotland) Act 2005.

The variation requested consists of the following amendments to the operating plan:

- 1. On sales licensed hours to be amended to allow a later opening time of 1100 hours and terminal hour of 0200 hours each Friday and Saturday.
- 2. Off sales licensed hours to be amended to allow sales to commence at 1100 hours each Friday and Saturday.
- 3. The addition of seasonal variations to allow additional licensed hours in accordance with the Licensing Board's Festive Guidelines.
- 4. An amendment to hours of entry for young persons, restricting the terminal hour to 2200 hours.

In terms of Section 29(5) of the Act this request can be considered a variation.

In respect of points 2 and 3 above, I have no adverse comment to make.

In respect of point 1 above, in terms of Section 22(1)(a) of the same Act, I make the following objection and recommend that this element of the variation be

refused on the grounds that it would be inconsistent with the licensing objectives of Preventing Crime and Disorder.

Currently, the premises operating hours are consistent with the guideline operating hours for premises offering 'not significant entertainment' as detailed within Appendix 4 of Aberdeen City Licensing Board Statement of Licensing Policy 2013-2016. Meanwhile, the Operating Plan pertaining to the premises has indicated that the activity of 'live performances' which may take place after 2100 hours on Fridays and Saturdays is dedicated to karaoke performances.

Following contact with the applicant's agent, it is understood that the additional hour on Friday and Saturday is sought for the purpose of allowing patrons to enjoy an extra hour of karaoke entertainment.

Appendix 4 of the Aberdeen City Statement of Licensing Policy 2013-2016 indicates what the Board to be 'significant entertainment' and 'not significant entertainment' and the guidelines operating hours for both.

The activity of karaoke is detailed under the activities the Board considers to be 'not significant entertainment', the guideline terminal hour of which is 0000 Sunday to Thursday and 0100 hours on Friday and Saturday.

Since mid- 2016, Aberdeen City Licensing Board has considered several applications made for an increase to the terminal hour of premises that have, for many years, operated 'not significant entertainment' hours.


Police Scotland has objected to such applications on the basis that it would, in our view, be inconsistent with the licensing objective of Preventing Crime and Disorder as crime statistics consistently demonstrate that, in terms of the Aberdeen city centre, the longer and later 'on sale' licensed premises are open, the higher the incidence of crime and disorder, particularly crimes of violence and this has been amply evidenced by Anti-Social Behaviour Reports, compiled the Aberdeen Community Safety Partnership, which have formed the basis of the objections to extensions of terminal hours.

I am aware that when considering such applications, the Board has taken into account what it considers constitutes 'significant entertainment' and has applied their policy in terms of operating hours accordingly.

In respect of this application, the activity to take place which appears to form the basis of the later terminal hour sought does not constitute 'significant entertainment' in the Board's current Policy.

Police Scotland maintains the position that longer and later licensed hours leads to an increase in the commission of crime and disorder, particularly crimes of violence and, with regard to Aberdeen city, while the overall figures in terms of crime appear to be decreasing, the figures pertaining to serious assaults are not reducing. To that end, I provide the following relevant data, which is exclusive to Aberdeen city centre during the weekend night time economy hours (i.e. 2200 to 0559 on Friday and Saturday nights).

Common Assault	391	312	275
Serious Assault	41	35	41



The most recent data capture possible, for the year 1 July 2016 to 30 June 2017, indicates there were 36 serious assaults recorded within Aberdeen city centre during the weekend night time economy hours. All with the exception of one are linked to the consumption of alcohol within the city centre.

Of these 36, eleven were committed on licensed premises and of these eleven; eight were committed within late opening venues (premises open beyond 0100). Of the 25 committed outwith licensed premises, all persons involved had consumed alcohol in the time period prior to the offence.

All offenders (with the exception of one) who were traced at the time of the offence had a recorded sobriety status of 'had been drinking' or 'drunk'.

However, 21 of the 36, just less than two thirds, can be directly linked to persons who had been drinking within late opening venues.

April 2013, the Scottish Community Safety Network published a report, in conjunction with several supporting documents, entitled 'Measuring Preventative Spend - A Cost Toolkit for Community Safety'. Although dated April 2013, the Community Safety Partnership considers this document to still be accurate and relevant. The report provides that the estimated average cost of a serious assault was £24,719. These costs significantly impact on the public services involved, not just the police service; the health service and criminal justice system are similarly

affected and it is my view that the 'public purse' continues to be faced with meeting the costs of alcohol fuelled violence.

In respect of point 4, in terms of Section 22(1)(b)(ii) and (iii) of the same Act, I make the following representation. I am supportive of this element of the variation sought; however, wish it to be brought to the attention of the Board that the terms under which children and young persons are permitted access to these premises appears somewhat broad and perhaps outdated and inconsistent with the terms enjoyed by similar premises.

Currently, the circumstances in which children and young persons may be on the premises is undefined other than stating that children must be accompanied by an adult. There is no qualifying reason why children would be on the premises, as can be found in the vast majority of like premises; for example, when partaking of food or attending a function. The premises operates principally as a public house style venue and, I understand, offers significant provision of televised sport, particularly football. No restaurant facilities are indicated, however, the operating plan does indicate that bar meals are offered.

I therefore invite the Board to consider seeking the applicant's agreement to amend the terms at 6(b) of the operating plan, to ensure consistency of the Board's policy, with particular regard to 28.4 of said Policy. This letter is submitted for your attention when considering this application.

I refer to the above application and in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005, I make the following objections under the licensing objective:

#### **Protecting and Improving Public Health.**

The applicant seeks to make a number of variations to the Operating Plan. The variation that concerns NHS Grampian is listed below:

 Amendment to on sale hours on Fridays and Saturdays from 10:00 - 01:00 to 11:00 to 02:00

The Aberdeen City Licensing Board Statement of Licensing Policy, 2013-2016 states at Section 20.3, paragraph 1:

"The Board will deem up to a maximum of 14 hours continuous trading in any 24 hour period to be reasonable."

The terms of the Statement of Licensing Policy are the means through which the five licensing objectives, including protecting and improving public health will be pursued in Aberdeen City. Although we recognise that the premises has been historically trading for a continuous period of 15 hours, we feel any variation to operating times should result in compliance with the current Statement of Licensing Policy.

In addition, in order for a facility to be granted additional late opening times the Board should be satisfied that significant entertainment is being provided. Detailed information on this topic is available within Appendix 4 of the Statement of Licensing Policy. The following example of "**Not Significant Entertainment**" is provided

"For example **karaoke**, billiards, pool, snooker, darts, dominoes, leisure facilities, background live or recorded music"

Within the operating plan it is stated that "After 9pm on Friday and Saturday evenings the whole premises are used as a dedicated Karaoke venue."

For these reasons, and in terms of Section 22(1) (a) of the Licensing (Scotland) Act 2005, the Public Health Directorate of NHS Grampian submits this letter of objection as the granting of the application would be inconsistent with one or more of the licensing objectives, namely Protecting and Improving Public Health.

I am writing to register my objection to the application for a variation of the premises licence by Booktwin Limited for McNasty's, 37 Summer Street, Aberdeen. The basis for this objection is that granting a variation of the licence and extending the lateness of licencing hours undermines Aberdeen City's licensing objectives.

I object to the variation to the licence on the following grounds

- 1. The property to the rear of McNasty's, is both residential and business property located on Chapel Street. The residents in residential premises have a reasonable expectation to a quiet environment at night!
- 2. Public Nuisance: there is already a noise nuisance from the applicant's premises while it is open, and that if the premises were allowed to stay open longer, this will go on until an unacceptably late time. Noise before and after closing time is already a public nuisance problem, as is litter. During existing periods of excessive noise from the premises, residents are already taking measures such as keeping windows closed. A Tripadvisor review dated 23 May 2016 stated 'This pub is the place to be on a Friday night if you want to work those tonsils! Earplugs wouldn't go amiss either!!'
- 3. Some of the residential properties to the rear of McNasty's are rented and approval for this application would increase difficulty in renting out property and potentially reduce property values. This is in contradiction to the intention stated in Aberdeen Inspired's Business Plan 2016/2021, which incorporates Summer Street and Chapel Street, and which has stated aims of promoting our City centre, making it a safe, welcoming and attractive centre and helping business. Aberdeen is alleged to have the third highest proportion of people unable to work due to alcohol issues in the UK.
- 4. A variation to the existing licence to extend on sale hours from 01:00 to 02:00 on Fridays and Saturdays, and amending the times children and young persons are permitted access undermines at least three of the licensing objectives, namely preventing public nuisance, protecting and improving public health and securing public safety.

- 5. Alcohol consumption per capita is already higher in Aberdeen City than Grampian as a region and Scotland across the board. This is particularly notable in the 16-24 age group and it is believed that that group is particularly attracted to karaoke.
- 6. The application proposes that a further source of alcohol will be available at later hours within an area already heavily populated with licensed premises. There are an estimated 33,400 hazardous drinkers and 3,100 harmful or dependent drinkers in Aberdeen City. Police Scotland already consider there to overprovision of liquor licensed premises around Union Street (north side). The excessive consumption of alcohol can often increase the likelihood of both perpetrating and being a victim of crime, particularly within the City Centre area. It is fact that violent crime is most common late at night or early in the mornings and at weekends. The City Centre has, by far, the highest crime rate.

Residents in this area already suffer noise nuisance and antisocial behaviour and it is evidential that approval of the application will make this situation worse.

In view of the above, I would urge the Licensing Board to refuse the application.

According to the findings of the World Health Organisation (WHO), noise is the second largest environmental cause of health problems, just after the impact of air quality (particulate matter).

The World Health Organization's Night Noise Guidelines for Europe present evidence of the health damage of night-time noise exposure and recommend threshold values above which adverse effects on human health are observed. An annual average night exposure not exceeding 40 decibel (dB) has been recommended in the Guidelines.

Sleepers that are exposed to night noise levels above 40dB on average throughout the year can suffer health effects like sleep disturbance and awakenings. Licensing (Scotland) Act 2005 – Application for a Provisional Premises Licence Lidl Store, Inverurie Road, Bucksburn, Aberdeen, AB21 9LZ

I refer to the above application and in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005, wish to lodge an objection under the licensing objective:

#### Protecting and improving public health.

This is a new Provisional Premises Licence as the licence in relation to the Lidl store previously on this site was surrendered. The applicant seeks the following:

- Capacity for off sales display which was previously 42.85m2 to now be 47.61m2 of "normal" trading capacity.
- Add additional seasonal alcohol display area during 1 December of each year to 2<sup>nd</sup>
  January of the following year, to cope with festive demand this equates to an
  additional seasonal capacity area of 12.02m2.

The objection is focused on the request for additional seasonal alcohol capacity between 01 December to 02 January. The additional display capacity requested of 12.02m2 is comparable to the capacity of some small newsagents and convenience stores. We feel that this request is equivalent to the provision of an additional licensed premises in the area for that period. We would ask that the Board consider the request in this context.

This application could provide a total alcohol capacity of 59.63m2. This represents an overall increased capacity of almost 40% for the new Lidl store. We welcome the return of this Lidl store to the Bucksburn area but we would question the requirement for such a large increase to the alcohol display area during these 33 days.

#### Our objection is focussed on the following areas:

- 1. Proximity of similar premises
- 2. Capacity issues
- 3. Increased marketing of alcohol
- 4. Health concerns for Aberdeen citizens

#### 1. Proximity of premises

In section 27.4 of the statement of licensing policy, the Board acknowledges that

"Increased access and availability to alcohol through increased numbers of premises and/or opening hours or decreased pricing is linked to increased consumption, which in turn potentially leads to increased harm...

Alcohol availability is affected by outlet density, outlet distance"

There are 8 existing licensed premises within this post code area which serve the local community.

These premises are open all year round and do not increase the size of the alcohol display between 01 December and 02 January. We do not see any justification for the provision of what would effectively be another premises in this area during this period.

#### 2. Capacity issues

Section 4 of the Statement of Licensing Policy indicates that the Board

"welcomes the powers given to it by the Act and intends to use those powers in a socially responsible way"

The operating plan makes it clear that this additional display area is to help Lidl cope with festive demand. This is a commercial need that should be addressed by the store, e.g. employing more staff to re-stock shelves. We are concerned that granting this request would set a precedent for the expectation of additional display capacity. Replicated over many stores, this could significantly increase the amount of alcohol available for consumption in the city which in turn potentially leads to increased harm.

#### 3. Increased marketing of alcohol

We are aware that special occasions, such as Christmas, herald the introduction of increased marketing of many products, including alcohol.

International evidence clearly indicates that increasing price, reducing availability and restricting marketing are amongst the most effective and cost-effective policy measures to reduce alcohol consumption and harm in a population<sup>1</sup>. They are identified as the 'three best buys' of alcohol policy by the World Health Organization<sup>2</sup>. The Scottish Government's alcohol strategy Changing Scotland's Relationship with Alcohol: A Framework for Action<sup>3</sup>, by giving the 'three best buys' central prominence, is internationally recognised as being one of the most forward-thinking and ambitious responses to alcohol-related harm. The price, availability and marketing of alcohol are intrinsically linked; for example, increased availability increases marketing opportunity and drives down price in a competitive business environment<sup>1</sup>.

We object to any increase in marketing of alcohol that is clearly aimed to increase sales and therefore lead to increased consumption. We are aware that 74% of alcohol is now purchased in off sales premises with drinking at home, in unregulated environments becoming more common<sup>4</sup>. We believe that most harm by drinking alcohol is caused by people drinking at home.

#### 4. Health Concerns

The board are aware of the health harms associated with alcohol and have accepted and acknowledged the evidence submitted by NHS Grampian for the formation of the Statement of Licensing Policy 2013 – 2016.

Information from the Scottish Public Health Observatory (ScotPHO) can be broken down to post code sector. This postcode sector includes the data zone of Bucksburn South which covers 41.2% of the population. Health statistics for this data zone identify alcohol related hospital admissions, early deaths from coronary heart disease and emergency admissions to hospital to be more than 5% worse than the Scottish average<sup>5</sup>. Referral rates to the specialist integrated alcohol service for the treatment of alcohol dependence from the Bucksburn medical practice are above average for Aberdeen City and have remained largely steady, showing no reduction, since 2011.

Lidl is a well known store with broad market appeal. It is likely that its customers would be drawn from across the city.

The Scottish Public Health Observatory (ScotPHO) Health & Wellbeing Profiles for Aberdeen City identify Alcohol related hospital stays as being "statistically significantly "worse" than the National average<sup>6</sup>. Despite the fall in the rate of alcohol related hospital admissions since 2007, the numbers of people newly diagnosed with alcoholic liver disease almost doubled between 2007 and 2016.

The Board will also be aware that health harms are not solely related to the drinker but extend to impact on friends and family. Holiday periods are often a time of added stress for many families.

Even small reductions in the availability of alcohol can contribute to health gain and reduce violence and harm to the population generally, as well as to the drinker themselves. We would suggest that this store limit its alcohol capacity to 47.61m2 in an effort to protect and improve the health status of Aberdeen city residents and request that approval for the increased seasonal display capacity is not granted.

For these reasons, and in terms of Section 22(1) (a) of the Licensing (Scotland) Act 2005, the Public Health Directorate of NHS Grampian submits this letter of objection as the granting of the application would be inconsistent with one or more of the licensing objectives, namely Protecting and Improving Public Health.



I refer to the above application for the variation of a premises licence under terms of Section 29(5) of the Licensing (Scotland) Act 2005.

The variation requested consists of amending the on-sales core hours on Friday and Saturday night from 1200 - 0100 hours to 1200 - to 0300 hours.

In terms of Section 29(5) of the Act this request can be considered a variation.

In terms of Section 22(1)(a) of the same Act, and in support of the Preventing Crime and Disorder licensing objective I make the following objection in relation to the application.

The applicant premises principally provides karaoke facilities. Karaoke is considered within the Aberdeen City Licensing Board Statement of Licensing Policy 2013-2016, at Appendix 4, to be 'not significant entertainment', the guideline terminal hour of which is 0000 Sunday to Thursday and 0100 on Friday and Saturday. Additionally, if granted, the premises would trade for fifteen continuous hours on Friday and Saturday which is also outwith the guidelines contained at 20.3 of said Policy.

Since mid- 2016, Aberdeen City Licensing Board has considered several applications made for an increase to the terminal hour of premises that have, for many years, operated 'not significant entertainment' hours.


Police Scotland has objected to such applications on the basis that it would be inconsistent with the licensing objective of Preventing Crime and Disorder as crime statistics consistently demonstrate that, in terms of the Aberdeen city centre, the longer and later 'on sale' licensed premises are open, the higher the incidence of crime and disorder, particularly crimes of violence and this has been amply evidenced by Anti-Social Behaviour Reports, compiled the Aberdeen Community Safety Partnership, which have formed the basis of the objections to extensions of terminal hours.

I am aware that when considering such applications, the Board has taken into account what it considers constitutes 'significant entertainment' and has applied their policy in terms of operating hours accordingly.

In respect of this application, the activity to take place which forms the basis of the later terminal hour sought does not constitute 'significant entertainment' in the Board's current Policy.

Police Scotland maintains the position that longer and later licensed hours leads to an increase in the commission of crime, particularly crimes of violence, and, with regard to Aberdeen city, while the overall figures in terms of crime appear to be decreasing, the figures pertaining to serious assaults are not reducing and this is illustrated by the following relevant data, which is exclusive to Aberdeen city centre during the weekend night time economy hours (i.e. 2200 to 0559 on Friday and Saturday nights).

Offence/Fiscal Year	2014/15	2015/16	2016/17
ASB	456	409	318
Common Assault	391	312	275
Serious Assault	41	35	41



The most recent data capture possible, for the year 1 July 2016 to 30 June 2017, indicates there were 36 serious assaults recorded within Aberdeen city centre during the weekend night time economy hours. All with the exception of one are linked to the consumption of alcohol within the city centre.

Of these 36, eleven were committed on licensed premises and of these eleven; eight were committed within late opening venues (premises open beyond 0100). Of the 25 committed outwith licensed premises, all persons involved had consumed alcohol in the time period prior to the offence.

All offenders (with the exception of one) who were traced at the time of the offence had a recorded sobriety status of 'had been drinking' or 'drunk'.

However, 21 of the 36, just less than two thirds, can be directly linked to persons who had been drinking within late opening venues.

In April 2013, the Scottish Community Safety Network published a report entitled 'Measuring Preventative Spend - A Cost Toolkit for Community Safety'. Although dated April 2013, the Community Safety Partnership considers this document to still be accurate and relevant. The report provides that the estimated average cost of a serious assault was £24,719. These costs significantly impact on the public services involved, not just the police service; the health service and criminal justice system are similarly affected and it is my view that the 'public purse' continues to be faced with meeting the costs of alcohol fuelled violence.

In support of the Preventing Crime and Disorder licensing objective I recommend that the application be refused.

I refer to the above application and in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005, I make the following objections under the licensing objective:

#### **Protecting and Improving Public Health.**

The applicant seeks a terminal hour of 3am on Fridays and Saturdays. This extension to operating times concerns NHS Grampian as it increases the availability of alcohol.

The Aberdeen City Licensing Board Statement of Licensing Policy, 2013-2016 states at Section 20.3, paragraph 1:

"The Board will deem up to a maximum of 14 hours continuous trading in any 24 hour period to be reasonable."

These premises would be trading for a period of 15 hours on Friday and Saturday if this variation is granted, which would not comply with the terms of the Statement of Licensing Policy.

In addition, in order for a facility to be granted additional late opening times the board should be satisfied that significant entertainment is being provided. Detailed information on this topic is available within Appendix 4 of the Statement of Licensing Policy. The following example of "**Not Significant Entertainment**" is provided

" For example **karaoke**, billiards, pool, snooker, darts, dominoes, leisure facilities, background live or recorded music"

Within the operating plan it is stated that entertainment activity includes:

Recorded music is in the form of background music, or from the karaoke machines in the private karaoke rooms.

Live performance: the occasional social evening with the provision of mobile DJ or musical act.


Although live performance is mentioned there is no indication of the regularity. We are not of the opinion that significant entertainment is provided by this venue. 

The above variation application has been assessed by this Service. The assessment focussed on extension of the terminal hour from 01:00 Hours to 03:00 Hours on Friday and Saturday nights and potential for impact on neighbouring residences.

It is naturally desirable to avoid a situation that would result in this Service serving formal notices to abate activities that have caused statutory nuisance. I am of the opinion that application of suitable music noise control measures can protect the amenity of local residences and reduce the possibility of disturbance and statutory noise nuisance. Additionally, there are no current unresolved music noise disturbance complaints associated with the premises.

Having carefully considered the matter I am not objecting to this application. There is however an expectation that Management at the premises would establish and apply suitable and robust noise control measures for all reasonably foreseeable noise sources associated with the business. This is considered necessary to protect the amenity of local residences and reduce the risk of noise disturbance constituting a statutory nuisance. These noise sources may include for example; music noise breakout from the premises.

I would therefore recommend that these noise control measures are formalised in writing to demonstrate and convey to staff for training purposes, the specific detail of the required noise controls.



- 1. Amend the commencement of on sales hours on Sunday from 1230 to 1100;
- Amend Q5 to include the provision of Club Meetings during core hours and Gaming, Indoor/Outdoor Sports and Televised Sport during and outwith core hours:
- Amend Q6 relating to state that children are permitted unaccompanied access until 2000 hours and young persons are permitted unaccompanied access until 2100 hours, thereafter both must be accompanied by an adult;
- 4. Change the name of the premises to 'Engage Gaming'.

In terms of Section 29(5) of the Act this request can be considered a variation.

In respect of points 1 and 4 I have no adverse comment to make.

In respect of points 2 and 3 and terms of Section 22(1)(b)(ii) and (iii) of the same Act, I make the following representation.

The application and accompanying operating plan and layout plans indicates there are significant changes to how the premises wish to operate. The premises previous operated principally as a restaurant and enjoys licensed hours until 0100, consistent with Appendix 4 of the Board's current Policy.

The applicant seeks to change the core function and environment of the premises from being a restaurant to a premises principally offering computer gaming facilities. There will also be provision of televised sport, indoor and outdoor sport, gaming and other activities as listed on the operating plan which accompanies the application.

Police Scotland spoke with the premises manager regarding all the proposed changes and it was established that the provision of 'restaurant facilities' would no longer be provided and not seen as a core function of the premises. I therefore recommend that the core hours within the operating plan are amended to operate from 1100 to 0000 hours from Sunday to Thursday and between 1100 to 0100 hours on Friday and Saturday.

In respect of point 2 the application includes the provision of 'gaming' which the premises manager has indicated includes competitions resulting in a monetary reward. It is my recommendation that the operating plan is amended to state that 'no person under eighteen years of age will be permitted to participate in a competition that results in a monetary reward'.

In addition it was also established that the premises intend on providing the provision of 'bar meals' therefore I further recommend that the operating plan is amended to include such a provision.

In respect of point 3 above relating to Children and Young Persons access, I am of the opinion that given the core function of the premises has materially changed, and as such, in terms of Section 22(1)(b)(ii) and (iii) of the same Act, I recommend that the operating plan in its current form in relation to such terms is modified to reflect the following:

- Children over the age of five are permitted entry for the purposes of attending an age appropriate pre-booked 'gaming camp' which will be appropriately supervised at all times. No alcohol is permitted to be sold during this time and all 'gaming camps' will terminate by 2000 hours.
- Children under the age of twelve who are not participating in a 'gaming camp' are permitted until 2000 hours and must be accompanied by an appropriate adult over eighteen years of age at all times.
- Children aged 12-15 are permitted unaccompanied access until 2000 hours, thereafter are only permitted to remain on the premises until the terminal hour providing they are participating in an age appropriate private pre-booked function and accompanied by an appropriate adult over eighteen years of age.
- Young persons are permitted unaccompanied until 2200 hours, thereafter are only permitted to remain on the premises until the terminal hour providing they are participating in an age appropriate private pre-booked

function and accompanied by an appropriate adult over eighteen years of age.

Police Scotland have spoken with the premises manager regarding the operating plan that accompanied the application and she intimated they were agreeable to all of aforementioned recommendations.



Currently, the premises operating hours with are consistent with the guideline operating hours for premises offering 'not significant entertainment' as detailed within Appendix 4 of the Aberdeen City Licensing Board Statement of Licensing Policy 2013 - 2016. Meanwhile, the Operating Plan pertaining to the premises has indicated that the activity of 'live performances' may take place during the core hours. 'Live performances' is not further described in said Plan. The Operating Plan which accompanies the application, other than the inclusion of the provision of 'Dance facilities' does not indicate any change in the activities that may take place.

It is understood that the additional hour on Friday and Saturday is sought for the purpose of allowing patrons to enjoy an extra hour of live music, in particular, live percussion bands, and an area has been identified to allow for patrons dancing.

The section of the Operating Plan which relates to premises which open after 0100 has been completed with the responses 'N/A'.

In late 2016 and early 2017, in connection with very similar applications for other licensed premises within Aberdeen city centre, Police Scotland objected to such applications in support of the Preventing Crime and Disorder licensing objective. In doing so, detailed evidence was provided that demonstrated that the longer and later licensed premises are open, the higher the likelihood of crimes of anti-social behaviour, violence and disorder occurring, particularly the commission of serious assaults.

Police Scotland reserves this position and is not supportive in principle to the extension of licensed hours, however, acknowledges that Aberdeen City Licensing Board are entitled to grant such variations if satisfied that premises are offering 'significant entertainment' as is currently defined within said Policy.

To that end, in terms of Section 22(1)(b)(ii) and (iii) of the Licensing (Scotland) Act 2005, I make representation that, if granted, the variation is subject to condition that significant entertainment, to the satisfaction of the Licensing Board, is to take place during some part of the additional hours sought, that is between 0100 and 0200 on Friday and Saturday.

Additionally, in the event the applicant is granted and the premises are not considered premises to which the Licensing Conditions (Late Opening Premises) (Scotland) Regulations 2007 applies, I request it be subject to the conditions specified at 6.5 of the aforementioned Policy, specifically in respect of CCTV, Door Supervisors and Radiolink.





The Freedom of Information (Scotland) Act 2002 (the Act) requires Scottish public authorities to produce and maintain a publication scheme. Authorities are under a legal obligation to:

- publish the classes of information that they make routinely available
- tell the public how to access the information and what it might cost.

Aberdeen City Licensing Board has adopted the **Model Publication Scheme 29 March 2016** produced by the Scottish Information Commissioner.

The purpose of this Guide to Information is to:

- allow you to see what information is available (and what is not available) in relation to each class.
- state what charges may be applied.
- explain how you can find the information easily.
- provide contact details for enquiries and to get help with accessing the information.
- explain how to request information we hold that has not been published.

#### Availability and formats

The information we publish through the model scheme is, wherever possible, available on our website. We offer alternative arrangements for people who do not want to, or cannot, access the information online or by inspection at our premises. For example, we can usually arrange to send information to you in paper copy (although there may be a charge for this).

All our written information can also be made available, on request, in a range of different formats and languages.

#### Exempt information

We will publish the information we hold that falls within the classes of information below. If a document contains information that is exempt under Scotland's freedom of information laws (for example sensitive personal information or a trade secret), we will confirm whether we hold this information and we may remove or redact the information before publication but we will explain why.

#### Copyright

The Board holds the copyright for the vast majority of information in this publication scheme.

Where the Board holds the copyright in its published information, the information may be copied or reproduced without formal permission, provided that:

it is copied or reproduced accurately;

- it is not used in a misleading context; and
- the source of the material is identified.

Where the Board does not hold the copyright in information we publish, we will make this clear.

#### Charges

This section explains when we may make a charge for our publications and how any charge will be calculated.

There is no charge to view information on our website or at our premises or where it can be sent to you electronically by email except where there is a statutory fee

We may charge for providing information to you e.g. photocopying and postage, but we will charge you no more than it actually costs us to do so. We will always tell you what the cost is before providing the information to you.

For photocopying, we will charge a standard rate of 10p per A4 side of paper (black and white copy) and 30p per A4 side of paper (colour copy).

Information provided on CD-Rom will be charged at £1.00 per computer disc.

Postage costs will be recharged at the rate we pay to send the information to you.

If providing copies of any pre-printed publications, we will charge no more than the cost per copy of the total print run.

We do not pass any other costs on to you in relation to our published information. Although, we do charge in relation to information not published under this scheme.

General information request:

- there will be no charge for information requests which cost us £100 or less to produce;
- where information costs between £100 and £600 to provide to you, you may
  be asked to pay 10% of the cost. That is, if you were to ask for information that
  cost us £600 to provide, you would be asked to pay £50, that calculated on the
  basis of a waiver for the first £100 and 10% of the remaining £500;
- we are not obliged to respond to requests for non-environmental information which will cost us over £600 to process;
- where environmental information costs over £600 to provide to you, we may
  ask you to pay the additional cost over that amount in full. For example, if you
  were to ask us for information that costs us £800 to provide, you may be
  asked to pay £250. This fee would be calculated on the basis of a waiver for
  the first £100 costs of providing the information, 10% of the next £500 costs,
  and full cost recovery for cost over £600 (in this example, £200);
- in calculating any fee, staff time will be calculated at actual cost per staff member hourly salary rate to a maximum of £15 per person per hour;
- we do not charge for the time to determine whether we hold the information requested, nor for the time it takes to decide whether the information can be released. Charges may be made for locating, retrieving and providing information to you; and

 in the event that we decide to impose a charge we will issue you with notification of the charge (a fees notice) and how it has been calculated. You will have three months from the date of issue of the fees notice in which to decide whether to pay the charge. The information will be provided to you on payment of the charge. If you decide not to proceed with the request there will be no charge to you.

#### Request for your own personal data:

The Act does not give a person the right to obtain copies of information which the Board may hold about them personally. You are however entitled to request your personal data from the Board under the Subject Access provisions contained in Section 7 of the Data Protection Act 1998.

The Board may charge a maximum fee of £10 for providing your own personal data.

Reguests for information in terms of Section 7 of the Data Protection Act must be –

- 1. made in writing;
- 2. give your name and address;
- 3. include proof of your identity;
- 4. specify the information or documents sought; and
- 5. include any fee applicable.

Such requests should be addressed to the Clerk to the Licensing Board at the address shown below.

# ABERDEEN CITY LICENSING BOARD MODEL PUBLICATION SCHEME 2017

#### Introduction

The Freedom of Information (Scotland) Act 2002 (the Act) requires Scottish public authorities to produce and maintain a publication scheme. Authorities are under a legal obligation to:

- i) Publish the classes of information that they make routinely available
- ii) Tell the public how to access the information and whether information is available free of charge or on payment.

The Act also allows for the development of model publication schemes which can be adopted by more than one authority. The Commissioner's Model Publication Scheme was approved on 29 March 2016

#### About this scheme

This single Model Publication Scheme has been produced and approved by the Scottish Information Commissioner.

It is suitable for adoption by any authority listed in Parts 3, 5, and 6 of Schedule 1 of the Freedom of Information (Scotland) Act 2002 (councils and other local authority bodies, educational institutions, police authorities).

The scheme may also be suitable for adoption by other Scottish public authorities. Any other authority who wishes to adopt the scheme should apply to the Commissioner for approval to do so.

#### **Adopting the single Model Publication Scheme**

This single Model Publication Scheme can be adopted only in its entirety, **without amendment**. It commits an authority to:

- i) **Publishing the information**, including environmental information, that it holds and which falls within the classes of information below.
- ii) **Ensuring** that the way it publishes its information meets the Model Publication Scheme Principles.
- iii) **Producing** a Guide to Information which sets out the information the authority publishes through the model scheme, how to access it, whether there is a charge for it and how to get help to access information.
- iv) Notifying the Scottish Information Commissioner that it has adopted the model scheme.

The Commissioner has issued Guidance to accompany this model scheme <a href="https://www.itspublicknowledge.info/MPS">www.itspublicknowledge.info/MPS</a>. This is essential reading for authorities adopting the model scheme: it explains the above requirements in further detail and lists the types of information the Commissioner expects authorities will publish under each class of information.

## **Guide to Information**

An authority adopting this model scheme must produce a guide to the information it publishes through the scheme. The authority can decide the format of its Guide to Information.

The authority's Guide to Information must:

- I) allow the public to see what information is available (and what is not available) in relation to each class
- II) state what charges may be applied
- III) explain how to find the information easily
- IV) provide contact details for enquiries and to get help with access to the information
- V) explain how to request information that has not been published.

These requirements are set out in more detail below.

#### Principle One: Availability and formats

The information published through this model scheme should, wherever possible, be available on the authority's website. There must be an alternative arrangement for people who do not wish to, or who cannot, access the information either online or by inspection at the authority's premises. An authority may, for example, arrange to send out information in paper copy on request (although there may be a charge for this).

Principle Two: Exempt information

The authority must publish the information it holds that falls within the classes of information below. If a document contains information that is exempt under Scotland's freedom of information laws (for example sensitive personal data or a trade secret), and cannot be published then the authority may withhold the information or provide a redacted version for publication of the information, but it must explain why it has done so.

Principle Three: Copyright

The authority must publish a copyright statement which explains what can, and what cannot, be done with information accessed through this model publication scheme. The statement must be consistent with the fair dealing provisions of the Copyright, Designs and Patents Act 1988.

The Commissioner recommends the use of the Open Government Licence and/or the noncommercial Government Licence, produced by the National Archives for their published information. A link to the licence and an alternative sample copyright statement are available in the accompanying Guidance.

Where the authority does not hold the copyright in information it publishes, this should be made clear.

Any conditions applied to re-use of published information must be consistent with the Re-use of Public Sector Information Regulations 2015.

Principle Four: Charges

The authority must publish within its Guide to Information a charging schedule which explains when there is a charge for publications available through the scheme and how any charge will be calculated. There should be no charge to view information on the authority's website or at its premises, except where there is a statutory fee, for example, for access to registers.

The authority may charge for computer discs, photocopying, postage and packing and other costs associated with supplying the information, but the charge must be no more than these elements actually cost the authority. There may be no further charges for information in Classes 1 – 7 below. An exception is made for commercial publications (see Class 8 below) where pricing may be based on market value.

The authority must provide contact details for enquiries about any aspect of the adoption of the model scheme, the authority's Guide to Information and for requests for copies of the authority's

The authority must give the recipient advance notice of any charges to be applied.

Principle Five: Contact details

published information.

The authority is under a duty to provide reasonable advice and assistance to anyone who wants to request information which is not published and the authority's Guide to Information must provide contact details for this purpose.

Principle Six: Duration

Once published through the Guide To Information, the Information should be available for the current and previous two financial years. Where information has been updated or superseded, only the current version need be available (previous versions may be requested from the authority).

The Commissioner's Guidance accompanying this scheme provides lists of the types of information authorities are expected to publish under each class. The authority's Guide to Information should make clear what is available under each class.

#### PURPOSE OF REPORT

This report provides the Board with an update on progress achieved at the end of Year 2 of the Licensing Boards Equality Outcomes for 2015-2017 and sets out new draft Equality Outcomes for 2017-2021.

## 2. RECOMMENDATION(S)

That the Board

- (1) approve the Licensing Board's new draft equality outcomes for 2017-2021;
- (2) approves the draft Report on the Boards Outcomes and Mainstreaming of the Equality Duty (Appendix 1)
- (3) instructs the Clerk to undertake to publish the Boards new equality outcomes for 2017 2021; and
- (4) note the progress since publication of the Boards equality outcomes and mainstreaming report of 2015.

#### 3. BACKGROUND

- (1) Section 149 of the Equality Act 2010 came into force in April 2011, introducing a new Public Sector Equality Duty that applies to all public authorities, across Scotland, such as Licensing Boards. The 2010 Act brings together the nine protected characteristics into one Act. The Licensing Board therefore have to have due regard to or consciously consider the need to:-
  - Eliminate discrimination, harassment and victimization;
  - Advance equality of opportunity between those who have protected characteristics and those who don't;
  - Foster good relations between those who have protected characteristics and those who don't.
- (2) The purpose of the public sector equality duty is to ensure that public authorities consider how they can positively contribute to a more equal society through advancing equality and good relations in their day-to-day business to:-

- Take effective action on equality
- Make the right decisions, first time around
- Develop better policies and practices, based on evidence
- Be more transparent, accessible and accountable
- Deliver improved outcomes for all

The Public Sector Equality Duty requires equality to be considered in all the functions of public bodies, including decision-making, in the design of internal and external policies and in the delivery of services, and for these issues to be kept under review.

- (3) Everyone is protected by the 2010 Act. Every person has one or more of the protected characteristics, so the Act protects everyone against unfair treatment. The protected characteristics are:-
  - Age
  - Disability
  - Gender reassignment
  - Pregnancy and maternity
  - Race (this includes ethnic or national origin, colour and nationality. It also includes Gypsy-Travellers)
  - Religion or belief (this includes lack of belief)
  - Sex (gender)
  - Sexual orientation
  - Marriage and Civil Partnership (but only in respect of the duty to consciously consider the need to eliminate discrimination, harassment, victimization and other conduct prohibited by the Act.)
- (4) Aberdeen City Licensing Board is a relevant public body under the 2010 Act. Therefore Aberdeen City Licensing Board is required to prepare and monitor the progress towards achieving Equality Outcomes in terms of Regulation 4 of the Equality Act 2010 (Specific Duties)(Scotland) Regulations 2012. The Board published their Equality outcomes in April 2013. In April 2015 the Board published a report, in accordance with its legal duties, on the progress towards achieving those outcomes.

In terms of the required reporting cycle the Board requires to publish a further report on its Equality outcomes in 2017.

In terms of the Licensing (Scotland) Act 2005, Section 5, there is to be a Licensing Board for the area of each Council under Section 46(1) of the Local Government (Scotland) 1994. The members of the Licensing Board are to be elected by the relevant Council from among their members. The Licensing Board although comprised of Councillors is a separate legal body from the Council. The Council must, at its first meeting after each ordinary election of the Council, hold an election of members to the Licensing Board for their area.

The Scottish Council Elections were held on 4 May 2017. Therefore the new Aberdeen City Council elected a new Aberdeen City Licensing Board at the first Council meeting on 16 May 2017.

It is therefore proposed that this new Aberdeen City Licensing Board, should review, consider and approve the required report on its Equality Outcomes.

The new Aberdeen City Licensing Board will also publish their new Statement

of Licensing Policy by November 2018 which will include a statement as to their duties under the Equality Act 2010 as well as their Equality Outcomes.

As part of preparing their new Statement of Licensing Policy the Board will complete an Equality and Human Rights Impact Assessment.

# (5) Mainstreaming and Equality Policy Progress Report-

The Aberdeen City Licensing Board must report on the progress in making equalities integral to their activities. The Licensing Board does this in conjunction with Aberdeen City Council. The City Council approved and subsequently published their latest Equality Outcomes and Mainstreaming Report in April 2017. However as outlined above the new Licensing Board had not been appointed at this time and therefore the report is now brought before the Board. It is intended that Aberdeen City Licensing Board will continue to work jointly with Aberdeen City Council in progressing Equalities over the next four years.

#### (6) Licensing Board Equality Outcomes 2017 – 2021

The Aberdeen City Licensing Board must set new Equality Outcomes for the next four year period. The aim is to build on the work already done by the Board and promote a fairer more inclusive Aberdeen where everyone can feel part of the City and ensure that equalities are always an important consideration in everything the Board do.

The Boards Equality Policy has been updated and new Equality Outcomes are proposed for the next four years (Appendix 1).

#### (5) Consultation

Once the Aberdeen City Licensing Board approve their Equality Outcomes and Mainstreaming Report they will consult the Local Licensing Forum at their joint meeting on 31 August 2017 and thereafter the policy will require to be published on the City Councils website from 1 September.

# **Equality Outcomes and Mainstreaming Report 2017-2021**

# Introduction - The Legal Requirement

Equality outcomes are strategic and are what the Local Authority and Licensing Board, often in partnership, will try to achieve to improve local people's lives. In "Equality Outcomes and the Public Sector Equality Duty: A Guide for Public Authorities in Scotland" 2016, the Equality and Human Rights Commission (EHRC) has provided a guide on preparing and publishing equality outcomes. It states that outcomes should be relevant and realistic. Aberdeen City Licensing Board set their equality outcomes for the period 2013-2017 with a review of progress on these outcomes in 2015.

A key legal requirement under the Equality Act 2010 is for local authorities to publicise and deliver equality outcomes. An equality outcome must further one or more of the aims of the public sector general equality duty:

- Eliminate unlawful discrimination, harassment and victimisation and other conduct that is prohibited by the Equality Act 2010;
- Advance equality of opportunity between people who share a relevant protected characteristic and those who do not;
- Foster good relations between people who share a protected characteristic and those who do not.

The public sector equality duty covers all of the protected characteristics, which are: Age, Disability, Gender Reassignment, Marriage and Civil Partnership, Pregnancy and Maternity, Race, Religion and Belief, Sex, Sexual Orientation.

Many of the specific equality duties require information to be reported upon and published on a reporting cycle of either two or four years. As part of the specific duty to report on mainstreaming the equality duty, the Licensing Board is required to publish a report on the progress it has made to make the general equality duty integral to the exercise of its functions, so as to better perform that duty. These should be published at intervals of not more than two years apart.

These reports must include (if not published previously); an annual breakdown of the information the Licensing Board has gathered under its duty and details of the progress that it has made in using that information to enable the Licensing Board to better perform the general equality duty.

The Licensing Board must publish a fresh set of equality outcomes within four years of publishing its previous set. In preparing a set of equality outcomes, the Licensing Board must take reasonable steps to involve people who share a relevant protected characteristic and anyone who appears to the Licensing Board to represent the interests on those people.

The Licensing Board must also consider relevant evidence relating to people who share a relevant protected characteristic. If a Licensing Boards set of outcomes does not further the needs of the general equality duty in relation to every relevant protected characteristic, it must publish the reasons for this.

# The Aberdeen City Licensing Board

Aberdeen City Licensing Board is a relevant public body under the 2010 Act. Therefore Aberdeen City Licensing Board is required to prepare and monitor the progress towards achieving Equality Outcomes in terms of Regulation 4 of the Equality Act 2010 (Specific Duties)(Scotland) Regulations 2012. The Board published their Equality outcomes in April 2013. In April 2015 the Board published a report, in accordance with its legal duties, on the progress towards achieving those outcomes.

In terms of the required reporting cycle the Board requires to publish a further report on its Equality outcomes in 2017.

In terms of the Licensing (Scotland) Act 2005, Section 5, there is to be a Licensing Board for the area of each Council under Section 46(1) of the Local Government (Scotland) 1994. The members of the Licensing Board are to be elected by the relevant Council from among their members. The Licensing Board although comprised of Councillors is a separate legal body from the Council. The Council must, at its first meeting after each ordinary election of the Council, hold an election of members to the Licensing Board for their area.

The Scottish Council Elections were held on 4 May 2017. Therefore the new Aberdeen City Council elected a new Aberdeen City Licensing Board at the first Council meeting on 16 May 2017.

It is therefore proposed that this new Aberdeen City Licensing Board, should review, consider and approve the required Equality Outcomes.

The new Aberdeen City Licensing Board will also publish their new Statement of Licensing Policy by November 2018 which will include a statement as to their duties under the Equality Act 2010 as well as their Equality Outcomes.

# Mainstreaming Equality by Aberdeen City Licensing Board

The Licensing Board has taken steps to ensure the mainstreaming of the general equality duty as an integral part of the exercise of its functions. The Board's statutory Statement of Licensing Policy sets out the policies that assist in the exercise of its functions under the Licensing (Scotland) Act 2005. During the formulation of this document an Equalities and Human Rights Impact Assessment was carried out. The Board considered the EHRIA and the licensing policy document before its introduction in November 2010.

Prior to the Specific Scottish Equalities Duties coming into force the Board made the general equality duty part of its procedures by following best practice to use impact assessments in the exercise of its functions. In a report in June 2011 the Board also emphasised its commitment to ensure it had due regard to the general equality duty during the intervening period between the expiry of the earlier equality (disability, gender, and race) duties and the introduction of the specific duties.

The Board's current Statement of Licensing Policy was published in November 2013 and was considered by the Board with a full Equalities and Human Rights Impact Assessment before implementation. Equality impact assessment has been made integral to the development and consideration of the Board's policies and reports. The practical functions of the Board, for example accessibility of publications and meetings, will be monitored and promoted through actions linked to the equality outcomes.

1. <u>Various actions have been taken in the interim, i.e. 30 April 2015 to 30 April 2017, to ensure that the Board makes the equality duty integral to the exercise of its functions so as to better perform that duty.</u>

The Licensing Board's equality outcomes have assisted the Board Members in mainstreaming equality issues. For example, it is noted that the Board's communication now more fully adheres to (Aberdeen City Council) Corporate Accessible guidelines. This is to assist persons with difficult reading, and those with visual impairment. The Board's meetings have been moved to rooms which are accessible to wheelchair users and persons with restricted mobility as there is a lift located close to the entrance to the building, which itself has wheelchair accessibility outside. These rooms also have a hearing loop facility for persons with hearing impairment who use hearing aid devices.

Officers have also agree to place mainstreaming of the equality duty as an item on the agenda of Licensing Board meetings, and have led and facilitated discussion of the Public Sector Equality Duty amongst the Board Members. They have explained its relevance to Licensing Board practice and how it should be made integral to all Licensing Board processes.

Similarly, at team meetings with the relevant officers who dealing with Licensing Board matters mainstreaming of the Public Sector Equality duty has also been explained and discussed, to ensure that all relevant officers are aware of the responsibility and are enacting mainstreaming in practice. Through the introduction of the Equalities and Human Rights Monitoring Questionnaires with all Licensing Board applications, and its availability online, the Board's officers have started to gather helpful equalities monitoring information, which assists them to make progress on mainstreaming the duty. They have noted

however that the number of forms which have been returned have been limited and do not fully reflect the diversity of applicants to the Licensing Board. Officers will now require to further publicise and encourage the completion of these forms. Officers will then use the information from these forms with the existing data from applications to understand better the profile of licence holders and applicants in relation to the protected characteristics. This should also help provide relevant data that can be used to positively mainstream the duty by making appropriate amendments to Board procedure, and improve accessibility to underrepresented groups.

It is the intention to place mainstreaming equality duty agenda items on Licensing Board meetings, Licensing Board officers' team meetings, and on the annual meeting between the Board and the Local Licensing Forum. This is with the aim of maintaining and improving awareness of how to make the Public Sector Equality Duty integral to the Board's practice.

The Licensing Board's officers have all been made aware that if there are persons who cannot access Licensing Board services in the same manner as persons without a protected characteristic then they must seek to adapt practice, and facilitate such access.

The Licensing Board's Statement of Licensing Policy was reviewed and the new version was published on 30 November 2013. The new Licensing Board will publish their new Statement of Licensing Policy by November 2018 which will again include a statement as to their duties under the Equality Act 2010 as well as their Equality Outcomes.

As noted above the Board's statutory Statement of Licensing Policy sets out the policies that assist in the exercise of its functions under the Licensing (Scotland) Act 2005. During the formulation of this document an Equalities and Human Rights Impact Assessment was carried out. The Board considered the EHRIA and the licensing policy document before its introduction in November 2013. Paragraphs 2.4 – 2.6 thereof refer. It was clear from preparation of the new Statement of Licensing Policy that there was greater awareness of mainstreaming of the Public Sector Equality duty in the consciousness of officers dealing with the policy review.

The Licensing Board also maintains good practice by utilising Equality and Human Rights Impact Assessment forms (EHRIA) when considering reports.

# **Proposed New Equality Outcomes 2017-2021**

The proposed outcomes for the protected characteristics set out below take account of key issues which are still ongoing and those which have arisen since the last report in 2015.

- 1. Members of the Licensing Board and the staff of the Licensing Team to improve their understanding and awareness of equality issues in carrying out their statutory roles with Licence holders, trade organisations, partners and the communities of Aberdeen City.
  - To achieve this, Members, LSO's and staff will participate in equality and diversity training.
  - This will benefit all Protected Characteristics
  - Public Sector Equality Duty: Eliminate unlawful discrimination; Advance equality of opportunity; Foster good relations.
  - Applicable authority Aberdeen City Council, Corporate Governance and Aberdeen City Licensing Board
- 2. The Licensing Board will seek to promote equal opportunity of access for all to Licensed Premises in the City and promote good practice.
  - To achieve this The Board will raise awareness of disabled access to Licensed premises and other awareness campaigns (e.g. work with Guide Dogs for the Blind, work with Building Standards to ensure and highlight the requirements for Disabled toilet provision in licensed premises, ensure the provision of baby changing facilities in licenses premises which are accessible to all genders, Promote other equality campaigns led by the Council to the licensed trade through the Board Meetings, the Local Licensing Forum and the Licensing Board pages on the City Council Website.
  - This will benefit all Protected Characteristics but with particular focus on disability, pregnancy and maternity, and sex.
  - Public Sector Equality Duty:- Eliminate unlawful discrimination; Advance equality of opportunity; Foster good relations.
  - Applicable authority Aberdeen City Council, Corporate Governance and Aberdeen City Licensing Board

- 3. All applicants and members of the public are able to access the Licensing Boards services easily and confidently and make sure it's information is available to all.
  - Action to improve the promotion and collection of information through our Equalities Monitoring Forms and seek to identify any service concerns specific to persons with protected characteristics in order to monitor and address such concerns. In addition to promote the Councils translation services in terms of our documentation, forms, policy documents and interpretation services for assisting customers with queries and representation at meetings if required.
  - This will benefit all Protected Characteristics.
  - Public Sector Equality Duty:- Eliminate unlawful discrimination; Advance equality of opportunity; Foster good relations.
  - Applicable authority Aberdeen City Council, Corporate Governance and Aberdeen City Licensing Board
- 4. Greater participation and involvement of the public and licence holders with protected characteristics in meetings, consultations and other statutory processes of the Board.
