 - ii. which has entered into a contractual arrangement with that local authority for the supply of goods and/or services to that local authority.

- (b) agree the remit and meeting frequency of the Group as outlined in the report at section 3.10;
- (c) instruct the Head of Legal and Democratic Services to write to the private hire firms and seek nominations to represent the Private Hire trade; and
- (d) upon receipt of nominations, agree to instruct the Head of Legal and Democratic Services to then write to all Private Hire Car Licence Holders asking them to indicate their preferred representative for the Group

The Committee resolved:

to approve the recommendations.

REVIEW OF CIVIC AND MISCELLANEOUS APPLICATION FEES - CG/17/095

11. The Committee had before it a report by the Head of Legal and Democratic Services which (1) advised of the proposed level of application fees for licences administered through the Civic Government (Scotland) Act 1982 and other miscellaneous statutes; (2) sought approval for a consultation process to review such fees; and (3) informed of the proposal to create a new post of 1 FTE Licencing and Immigration Assistant as part of that fee review.

The report recommended -

that the Committee

- (a) approve for consultation the fee review options set out at section 5 of in the report and instructs the Head of Legal and Democratic Services to conduct a consultation as outlined in section 6 below on the same; and
- (b) instruct the Head of Legal and Democratic Services to submit a report to the Licensing Committee on 19 December 2017 on the outcome of the fee review proposal consultation and seeking a final decision on the future fee levels to be adopted from 20 December 2017.

The Committee resolved:

to approve the recommendations.

UPDATE ON DRIVER TRAINING AND KNOWLEDGE TEST - CG/17/094

12. With reference to articles 3 and 4 of the minute of the meeting of the Licensing Committee of 28 April 2017, the Committee had before it a report by the Head of Legal and Democratic Services which advised of the outcome of further discussion held with the Taxi Consultation Group on the training for taxi and private hire drivers and the format of the knowledge test.

The report recommended -

that the Committee

- (a) note the updates;
- (b) instruct the Head of Legal and Democratic Services to investigate possible methods of delivery of driver training and report back to Committee on 6 February 2018 with details of the options available; and
- (c) instruct the Head of Legal and Democratic Services to undertake consultation with the trade on amendments to the procedure for applying for a taxi driver's licence or private hire driver's licence involving the Knowledge Test as detailed at paragraphs 3.14 and 3.15 of the report.

The Committee resolved:

- (i) to approve the recommendations; and
- (ii) to instruct the Head of Legal and Democratic Services to investigate the possibility of incorporating along with the knowledge test an assessment of ability to use an

appropriate satellite investigation system and to fully consult the trade thereon and report back by the Licensing Committee on 6 February 2017.

FIRST AID KIT REQUIREMENTS - TAXI/PRIVATE HIRE - CG/17/093

13. The Committee had before it a report by the Head of Legal and Democratic Services which sought the views of the Committee on the required contents of the first aid kits to be carried in all taxis and private hire vehicles.

The report recommended -

that the Committee

- (a) note the background issues relating to the first aid kits specification; and
- (b) stipulate that the contents of the first aid kits must be in accordance with HSE number BS8599-2:2014 in order to comply with the licence conditions.

The Committee resolved:

- (i) to approve recommendation (a); and
- (ii) to agree that the contents of the first aid kits must be in accordance with HSE number BS8599-2:2014, with the exception of 1 Foil Blanket (Adult), 1 Resuscitation Face Shield and 1 Heavy Duty Shears, in order to comply with the licence conditions.

REPORT TO VARY LOCAL CONDITIONS FOR BOOKING OFFICE LICENCES - CG/17/088

14. The Committee had before it a report by the Head of Legal and Democratic Services which sought approval to consult on the proposed variation to the local conditions applied to Booking Office licences under Para 10 Schedule 1 of the Civic Government (Scotland) Act 1982 and the Civic Government (Scotland) Act (Licensing of Booking Offices) Order 2009.

The report recommended -

that the Committee

- (a) approve (for the purposes of issuing for consultation in recommendation C below) the proposed variation of the local condition 3 from "the licence holder shall keep written or electronic records of the name address, licence number of every driver operating from the relevant premises" to read; "The Licence Holder, in order to ensure that relevant vehicles are only driven by a licensed taxi or private hire drivers, shall keep, and undertake an ongoing review or audit of, written or electronic records of the name, address, licence number and expiry date of every driver operating from the relevant premises.";
- (b) approve (for the purposes of issuing for consultation in recommendation C below) the proposed variation of the local condition 4 from "the Licence Holder shall ensure that only relevant vehicles licences by the Licensing Authority operate from

the relevant premises" to read; "The Licence Holder, in order to ensure that only relevant vehicles, currently licensed by this local authority, operate from the relevant premises, shall keep, and undertake an ongoing review or audit of, written or electronic records of the licence holder, licence number, registration number and expiry date of any taxi and private hire car operating from the relevant premises.": and

(c) instruct the Head of Legal and Democratic Services to consult the holders of Booking Office Licences and the Chief Constable, Police Scotland, on the above proposals and in accordance with paragraph 10 of Schedule 1 of the Civic Government (Scotland) Act 1982 invite them to be heard at the next meeting of the Licensing Committee on 7 November 2017 regarding the terms of the proposals.

The Committee resolved:

to approve the recommendations.

DECLARATION OF INTEREST

In accordance with article 2 of this minute, Councillor Imrie left the meeting prior to consideration of the following item of business.

REVIEW OF STREET TRADER POLICIES - CG/17/087

15. The Committee had before it a report by the Head of Legal and Democratic Services which sought approval to review the existing street trader policies and to consult on the proposed variation to the standard conditions in relation to Street Trader Licences.

The report recommended -

that the Committee

- (a) approve the proposed amended draft schedule of conditions (Appendix 2) for issuing for consultation; and
- (b) instruct the Head of Legal and Democratic Services to consult the holders of Street Traders Licences and the Chief Constable, Police Scotland, on these proposals and in accordance with paragraph 10 of Schedule 1 of the Civic Government (Scotland) Act 1982 invite them to be heard at the next meeting of the Licensing Committee on 7 November 2017 regarding the terms of the proposals.

The Committee resolved:

- (i) to approve the proposed amended draft schedule of conditions (Appendix 2), with the addition of the following proposed variation to condition 9 to read "The stance from which a street trader hawks, sells or offers or exposes for sale their goods requires to be moved daily at the end of trading", for issuing for consultation; and
- (ii) to approve recommendation (b).

ACCESSIBLE VEHICLE POLICY UPDATE - CG/17/096

16. (A) In terms of Standing Order 13.1, the Committee received a deputation from Mr William Lees, GMB. Mr Lees was accompanied by Mr Eric Thoresen.

Mr Lees advised that he believed that a mixed fleet was unfair and caused problems. Mr Lees provided an overview of the issues he felt arose as a result of a mixed fleet policy and advised that he believed that a 100% uniformed fleet should be introduced by the Council. He felt that a uniformed fleet was good for the city and visitors to the city.

He went on to refer to the mixed fleet position in Dundee and advised that this situation was currently under legal challenge. He also referred to the position in other cities within the UK.

Thereafter, Mr Thoresen explained that he felt that a mixed fleet was unfair and did not meet the requirements of the Equality Act 2010.

Members asked questions of Mr Lees and Mr Thoresen.

(B) In terms of Standing Order 13.1, the Committee received a deputation from Mr Tommy Campbell, Unite. Mr Campbell was accompanied by Mr Peter Campbell.

Mr Tommy Campbell advised that Unite the Unions position in respect of the Council's Accessible Vehicle Policy remained the same as that presented in May 2012, namely it did not accept that a 100% accessible vehicle taxi fleet was required as in their view demand for accessible vehicles was met by the existing number of accessible taxis in Aberdeen at this time.

He explained that in his view the Committee required to focus on its duty of care to the public under the Equality Act 2010. He quoted the Act and advised that it stated at section 3(a) "persons who share a relevant protected characteristic and persons who do not share it involves having due regard, in particular, to the need to (a) remove or minimise disadvantages suffered by persons who share a relevant protected characteristic that are connected to that characteristic". On the basis of the wording, he did not agree that the only way in which the Council could meet this requirement was by having a 100% wheelchair accessible fleet.

He also referred to a survey undertaken previously by Unite wherein not a single respondent wanted a 100% wheelchair accessible fleet.

Mr Peter Campbell referred to his experience of driving both types of vehicle and advised of customer feedback he had received wherein passengers had advised they wanted a choice and did not want a 100% wheelchair accessible fleet.

He recommended that the Committee review the current policy and whether a 100% accessible vehicle taxi fleet was required.

Members asked questions of Mr Tommy Campbell and Mr Peter Campbell.

- (C) In terms of Standing Order 13.1, the Committee had agreed to hear a deputation from Mr Littlejohn, however Mr Littlejohn had been unable to attend the meeting.
- (D) With reference to article 9 of the minute of the meeting of the Licensing Committee of 13 June 2016, the Committee had before it a report by the Head of Legal and Democratic Services which presented details of the process and potential consequences of revisiting the Accessible Vehicle Policy including the legal and financial implications.

The report recommended -

that the Committee

- (a) note the process and potential consequences of revisiting the policy; and
- (b) continue with the scheduled implementation of the current policy.

The Vice Convener, seconded by Councillor Bell moved:-

that the Committee approve the recommendations contained in the report; and agree to request the Head of Legal and Democratic Services to report to the Licensing Committee if there is any implication to Aberdeen City Council wheelchair accessible vehicle policy following the Dundee Council court decision.

Councillor Flynn, seconded by Councillor Hutchison moved as an amendment:that the Committee –

- (1) note the report;
- (2) instruct the Head of Legal and Democratic Services to proceed with a full consultation on the proposal to move from the Council's current accessible vehicle policy to a new policy that would deliver a mixed fleet through either taxi licensing or taxi drivers licencing;
- (3) agree that the consultation should involve all taxi and private hire driver licence holders, the Taxi Consultation Group, the Disability Equity Partnership, Police Scotland, all Transport Consultants, Transportation Strategy and Programmes officers, Community Safety officers, Unite Aberdeen and any other relevant charities and organisations and the public;
- (4) agree that the consultation, as well as any aspects determined by the Head of Legal and Democratic Services in consultation with the Convener, would specifically request views on what would be an appropriate ratio of wheelchair accessible vehicles to saloon vehicles to ensure a reasonable availability of both to any member of the public who might either require, or prefer, one type of vehicle for reasons of health or disability, and how a new

- system could be implemented and continued in a way that was both fair and naturally just to taxi license holders;
- (5) instruct the Head of Legal and Democratic Services to report back to a future meeting of the Licensing Committee in 2018 with the results of the consultation, and the legal and financial implications of a mixed fleet policy, at which time the Committee would determine whether a new mixed fleet policy should be drafted; and
- (6) agree that the date of implementation of the current wheelchair accessible vehicle policy be moved to 6 June 2019, pending the outcome of the consultation.

On a division, there voted:- <u>for the motion</u> (5) – the Vice Convener; and Councillors Bell, Imrie, Avril MacKenzie and Wheeler; <u>for the amendment</u> (11) – Councillors Allard, Delaney, Flynn, Graham, Hutchison, Catriona Mackenzie, Malik, Nicoll, Sellar, Sandy Stuart and Townson; and <u>declined to vote</u> (1) – the Convener.

The Committee resolved:

to adopt the amendment.

I refer to the above HMO licence application, which is on the agenda of the Licensing Committee at its meeting on 7 November 2017 for the reason that one written representation was received by the HMO Unit.

I can advise you as follows:

The HMO legislation

This application is being dealt with under the provisions of Part 5 of the Housing (Scotland) Act 2006, as amended. Available grounds of refusal are as follows:

- 1) The applicant and/or agent is not considered to be a 'fit & proper' person to hold an HMO licence, and
- 2) The property is unsuitable for occupation as an HMO for one, some or all of the following reasons:
- i) Its location
- ii) Its condition
- iii) Any amenities it contains
- iv) The type & number of persons likely to occupy it
- v) Whether any rooms within it have been subdivided
- vi) Whether any rooms within it have been adapted, resulting in an alteration to the water & drainage pipes within it
- vii) The safety & security of persons likely to occupy it
- viii) The possibility of undue public nuisance
- ix) There is, or would be, an overprovision of HMOs in the locality (see Other Considerations)

The premises:

The property at No.53 Bannermill Place, Aberdeen, is an upper floor maisonette flat providing accommodation of 5 letting bedrooms, one public room, one kitchen & 4 bathrooms (2 en-suite). The plan attached as Appendix 'A' shows the position of the premises.

Previous HMO Licence:

The Licensing Committee, at its meeting on 23 August 2016, resolved to grant the owner of No.53 Bannermill Place, an HMO licence for a restricted one-year period subject to the usual licence conditions plus one additional condition concerning the appointment of a managing agent. The wording of the additional licensing condition on the HMO licence certificate was:

"The licence-holder must appoint a professional managing agent to provide a fully factored service for the duration of the licence."

The licence-holder duly appointed the firm of James & George Collie, Solicitors, to manage his HMO property, and this firm continues to manage the property.

The current HMO licence application:

The HMO licence application is dated 2 August 2017, and was received by the HMO Unit on 2 August 2017.

Certificate of Compliance – Notice of HMO Application:

The Certificate of Compliance submitted by the agent declares that the public Notice of HMO Application was on display outside the property for the statutory 21-day period between 2 August 2017 – 23 August 2017.

Letter of representation:

One written representation was received by the HMO Unit within the abovementioned 21-day statutory period, and must therefore be considered by the Committee. The letter of representation is attached as Appendix 'B', and attention is drawn to the final paragraph wherein the respondent states;

"I do not wish to object this time around as long as Collie, or another responsible agent, is employed by Mr Lamb."

HMO Licensing Conditions:

Only the Licensing Committee holds the power to include additional licencing conditions, and discussions were held with the respondent and the licence-applicant's agent regarding a resolution which was acceptable to both parties. In this regard, both parties were asked to agree upon the inclusion of the same additional licensing condition as attached to the one-year HMO licence, ie.

"The licence-holder must appoint a professional managing agent to provide a fully factored service for the duration of the licence."

Both parties agreed to the additional licensing condition, and on this basis they were advised that their attendance at the Committee meeting was not required.

Other Considerations:

- Police Scotland has been consulted in respect of the applicants' suitability as 'fit & proper' persons, and has made no comment or objection.
- The Scottish Fire & Rescue Service has been consulted in respect of the suitability of the premises as an HMO, and has made no comment or objection.
- The Council's Anti-Social Behaviour Investigation Team (ASBIT) has no record of any complaint of anti-social behaviour at No.53 Bannermill Place, during the recent one-year duration of the HMO licence.

- The applicant, agent and property are currently registered with Landlord Registration.
- The applicants have requested an occupancy of 5 tenants, which is acceptable to the HMO Unit in terms of space and layout.
- The application under consideration is a renewal application.


Conclusion:

I refer to the notice of application, dated 04 August 2017 and note that Collie are named as agents.

As I have objected in the past I feel I should comment on the current application.

There has been a marked improvement in the management of this property since Collie took over the role of agent. For the record, there have been no further escapes of water and the level of noise is significantly less.

There have been fewer occupants (which is one of the reasons the noise levels have been much lower) and their behaviour has generally been responsible.

For the record, I had to contact Collie twice about noise from late night parties when the new tenants first moved in but since then there have been no further noise issues. Like the majority of tenants at Bannermill the occupants of 53 Bannermill occasionally park in spaces that do not belong to them, which is irritating, but not something I would consider grounds to object to the renewal of the HMO licence.

In summary I do not wish to object this time around as long as Collie, or another responsible agent, is employed by Mr Lamb. I also trust that Collie will be able to maintain the current standards.

Director Stephane de Freitas' documentary follows a group of college students taking part in an annual oratory competition in the suburbs of Paris. The French have always had a way with words, which is why the annual college *concours Eloquentia*, or eloquence competitions, have such an important place. But not everyone is a born orator, nor are they necessarily given the tools to express themselves — especially if they come from a family where French isn't even the first language. The film looks at a group of mixed race students who are involved in the contest for the first time. Most of them have never spoken in public, but by the time the film is over, they have acquired skills in fluency and presentation. 1. PURPOSE OF REPORT:-

1.1 To request that the Licensing Committee consider the views of the holders of Booking Office licences and the Chief Constable, who have been invited to attend the 7th November Licensing Committee meeting and be heard, on the variation of the standard local conditions in relation to Booking Office Licences.

2. RECOMMENDATION(S)

2.1 That the Committee:-

(a) notes that all holders of Booking Office Licences and the Chief Constable, Police Scotland, have, in accordance with Paragraph 10 of Schedule 1 of the Civic Government (Scotland) Act 1982, been notified of the proposed variation of conditions, as agreed by the Committee at their meeting on 12 September 2017 and noted below, and have been invited to attend and be heard at this meeting of the Committee:-

The proposed variation of the local condition 3 from "the licence holder shall keep written or electronic records of the name address, licence number of every driver operating from the relevant premises" to read;

"The Licence Holder, in order to ensure that relevant vehicles are only driven by a licensed taxi or private hire drivers, shall keep, and undertake an ongoing review or audit of, written or electronic records of the name, address, licence number and expiry date of every driver operating from the relevant premises."

The proposed variation of the local condition 4 from "the Licence Holder shall ensure that only relevant vehicles licences by the Licensing Authority operate from the relevant premises" to read;

"The Licence Holder, in order to ensure that only relevant vehicles, currently licensed by this local authority, operate from the relevant premises, shall keep, and undertake an ongoing review or audit of, written or electronic records of the licence holder, licence number, registration number and expiry date of any taxi and private hire car operating from the relevant premises"; and

- (b) considers the views of the holders of Booking Office licences and the Chief Constable, Police Scotland on the proposed variation of the local conditions above and (Appendix 1); and
- (c) thereafter approves the proposed amended draft schedule of conditions (Appendix 1); and
- (d) instructs the Head of Legal and Democratic Services to give written notice of the Committees decision to the holders of Booking Office Licences and The Chief Constable, Police Scotland on the variation of the local conditions in accordance with paragraph 10 of Schedule 1 of the Civic Government (Scotland) Act 1982.

3. BACKGROUND/MAIN ISSUES

- 3.1 Officers recently received two separate complaints regarding two taxi drivers and their behaviour, when checks were conducted both of their licences had expired. On investigation, Enforcement officers found both operators were working through the same Booking Office. When Officers contacted the licensed Booking Office it transpired that there were no checks in place other than when the licence was granted.
- 3.2 All Booking Offices licensed by this Authority were then contacted and asked to submit lists of vehicles and drivers that they were using to fulfil bookings. On checking these lists both Enforcement Officers and Police Scotland worked together and found 14 operators and 7 drivers operating through Booking Offices who had expired licences. A meeting was then called with Aberdeen City Council, Police Scotland and Booking Office licence holders to discuss a way forward and to answer any questions. All those that were found to be operating without a licence were charged by Police Scotland.
- 3.3 Aberdeen City Council records showed that the licenses had lapsed but no follow up was in place to check if the licenses were still being used. This was in addition to no real time checks by the licensed booking offices. Varying the local conditions will ensure that Booking Office Licence Holders will be obliged to carry out an ongoing review of all drivers and taxi and private hire cars and their licences and update their records frequently.

- 3.4 Therefore in order amend local conditions 3 and 4, and therefore vary the terms and standard schedule of conditions for holders of Booking Office licences (Appendix 1), the Licensing Committee would have to notify licence holders and the Chief Constable of this proposed variation and invite them to the next appropriate meeting of the Committee. In terms of paragraph 10 of Schedule 1 of the Civic Government (Scotland) Act a licensing authority may at any time vary the terms of a licence, e.g. the conditions, on any grounds they think fit. The authority have to notify the licence holder and the Chief Constable of the proposed variation to be considered, giving them not less than 7 days notice; and give each of the persons notified an opportunity to be heard by the authority, at a specified meeting of the Licensing Committee to which they will be invited. Consultees may submit their responses in writing prior to the Committee meeting and if available these will be included with the report, or if too late will be presented to the Committee at their meeting. However the Act specifies that consultees should be invited to attend a specified meeting of the Committee and be given an opportunity there to be heard and express their views on the proposed variation. Therefore consultees views/responses may not be known until the Committee meeting commences.
- 3.6 Licence holders would have the right to appeal any decision to vary their licence conditions within 28 days, from the date of the decision. Therefore any amended schedule of conditions would not come into effect until 28 days from the date of that decision, or if an appeal is lodged, it would only come into effect if the appeal was abandoned or determined in favour of the licensing authority.
- 3.7 The Licensing Committee at its meeting on 12 September 2017 agreed to consult on the proposed variation of the licence conditions as outlined above (and Appendix 1) and in accordance with the procedure in paragraph 10 of schedule 1 of the Civic Government (Scotland) Act 1982 invite the relevant parties to attend and be heard at the Committees meeting on 7 November 2017.
- 3.8 A copy of the amended draft schedule of conditions, which has been issued for consultation, is attached to the report (Appendix 1).

4. FINANCIAL IMPLICATIONS

- 4.1 The approval of the recommendations require :-
 - all Licence holders and the Chief Constable, Police Scotland to be written too notifying them of the decision of the Licensing Committee
 - copies of the new schedule of conditions to be produced and issued to all Booking Office licence holders, approximately 11.

There will therefore be a financial cost to the Licensing Team, Legal and Democratic Services in producing and issuing the above documentation. This expenditure will be contained within existing budgets.

5. LEGAL IMPLICATIONS

5.1 The recommendations will ensure that the legislation is complied with and that all taxis and private hire cars and their drivers operating from licensed Booking Offices are appropriately licensed.

6.7 Varying the conditions attached to the Booking Office Licence will ensure that the taxi and private hire service in Aberdeen is licensed properly, therefore enhancing Aberdeen's reputation as providing a professional and law abiding service.

7. IMPACT SECTION

7.1 There will be no impact on the economy arising from the recommendations.

- 7.2 The proposals to vary and amend the schedule of conditions applicable to Booking Office licences have a neutral impact on groups with protected characteristics and an impact assessment is therefore not required.

CIVIC GOVERNMENT (SCOTLAND) ACT 1982 CONDITIONS APPLICABLE TO BOOKING OFFICE LICENCE MANDATORY CONDITIONS

- 1. A record must be kept of every booking for the hire of a relevant vehicle taken at the relevant premises.
- 2. A record must be kept of -
- (i) the registration number of the vehicle which was hired as the result of a booking taken at the relevant premises; and
- (ii) the name of its driver at the time of that hire.
- 3. The holder of a licence shall take all reasonable steps to ensure that any booking taken at the relevant premises from a member of the public for the hire of a relevant vehicle results in the hire of a vehicle which is –
- (i) a relevant vehicle; and
- (ii) being driven by a person who holds a licence granted under section 13 of the Act and that licence is in effect.

LOCAL CONDITIONS

The Licensing Authority shall mean Aberdeen City Council

- 1. The Licence Holder shall keep a record of the following –
- (a) the date and time of every hire;
- (b) the location of the hire pick up point; and
- (c) the destination of that hire.
- 2. Where the Licence Holder changes its address as specified in the application form, it shall notify the Licensing Authority in writing of said change within fourteen days of that change.
- 3. The Licence Holder, in order to ensure that relevant vehicles are only driven by a licensed taxi or private hire drivers, shall keep, and undertake an ongoing review or audit of, written or electronic records of the name, address, licence number and expiry date of every driver operating from the relevant premises."
- 4. The Licence Holder, in order to ensure that only relevant vehicles, currently licensed by this local authority, operate from the relevant premises, shall keep, and undertake an ongoing review or audit of, written or electronic records of the licence holder, licence number, registration number and expiry date of any taxi and private hire car operating from the relevant premises.
- 5. If the Licence Holder is convicted of any offence, it shall, within twenty-eight days of said conviction, provide the Licensing Authority with full written details of that conviction.
- 6. The Licence Holder shall not ask any driver to do anything which would result in him/her committing a breach of the conditions of his/her licence.

- 7. The Licence Holder shall make all records covered by these conditions available for inspection at any time to the Licensing Authority upon reasonable request by the Licensing Authority.
- 8. All records must be kept for a period of no less than three years and said record keeping shall be acceptable in electronic format.

1. PURPOSE OF REPORT:-

1.1 To request that the Licensing Committee consider the views of the holders of street trader licences, the Chief Constable and relevant consultees, who have been invited to attend the Licensing Committee meeting on 7th November, on the review of the policies and variation of the standard conditions in relation to Street Trader Licences.

2. RECOMMENDATION(S)

2.1 That the Committee:-

- (a) notes that all holders of Street Traders Licences, the Chief Constable, Police Scotland, and relevant consultees have, in accordance with Paragraph 10 of Schedule 1 of the Civic Government (Scotland) Act 1982, been notified of the proposed review and variation of conditions, as agreed by the Committee at their meeting on 12 September 2017, and been invited to attend and be heard at this meeting of the Committee;
- (b) considers the views of the holders of street traders licences, the Chief Constable, Police Scotland, and other relevant consultees on the proposed review and variation of conditions (Appendices 3 to 8);
- (c) thereafter approves the proposed amended draft schedule of conditions (Appendix 2); and
- (d) instructs the Head of Legal and Democratic Services to give written notice of the Committees decision to the holders of Street Traders Licences, The Chief Constable, Police Scotland, and other relevant consultees on the review and variation of conditions in accordance with paragraph 10 of Schedule 1 of the Civic Government (Scotland) Act 1982.

3. BACKGROUND/MAIN ISSUES

3.1 Section 39 of the Civic Government (Scotland) Act 1982 provides that a street trader's licence is required for street trading by a person, whether on his own account or as an employee. This means that a licence is required for persons who are both employers and employees.

Street trading is defined as hawking, selling or offering or exposing for sale any article, or offering to carry out, or carrying out for money or money's worth any service in a public place. It includes doing any of these things from a vehicle, a kiosk or a moveable stall not entered in the valuation roll.

For any activity which involves the sale of food, a street trader must have a Food Safety Certificate of Compliance issued by the Environmental Health service of the Council. Certificates of Compliance now last for a period of 3 years and a Certificate from any Local Authority in Scotland is valid in any other area of Scotland.

- 3.2 The Licensing Committee at its meetings on 17 November 2010 and 23 March 2011 reviewed and updated the practices and procedures in relation to street traders licences. In particular this involved revoking the previous condition 10 which prohibited a street trader from engaging in street trading within 100 metres of any other licence holder or establishment or premises in which are sold or offered for sale any goods or articles or services of the same or similar class and description as those to be offered for sale by him, when operating out with a recognised market, and they also added a new condition 21 which prohibited street traders from engaging in hawking, selling or offering for sale any type of food and/or drinks within a 400 metre radius of the outer boundary of a school at any time. A copy of the updated schedule of conditions as agreed in 2011 is attached to this report (Appendix 1).
- 3.3. In relation to the aforementioned new condition 21 (Appendix 1), the Licensing Committee added this to the schedule of standard conditions, in 2011, for the holders of street traders licences because they had received complaints about street traders selling food near schools and there were both health and safety concerns about children leaving school to purchase items from these vans. They also considered that the Council had an obligation to discourage unhealthy eating in children.
- 3.4 A number of licensing authorities including Aberdeen City and North Lanarkshire have had a condition, similar to condition 21 above (Appendix 1), prohibiting street trading in the proximity of schools. In 2015 a number of licensed street traders in North Lanarkshire appealed against that Councils decision to vary their licences to impose a condition prohibiting them from operating within a distance of 250 metres of the perimeter of all secondary schools in the North Lanarkshire Area from 8.00am to 5.00pm on any school day during term time. The prohibition applied to snack vans selling or offering for sale hot or cold food, fish and chip vans and ice cream vans. On 27 November 2015 the Sheriff reversed the Councils decision to impose this

condition. The sheriff's decision was reported in 2016 in the case of McCluskey v North Lanarkshire Council. The Sheriff held that the condition was ultra vires and the quality of food that consumers bought was covered by legislation to be found elsewhere and had Parliament intended to provide for the protection of consumers by means of conditions under the licensing system, that would have been set out in the Civic Government (Scotland) Act 1982 with regard to street traders and attempts to insert conditions might have effects for the customer which were entirely arbitrary. The court stated that child obesity was not a licensing purpose and neither was the promotion of school meals nor a ban on trading for the majority of the calendar year. The Court said that Parliament could not have intended local licensing authorities to have the implied power to attach a condition with such a significant effect on the commercial contracts of street traders, regardless of the aim of the condition.

- 3.5 The scope of condition 21, in the current schedule of conditions (Appendix 1), is even wider than the North Lanarkshire Condition, in that condition 21 prohibits the sale of any type of food or drink within the 400 metre radius of a school at any time, not just during school hours or term time. North Lanarkshire shared the same motives for adding this condition, namely tackling childhood obesity and promoting healthy eating. Therefore given the very clear similarities between the two conditions and the Sheriff's decision in the case against the North Lanarkshire condition it is advised that condition 21 is ultra vires and should be revoked.
- 3.6 In terms of paragraph 10 of Schedule 1 of the Civic Government (Scotland) Act a licensing authority may at any time vary the terms of a licence, e.g. the conditions, on any grounds they think fit. In order to vary a licence the authority have to notify the licence holder and the Chief Constable of the proposed variation to be considered, giving them not less than 7 days notice; and give each of the persons notified an opportunity to be heard by the authority, at a specified meeting of the Licensing Committee to which they will be invited. Consultees may submit their responses in writing prior to the Committee meeting and if available these will be included with the report, or if too late will be presented to the Committee at their meeting. However the Act specifies that consultees should be invited to attend a specified meeting of the Committee and be given an opportunity there to be heard and express their views on the proposed variation. Therefore consultees views/responses may not be known until the Committee meeting commences.
- 3.7 Therefore in order to revoke condition 21, and therefore vary the terms and standard schedule of conditions for holders of street traders licences (Appendix 1), the Licensing Committee would have to notify licence holders and the Chief Constable of this proposed variation and invite them to the next appropriate meeting of the Committee in order to hear any representations or consider any written responses. Other relevant consultees have also been consulted regarding this report and have been invited to attend, for example the Council's Roads Service, Education and Children's Services, Communities Housing and Infrastructure and the Environmental Health Service.

- 3.8 Licence holders would have the right to appeal any decision to vary their licence conditions within 28 days, from the date of the decision. Therefore any amended schedule of conditions would not come into effect until 28 days from the date of that decision, or if an appeal is lodged, it would only come into effect if the appeal was abandoned or determined in favour of the licensing authority.
- 3.9 Condition 2 currently makes reference to Aberdeen City Council's Employment of Children Byelaws (made 18 October 2001) which provide that a child aged 14 years or over may engage in street trading in certain circumstances, otherwise the holder of a street trader's licence shall not be less than sixteen years of age. These byelaws have been updated and therefore the schedule of conditions requires to be updated to reflect this and now state, "Aberdeen City Council's Employment of Children Byelaws (made 14 April 2016)". (Appendix 2)
- 3.10 The Air Weapons and Licensing (Scotland) Act 2015 amended the Civic Government (Scotland) Act 1982. This included, in section 78, giving licensing authorities the additional sanction of revoking a licence. Therefore it is proposed that the wording of condition 7b) requires to be amended to reflect this change and include the additional words "revoked or varied" after the word "suspended" where this already appears. (Appendix 2)
- 3.11 Conditions 11 and 14 in the current schedule of conditions (Appendix 1) both deal with the issue of litter which may result from the licence holders activity as a street trader in a public place. As the decision in the aforementioned McCluskey v North Lanarkshire Council case shows conditions must be for a licensing purpose only. Therefore these conditions regarding litter should only relate to litter which has accumulated as a result of the street trading in question and should not put a more onerous obligation on the licence holder to remove litter generally which may have accumulated as the result of other businesses. It is therefore proposed that the wording of condition 14 be amended to reflect this. It is further proposed that as conditions 11 and 14 both relate to litter it would be more appropriate if these were together in the schedule of conditions, and therefore the amended condition, formerly number 14, would now become condition 12 (Appendix 2).
- 3.12 It is proposed a new condition 21 be added in association with the existing condition 22 (Appendix 2). Both of these relate to the statutory duty of a licence holder to advise the licensing authority of any material change in circumstances affecting them, for example a change of address or being convicted of an offence. Although a licence holder is obliged in terms of paragraph 9 of schedule 1 to the Civic Government (Scotland) Act 1982 to provide this information, practically they often don't. By adding a requirement to advise of any change of name or address as a condition would seek to highlight and reinforce this duty to the licence holders and would assist in terms of administration and enforcement.

- 3.13 The Licensing Committee at its meeting on 12 September 2017 agreed to consult on the proposed variation of the licence conditions as outlined above (and Appendix 2) and in accordance with the procedure in paragraph 10 of schedule 1 of the Civic Government (Scotland) Act 1982 invite the relevant parties to attend and be heard at the Committee's meeting on 7 November 2017.
- 3.14 In addition the Committee on 12 September 2017 also agreed that they wished to consult holders of street traders licences, the Chief Constable and relevant consultees including the Council's Roads Service on the proposed variation to the current condition 9 of the Schedule of Conditions (Appendix 1) to read instead:-

"The stance from which a street trader hawks, sells or offers or exposes for sale their goods requires to be moved daily at the end of trading" (Appendix 2)

- 3.15 The current condition 9 of the Schedule of conditions (Appendix 1) already states that the stance from which the licence holder trades "shall be of a form that can be removed within a reasonable timeframe if so required upon reasonable request by a relevant person". Therefore the variation, as proposed, to move the stance at the end of each trading day would have significant implications for licence holders and the Roads Service of the Council. Therefore the Roads Service will also be included in this consultation and be invited to attend the Committee meeting on 7 November 2017. An initial consultation with the Roads service has already taken place and a copy of their written response is attached to this report (Appendix 3)
- 3.13 A copy of the new proposed schedule of conditions which includes the amendments detailed above (which are highlighted in bold), and which has been issued for consultation, is attached to this report (Appendix 2).

4. FINANCIAL IMPLICATIONS

- 4.1 The approval of the recommendations would require :-
 - all Licence holders and the Chief Constable, Police Scotland to be written to and advised of the decision to vary the schedule of conditions, approximately 150 letters
 - copies of the new schedule of conditions to be produced and issued to all street trader licence holders, approximately 150.

There will therefore be a financial cost to the Licensing Team, Legal and Democratic Services in producing and issuing the above documentation. This expenditure will be contained within existing budgets.

5. LEGAL IMPLICATIONS

5.1 If Condition 21 of the standard schedule of conditions for street traders licences (Appendix 1) is not revoked, it is highly likely, as a result of the decision in the McCluskey v North Lanarkshire case, that should the Council as licensing authority be legally challenged, either by appeal to the sheriff in respect of an application for a new grant of a licence or judicial review in respect of existing licence holders, any challenge would be successful as the condition is invalid.

In relation to the proposed variation to condition 9, requiring traders to move their stance at the end of each trading day, it should be noted that licensed traders require to pay a fee and enter into an agreement and also obtain a permit from the Roads Service of the Council. The Roads Service check and approve the location of stances before issuing these permits and agreements and are consulted on street trader applications by the Licensing Team. If a trader was required then to move at the end of each trading day, and as there are no parking restrictions in the areas approved for such traders, the trader may not be able to return to his approved stance the next day potentially causing loss of business or then moving to another site which has not been assessed and approved. Given that the Council has approved and entered into agreements with licensed traders for these stances and required payment of a fee for their use, the variation of this condition may breach this agreement and result in legal action against the council.

6. MANAGEMENT OF RISK

Financial

There may be financial implications arising from the recommendations of this report in relation to the proposed changes to condition 9 if agreed. We have already initially consulted the Councils Road's Service on the proposed change to this condition and they advise that to ask traders to leave their stance each day and return to their stance the following day could involve issuing TTRO's for each site which would involve a lot of work and expense for that service in relation to pitches that occupy high demand sections of carriageways within industrial areas.

Street traders require to enter an agreement and to pay the Roads Service of the Council a fee in relation to their site. By being asked to move they may not be able to return to their site the next day, as it had been taken by someone else, which may result in loss of business. This could potentially lead to claims against the council in respect of such losses as the traders had already paid a fee for permission to trade from that site. This may also result in the loss of site fees.

Employee

There is no risk to employees arising from the recommendations of this report

Customer/Citizen

- The variation of condition 9, requiring licensed traders to move from their stance at the end of each trading day, may result in them not being able to return to their stance which has been assessed and approved by the Council. Licensed traders may then move to stances which have not been assessed and approved potentially leading to the following risks:-
 - in terms of Road Safety, causing a danger for citizens visiting the stance and other road users
 - to citizens at home/in residential areas from stances having to be relocated each night, leading to an impact on parking and amenity
 - to licensed traders through loss of business from not being able to potentially return to their approved site on the next trading day

Environmental

The variation of condition 9, requiring licensed traders to move from their stance at the end of each trading day, may result in them not being able to return to their stance which has been assessed and approved by the Council. Licensed traders may then move to stances which have not been assessed and approved and their operation from there may have implications for the environment.

Technological

There is no risk to technology arising from the recommendations of this report.

Legal

6.6 Implications as per paragraph 5.1.

Reputational

- As decision in the case of McCluskey v North Lanarkshire was made on 27 November 2015, the Council as Licensing Authority, require to take the actions recommended now to ensure their standard conditions now comply with current case law. Further delay could result in a similar legal challenge to the North Lanarkshire case and as a result reputational damage to the Council.
- As the Council requires licensed traders into enter agreements with the Roads Service, pay a fee and obtain a permit for their approved

stance, to then amend condition 9 and require them to leave that stance each night and possibly not be able to return to it the next day, could be a breach of that agreement and lead to legal action against the Council for the breach and any resultant loss of earnings. Such breach of these agreements and any legal proceedings could result in reputational damage to the Council.

7. IMPACT SECTION

Economy

7.1 There will be no impact on the economy arising from the recommendations.

People

- 7.2 The proposals to vary and amend the schedule of conditions applicable to a street traders licence have a neutral impact on groups with protected characteristics and an impact assessment is therefore not required.
- 7.3 Therefore in order to revoke amend and vary the terms and standard schedule of conditions for holders of street traders licences (Appendix 1), the Licensing Committee would have to notify licence holders and the Chief Constable of this proposed variation (Appendix 2) and invite them to the next appropriate meeting of the Committee in order to hear any representations or consider any written responses. Relevant Consultees will also be included in the process. Due to the proposed variation to condition 9 the Roads Service of the Council has also been consulted.

CIVIC GOVERNMENT (SCOTLAND) ACT 1982

CONDITIONS APPLICABLE TO A STREET TRADER'S LICENCE

1. DEFINITIONS:

- a) "Head of Legal and Democratic Services" means Head of Legal and Democratic Services and/or his/her authorised representative;
- b) "Corporate Director" means the Corporate Director, Corporate Governance, Aberdeen City Council or his/her authorised representative;
- c) "the Council" means Aberdeen City Council and/or an authorised officer of that Council;
- d) "the licence holder" means the person named in the licence;
- e) "Licensing Authority" means the Licensing Committee of Aberdeen City Council;
- f) "relevant person" means a police officer or authorised officer of the Council;
- g) "stance" means any vehicle, kiosk or moveable stall not entered in the valuation roll to which the licence relates; and
- h) "street trading" shall have the same meaning ascribed to it by subsection 39(2) of the Civic Government (Scotland) Act 1982.

CONDITIONS

- 2. Subject to paragraph 16 of Aberdeen City Council's Employment of Children Byelaws (made 18 October 2001) which provide that a child aged fourteen (14) years or over may engage in street trading in certain circumstances, the holder of a street trader's licence shall not be less than sixteen (16) years of age.
- 3. A licence holder shall at all times, whilst engaged in the work of street trading, have with them the licence and identity badge issued to them by the Council. Upon reasonable request by a relevant person, the licence holder shall produce their licence and/or identity badge to that relevant person.
- 4. The licence holder shall display both licence and identity badge on the stance and/or on the licence holder's outer person in a place that shall be both visible and conveniently read by members of the public.

- The licence holder shall not at any time lend to or allow any other person to use their licence, and/or identity badge.
- 6. The licence holder shall not in any way alter, erase or deface their licence and/or identity badge. Where said licence/identity badge becomes illegible for any reason, the licence holder shall apply to the Council as soon as is reasonably practicable for a replacement.
- 7. The licence holder's identity badge shall remain the property of the Council at all times. Within seven days of the occurrence of any of the following, the licence holder shall return said identity badge to the Licensing Authority:
 - a) If the licence holder ceases to act for any reason for the unexpired period of their licence:
 - b) the licence is suspended by the Council;
 - c) the licence expires and no application for renewal of said licence is made; or
 - d) any other reason upon reasonable request by the Licensing Authority.
- 8. The stance from which a licence holder trades shall be positioned in a place whereby no danger shall or be likely to arise to any member of the public at any time.
- 9. The stance from which a street trader hawks, sells or offers or exposes for sale their goods shall be of a form that can be removed within a reasonable timeframe if so required upon reasonable request by a relevant person.
- 10. The licence holder shall trade only from the stance specified in the licence.
- 11. The licence holder shall provide a bin or other suitable receptacle for the deposit of litter. Said bin/receptacle shall be placed within a reasonable distance from the stance in a place that is easily accessible by members of the public.
- 12. The licence holder shall carry out their street trading activity in a public place in a manner that does not at any time cause any type of obstruction, nuisance or annoyance to any member of the public or affect their safety in any way.
- 13. The licence holder shall operate only on the days and hours of operation as specified in the licence. On the terminal hour of trading, where it is reasonable and practical to do so, the stance shall be dismantled and removed by the licence holder.
- 14. The licence holder shall, if so required during trading hours and upon the terminal hour each day, ensure the collection and removal of any litter found in a public place within a fifteen (15) metre radius of their stance.

- 15. The licence holder shall comply with any reasonable instruction given by a relevant person in relation to his/her street trading activity.
- 16. The licence holder shall exercise their trade only within the area(s) specified in their licence.
- 17. The licence holder shall not commence their street trading activity until all necessary consents have been applied for and obtained from the Council and/or any other relevant body.
- 18. Where applicable, the licence holder shall comply at all times with the provisions of the Code of Practice on Noises from Ice-Cream Van Chimes etc, 1982, issued under Section 71 of the Control of Pollution Act 1974.
- 19. Where a licence is granted in respect of food in terms of section 39(4) of the Act, then, prior to subsequent renewal of that licence, the licence holder shall ensure that the stance to which the licence relates is inspected by an authorised person(s) from the Council's Environmental Services. Any recommendation(s)/direction(s) made subsequent to that inspection shall be implemented by the licence holder within the specified time frame.
- 20. Where applicable, a licence holder shall ensure that any STT (Street Trader) number allocated to their stance by the Council's Environmental Services is painted on said stance in a position that can be conveniently and easily read by members of the public and shall be no less than five (5) centimetres both in height and breadth.
- 21. Subject to the explicit consent in writing from the Licensing Authority, no street trader shall engage in the hawking, selling or offering or exposing for sale any type of food and/or drinks within a four hundred (400) metre radius of the outer boundary of a secondary school at any time. Without prejudice to any statutory rights that the licence holder may have, the Council shall be the ultimate arbiter in determining what may constitute the outer boundary of a school for this purpose.
- 22. If, throughout the duration of the licence, a licence holder is convicted of any offence, they shall, within fourteen days of said conviction, notify the Licensing Authority in writing of that conviction.

CONDITIONS APPLICABLE TO A STREET TRADER'S LICENCE

(Proposed amendments to the conditions highlighted in bold below)

1. DEFINITIONS:

- a) "Head of Legal and Democratic Services" means Head of Legal and Democratic Services and/or his/her authorised representative;
- b) "Corporate Director" means the Corporate Director, Corporate Governance, Aberdeen City Council or his/her authorised representative;
- c) "the Council" means Aberdeen City Council and/or an authorised officer of that Council;
- d) "the licence holder" means the person named in the licence;
- e) "Licensing Authority" means the Licensing Committee of Aberdeen City Council;
- f) "relevant person" means a police officer or authorised officer of the Council;
- g) "stance" means any vehicle, kiosk or moveable stall not entered in the valuation roll to which the licence relates; and
- h) "street trading" shall have the same meaning ascribed to it by subsection 39(2) of the Civic Government (Scotland) Act 1982.

CONDITIONS

- 2. Subject to paragraph 16 of Aberdeen City Council's Employment of Children Byelaws (made 14 April 2016) which provide that a child aged fourteen (14) years or over may engage in street trading in certain circumstances, the holder of a street trader's licence shall not be less than sixteen (16) years of age.
- 3. A licence holder shall at all times, whilst engaged in the work of street trading, have with them the licence and identity badge issued to them by the Council. Upon reasonable request by a relevant person, the licence holder shall produce their licence and/or identity badge to that relevant person.
- 4. The licence holder shall display both licence and identity badge on the stance and/or on the licence holder's outer person in a place that shall be both visible and conveniently read by members of the public.

- The licence holder shall not at any time lend to or allow any other person to use their licence, and/or identity badge.
- 6. The licence holder shall not in any way alter, erase or deface their licence and/or identity badge. Where said licence/identity badge becomes illegible for any reason, the licence holder shall apply to the Council as soon as is reasonably practicable for a replacement.
- 7. The licence holder's identity badge shall remain the property of the Council at all times. Within seven days of the occurrence of any of the following, the licence holder shall return said identity badge to the Licensing Authority:
 - a) If the licence holder ceases to act for any reason for the unexpired period of their licence:
 - b) the licence is suspended, revoked or varied by the Council;
 - c) the licence expires and no application for renewal of said licence is made; or
 - d) any other reason upon reasonable request by the Licensing Authority.
- 8. The stance from which a licence holder trades shall be positioned in a place whereby no danger shall or be likely to arise to any member of the public at any time.
- 9. The stance from which a street trader hawks, sells or offers or exposes for sale their goods requires to be moved daily at the end of trading
- 10. The licence holder shall trade only from the stance specified in the licence.
- 11. The licence holder shall provide a bin or other suitable receptacle for the deposit of litter. Said bin/receptacle shall be placed within a reasonable distance from the stance in a place that is easily accessible by members of the public.
- 12. The licence holder shall, as so required during trading hours and upon the terminal hour each day, collect and remove any paper, garbage or other refuse which may be produced, or may accumulate in the course of trading and shall not place or deposit same, allow same to be placed or deposited or to fall on any street, foot pavement or footway or adjoining property.
- 13. The licence holder shall operate only on the days and hours of operation as specified in the licence. On the terminal hour of trading, where it is reasonable and practical to do so, the stance shall be dismantled and removed by the licence holder.
- 14. The licence holder shall carry out their street trading activity in a public place in a manner that does not at any time cause any type of obstruction, nuisance or annoyance to any member of the public or affect their safety in any way.

- 15. The licence holder shall comply with any reasonable instruction given by a relevant person in relation to his/her street trading activity.
- 16. The licence holder shall exercise their trade only within the area(s) specified in their licence.
- 17. The licence holder shall not commence their street trading activity until all necessary consents have been applied for and obtained from the Council and/or any other relevant body.
- 18. Where applicable, the licence holder shall comply at all times with the provisions of the Code of Practice on **Noise** from Ice-Cream Van Chimes etc, 1982, issued under Section 71 of the Control of Pollution Act 1974.
- 19. Where a licence is granted in respect of food in terms of section 39(4) of the Act, then, prior to subsequent renewal of that licence, the licence holder shall ensure that the stance to which the licence relates is inspected by an authorised person(s) from the Council's Environmental Health Service. Any recommendation(s)/direction(s) made subsequent to that inspection shall be implemented by the licence holder within the specified time frame.
- 20. Where applicable, a licence holder shall ensure that any STT (Street Trader) number allocated to their stance by the Council's **Environmental Health Service** is painted on said stance in a position that can be conveniently and easily read by members of the public and shall be no less than five (5) centimetres both in height and breadth.
- 21. (previous condition 21 to be revoked) New Condition:A licence holder who changes his name or address shall, within fourteen days of
 the said change, notify the Licensing Authority in writing and shall produce to
 them his/her licence who shall endorse thereon the particulars of such change(s).
- 22. If, throughout the duration of the licence, a licence holder is convicted of any offence, they shall, within fourteen days of said conviction, notify the Licensing Authority in writing of that conviction.

Street Traders Licence Conditions - Removing Traders from Stances

With reference to the Licensing Committee's meeting on the 12 September 2017 and the associated proposal that the current condition 9 be reviewed, I would comment as follows.

It would be unreasonable and impractical to request that street traders remove their occupations at the end of each trading day, merely to re-establish their pitch prior to trading on the following day. Each pitch is assessed and approved by the Traffic Management Section of Aberdeen City Council to ensure that there are no safety issues in terms of location, visibility and accessibility. There is the potential that if a trader is required to vacate their pitch, it may be unavailable subsequently if other vehicles park within the pre-approved footprint. This may lead to traders setting up as close to their existing pitch as possible, potentially in locations that are unsuitable, or unsafe.

The only way to ensure that the pitch could be retained for the use of the trader would be to formally designate the section of carriageway as 'restricted parking' (similar to Blue Badge spaces). This however would have a significant cost implication to the trader.

The introduction of any restriction(s) would require a Traffic Regulation Order (TRO) to be processed, along with associated road markings and signage. Currently, TRO's cost £2000 each, and can take up to nine months to approve. Temporary Traffic Regulation Orders (TTRO's) can be introduced in the interim period, but these would still incur a cost of £1650.00. Signage and road markings required to make the restrictions enforceable would merely add to the overall cost.

There would also be issue with the enforcement of the pitches. As the majority of these pitches are located within Industrial Estates, with limited or no restrictions on the carriageway, any rogue parking encountered by the City Warden Service which prevented the trader from establishing their pitch, would only serve to impact on the

revenue as generated by the affected trader(s)' as there would be a time delay in removing the offending vehicle(s).

Cond. 11 + 14, I ensure I remove all litter from/around my designated area, and do not oppose any amendment.



Ref: Wok on the Road, Howemoss Drive, Dyce.

With regards to your communication of 13th October 2017 regarding proposals to vary the standard conditions for street trader licenses, I find that I must object strongly to the proposed amendment to Condition 9, namely 'The stance from which a street trader hawks, sells or offers or exposes for sale their goods requires to be moved daily at the end of trading'. This is entirely impractical for me for the following reasons:-

- 1) It would require a suitable towing vehicle to be available, which I don't have
- 2) The trailer would require an overnight storage area, which I don't have
- 3) It would take considerable time to move and set up at the start of the day and then disassemble at the end of the day
- 4) My pitch would be unlikely to be left available in the mornings due to parked cars and even if available, would require a considerable length of clear kerb space to be able to tow the trailer into position (i.e. towing vehicle + trailer + clearance).
- 5) I work on my own but would need assistance to move and set up the trailer

Furthermore, the congestion caused by all of Aberdeen's street traders moving their vans/trailers each morning and evening, during rush hours, would severely affect the flow of traffic on Aberdeen's roads.

If this condition were to be enforced I would find my position untenable and my livelihood severely threatened.

I sincerely hope that you can find your way to revoke this condition
