I refer to the above application for the variation of a premises licence under terms of Section 29(5) of the Licensing (Scotland) Act 2005.

The variation requested consists of the following requests, namely;

- Amend the core onsales hours from Sunday between 1230 to 0000 hours and Monday to Wednesday between 1100 to 2300 hours to between 1100 to 0000 hours Sunday to Wednesday;
- 2. Amend the wording within the seasonal variation to include any additional hours afforded to them by the licensing board;
- Amend Question 5 to include the provision of restaurant facilities and outdoor drinking;
- 4. Amend the times in which Children and Young Persons are permitted access from between 1100 to 2000 hours to until 2100 or when consuming meal until the end of that meal.

In terms of Section 29(5) of the Act this request can be considered a variation.

In respect of points 1 and 2, I have adverse comment to make.

In terms of Section 22(1)(b)(ii) and (iii) of the same Act, I make the following representation.

In respect of point 3, the outdoor area to be licensed is already bounded by high fencing, however, due to nearby residential properties, I recommend that the outdoor area is subject to a terminal hour of 2200 hours.

In respect of point 4, it is recommended that the wording within the operating plan is amended to reflect that after 2000 hours, Children and Young Persons are only permitted for the purposes of consuming a meal (whilst accompanied) and are not permitted after 2200 hours.

In terms of Section 22 (1) (b) (ii) I make the following representation to the Licensing Board.

If this variation is granted I would like to make the following recommendations:

- The external area is restricted to a terminal hour of 22.00, there is clear delineation and that no amplified music is played within the area.
- With regard to the children and young persons access, to include the external area as an access area and to extend the terminal hour to 22.00 on the basis that the child or young person is accompanied by a responsible adult aged 18 or over when consuming a meal.
  - The wording "or when consuming a meal until the end of that meal" should be removed as in theory this could extend the child or young persons access to an open-ended terminal hour.
- Within the submitted operating plan the activity for Restaurant is marked "No "in column 1, this should be amended to "Yes"
- As the layout plan is being amended to show as a licensed area, the layout plan should be submitted, and the application form should be amended to show that there is an amendment to the layout plan.
- If the inclusion of an external area is granted, this will affect the capacity also, which should be amended on the submitted operating plan.
- It may also be advisable to include the reference to an external area within the description for the premises. This would enable an accurate description of the premises with associated licensed area.

Dear Sir/Madam

Thank you for your email and attached letter advising of the application for major variation to the licensing hours and facilities by the owners of the Langdykes pub in Cove Bay, Aberdeen.

I have consulted with my Cove and Altens Community Councillor colleagues and have received the following feedback for consideration by the Licensing Board.

- Based on previous incidents, there are concerns about unruly behaviour inside and in the vicinity of the pub as this may increase with longer drinking times. Extending the hours at night may increase the potential for such incidents and behaviour. The police have had cause to monitor this over a period of time.
- The request to extend the opening times may also be detrimental to quality of life for residents living close to the pub due to increased noise and safety risks.
- The need for extending the licence to midnight is not conducive to a quiet residential area and does not fit into the city centre night time activity/economy
- Concerns have also been raised regarding the use of the outside area in particular until midnight
- There should be a clear deadline /time that children need to leave the premises in the evening (which also includes outdoor areas). This request is currently open to ad hoc interpretation which would lead to confusion.

I trust the above concerns will be considered and look forward to the outcome of the application.

### HOURS OF TRADING – GENERAL & EXTENDED General

20.8 Premises in the City that provide significant entertainment (to the satisfaction of

the Board) may apply and be granted hours until 02.00 Sunday – Thursday and 03.00 on Fridays and Saturdays .The Board regards significant entertainment to be entertainment which is of such a nature to be the principal attraction for patrons to attend the premises and where alcohol is served to patrons only as an ancillary accompaniment to their attendance and /or participation in the entertainment provided. The Board considers in these cases that the entertainment is the principal reason for patrons attending the licensed premises and that the consumption of alcohol would therefore be ancillary to such entertainment.in order to be consistent with the licensing objectives. This would apply to premises such as nightclubs (with dance floor areas/facilities included in their operating plan and detailed in their layout plan) where recorded or live music for dancing is provided. Other examples of where significant entertainment may apply are discos, DJs,

adult entertainment, and live music for concerts, cabaret and theatrical plays. Some examples where the Board does not consider there to be significant entertainment are pool, darts, dominoes, leisure facilities and background music. The Board are entitled to distinguish between premises of different descriptions offering different facilities or activities. e.g. Section 27(9) of the 2005 Act allows the Board to impose conditions in relation to the sale of alcohol on a premises to which a licence relates or any other activity carried on in such premises. In light of the evidence before the Board on the levels of alcohol consumption in the city and the levels of alcohol related crime the Board wish to promote in terms of the objectives the types of premises which can operate where the service and sale of alcohol is not the primary objective thus contributing to the positive night time economy in the City but not adding to the health or crime related harms associated with are premises which focus wholly or mainly on alcohol consumption.

I refer to the above application for the variation of a premises licence under terms of Section 29(5) of the Licensing (Scotland) Act 2005.

The variation requested consists of the following:

- 1. Amending the layout plan to include a bar area within the existing basement of the premises which will be accessed from within the ground floor of the premises and directly from Union Street. This will include increasing amending the capacity of the premises;
- 2. Amending core licensed hours in respect of both floors of the premises;
- 3. Amending Children and Young Persons access.

In terms of Section 29(5) of the Act this request can be considered a variation.

Following discussion with a representative of the applicant company, it is understood that the ground floor part of the premises will operate as a restaurant and the basement floor as a themed bar.

In terms of Section 22(1)(b)(ii) and (iii) of the same Act, I make the following representation.

In relation to point 1, I have no adverse comment to make.

In relation to point 2, I have no adverse comment to make in relation to the hours sought in respect of the ground floor part of the premises.

The applicant seeks core licensed hours for the basement floor as follows: 1900 - 0100 hours on Monday to Wednesday inclusive; 1900 - 0200 hours on Thursday and Sunday; 1900 - 0300 hours on Friday and Saturday and a commencement of core hours at 1300 hours for any private function.

I recommend that the hours sought after 0000 on Sunday to Thursday inclusive and after 0100 on Friday and Saturday are only granted if the Board is satisfied that the premises are offering 'significant entertainment' as defined within Appendix 4 of Aberdeen City Licensing Board's Statement of Licensing Policy 2013 - 2016.

Additionally, it would appear that the premises are not premises to which Section 3 of the Licensing Conditions (Late Opening Premises) (Scotland) Regulations 2007 will apply.

In support of the Preventing Crime and Disorder and Securing Public Safety licensing objectives, I therefore recommend the Licensing Board considers imposing the conditions contained within 6.5.1 and 6.5.3 of Aberdeen City Licensing Board's Statement of Licensing Policy 2013 - 2016 in respect of the basement part of the premises at any time it trades after 0100 hours.

In relation to point 3, I recommend that variation in its current form should be modified to reflect that in respect of the basement part of the premises, children (albeit accompanied by an adult and present only for a private function) will not be permitted access after 0100 hours.

This representation is submitted for your attention when considering this application.

Licensing (Scotland) Act 2005 – Application for a Variation of Premises Licence VOVEM (Formerly The Filling Station), 254 Union Street, Aberdeen, AB10 1TN

I refer to the above application and in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005, I make the following representation under the licensing objective:

### **Protecting and Improving Public Health.**

The applicant seeks to make a number of variations to the Operating Plan. The variation that is of concern to NHS Grampian is:

- to amend the on sales terminal hour in the basement bar
  - Monday Wednesday to 01:00;
  - o Thursday & Sunday to 02:00 and
  - Friday & Sunday to 03:00.

According to the Statement of Licensing Policy, Appendix 4, this is in keeping with the acceptable hours of trading for premises providing **significant entertainment**.

The Aberdeen City Licensing Board Statement of Licensing Policy, 2013-2016 states at Section 20.7, paragraph 4:

"Premises in the City that provide significant entertainment (to the satisfaction of the Board) may apply and be granted later hours." "The Board regards significant entertainment to be entertainment which is of such a nature to be the principal attraction for patrons to attend the premises and where alcohol is served to patrons only as an ancillary accompaniment to their attendance and/or participation in the entertainment

provided. The Board considers in these cases that the entertainment is the principal reason for patrons attending the licensed premises and that the consumption of alcohol would therefore be ancillary to such entertainment."

If entertainment at its lowest level is the action of a premises receiving people and providing drinks (and or food) and an enjoyable atmosphere I would anticipate that significant entertainment, at the top end of the scale would be providing an event, activity or performance specifically designed to entertain people.

I understand from the agent that the basement bar will possibly be themed as a "prohibition"/1920s type premises with jazz, informal and recorded music provided. It is not anticipated that this will be live bands and entertainment may not be available every evening. The entertainment on offer at these premises would appear to be low key.

The Licensing Board will decide whether this application meets their view of significant entertainment.

From a health point of view individuals will make their own judgements as to the risks they are willing to accept from alcohol, how much and how often to drink. We are of the view that in pursuing the public health objective of licensing, premises should take reasonable measures to ensure that people are enabled to drink in a low risk way. The 2016 Chief Medical Officer (CMO) guidance suggests that this can be achieved by limiting the amount of alcohol drunk on a single occasion, drinking with food and spacing out drinks.

I have a concern that these premises will attract customer from surrounding bars at closing time e.g. after 01:00 who wish to extend their drinking time until 03:00. From talking to the agent it is clear that there will be no curfew on admission to the premises. I also understand that there are plans to provide a food offering in the basement bar.

#### I wish to request that:

- a condition is added to the license which makes the provision of food (not crisps, nuts or bar snacks) in the basement bar compulsory during late opening periods
- that the premises develop and implement a managing intoxication policy and commit to providing a duty of care for vulnerable or intoxicated customers
- that the premises develop a policy for admission to the premises (this may overlap with the above)

Scotland has the highest rates of alcohol related hospital admissions of the four UK home nations. Recently published data on Alcohol Related Deaths for Aberdeen suggest an upward trend in the numbers of people dying as a result of alcohol<sup>1</sup>.

Although alcohol related hospital stays appear to be on a decreasing trend there is evidence of an increasing trend in alcoholic liver disease stays. This figure is currently over double the rate recorded in 1997/98<sup>2</sup>.
