
### Introduction

The following report outlines the findings from a customer research interviewing program carried out between Monday 26<sup>th</sup> March and Tuesday 10<sup>th</sup> April at Cocket Hat Filling Station, North Anderson Drive Aberdeen, AB15 5DB. The research explored the buying behaviours of persons' resident in the locality of the site. Customers were asked to provide information on; their place of residence in relation to the premises, their means of travel to the premises and their purchasing behaviour in relation to fuel and groceries.

This summary page contains the results from the key objective of the research as outlined below.

### Key Research Objective

[Section 123(5) seeks to determine, as interpreted in the Opinion of the Inner House of the Court of Session in BP Oil UK Limited v City of Glasgow Licensing Board and City of Edinburgh Licensing Board (5<sup>th</sup> April 2011) whether a recognisable number of persons in the locality see and treat the said premises as the principal source from which they, in ordinary course, purchase groceries or fuel and who would properly consider themselves materially disadvantaged or inconvenienced were these retail facilities to no longer be provided from said premises.



### **Conclusion**

The results show that a statistically significant\* proportion of persons (61% (+/-7.4%) in the locality) see and treat this service station on North Anderson Drive as the principal source from which they, in ordinary course, purchase groceries or fuel and would properly consider themselves materially disadvantaged or inconvenienced were these retail facilities to no longer be provided from said premises.

\* Statistically significant - In statistics, a result is called **statistically significant** if it is unlikely to have occurred by chance. The likelihood that a result or relationship is caused by something other than mere random chance.

# Research Methodology Cocket Hat Filling Station

A quantitative research study was carried out at Cocket Hat Filling Station, North Anderson Drive Aberdeen, AB15 5DB between Monday 26th March and Tuesday 10th April 2018 with 726 customers (or 'participants'), all of whom were selected as they were exiting the store. Fieldwork was stratified to cover the core hours of off-sale of alcohol on the premises 10am until 10pm.

The structured questionnaire (please see Appendix 2 for full questionnaire) was executed via Computer Assisted Personal Interviewing (CAPI) with the use of an iPad. The screen was shared with participants so that they could view all images and questions. All participants were asked to give their full postcode in order to help map travel time and distance to location.

#### Sample Size

All intercepts (interviews) were conducted as participants were exiting via the main front entrance/exit; participants were selected at random to ensure sampling confidence. Upon completion of each survey, interviewers were under strict instruction to approach the second customer that passed them. By completing 726 interviews with current service station users we can be sure that the data and attitudes collected will be statistically representative of the customer base. Importantly this large number of 'base' participants allowed for statistical comparison of sub-groups. An important sub-group within this research that will form the 'population of interest' are participants who live within the locality of the premises AND use the garage as their principal source for purchasing Fuel or Groceries [Base - 172]. This figure represents 24% of the entire customer population.


#### Population of Interest

This sub-group of 172 participants will be used to answer the key objective of the research. Whether a recognisable number of persons in the locality see and treat the said premises as the principal source from which they, in ordinary course, purchase groceries or fuel and who would properly consider themselves materially disadvantaged or inconvenienced were these retail facilities to no longer be provided from said premises.





Figure 2 - Base - 726




Figure 3 - Base 255




Figure 4 - Base 255

### Respondent travel habits





Figure 5 – Base 255

#### Figure 6 - Base 255




Figure 7 - Base Varied

### Defining the population of interest

Participants, who live within the locality (within 1.5 miles) of the service station [Base 255], were asked how they currently use the Service Station - Figure 6.

They were then asked if, in the ordinary course of their purchasing habits, they treated this Service Station as their principal source of Petrol/DERV or Groceries - Figure 7.





Figure 8 - Base 255

172 (67.5%) local customers (participants) answered 'yes' to treating the service station as their principal source of either groceries or fuel. This forms the population of interest as outlined in the introduction - Figure 8.

Once the population of interest had been defined (Base 172), these participants were asked: Would you consider yourself materially disadvantaged or inconvenienced were this premises to be unable to provide you with: a) Petrol or DERV (Fuel)? b) Groceries?



The results show that a statistically significant proportion of persons in the locality (61%) see and treat the premises as the principal source from which they, in ordinary course, purchase groceries or fuel and that they would properly consider themselves materially disadvantaged or inconvenienced were any of these retail facilities to no longer be provided from said premises.

### **Bases explained**

Fuel: Overall 172 participants from the locality stated that they used the station as their principal source of fuel, of these participants 61% (105) stated that they would be materially disadvantaged if the premises could no longer provide them with fuel.

Groceries: We did not speak with any customers who used the station as a principle source of groceries **Either:** The combined base and response for fuel and groceries.

In order to qualify the result all participants who coded yes to being materially disadvantaged if the service station could no longer provide fuel were asked 'Would you have an alternative fuel source you could use?' Base 105

Yes – 69.5% (73) No –30.5% (32)

Those who answered 'Yes' to having an alternative fuel source – 69.5% (73) were then asked: Is this alternative fuel source available to you without causing you to be disadvantaged or inconvenienced in any way? Base 73

Yes – 8.2% (6) No – 91.8% (67)

Results show that the alternative fuel sources available to 69.5% of participants would cause 91.8% of this group to be inconvenienced.

94.2% (99) of those materially disadvantaged (base 105) confirmed this was still the case after considering alternatives.

The graph below highlights participants who live locally and use the garage as their principal source of either fuel or groceries and who, after considering local alternatives, still feel they would be materially disadvantaged or inconvenienced if the premises could no longer provide them with either.





Figure 10, Base 105


The geo-map below shows where all participants (99) who coded 'yes' live; on average 0.83 miles from the station.

Section 123(5) seeks to determine, as interpreted in the Opinion of the Inner House of the Court of Session in *BP Oil UK Limited v City of Glasgow Licensing Board and City of Edinburgh Licensing Board (5<sup>th</sup> April 2011)* whether a recognisable number of persons in the **locality**<sup>1</sup> see and treat the said premises as the **principal source**<sup>2</sup> from which they, in **ordinary course**<sup>3</sup>, purchase **groceries**<sup>4</sup> or fuel and who would properly consider themselves **materially disadvantaged** or **inconvenienced**<sup>5</sup> were these retail facilities to no longer be provided from said premises.

Should the research prove that a substantial % of a **representative sample**<sup>6</sup> local residents who use the outlet as their principal source of groceries and would be materially disadvantaged or inconvenienced if the outlet stopped selling groceries then it would help to form a case to include the outlet as being 'not excluded' from the changing legislation.

<sup>1</sup> **Locality** will be defined on a premises by premises basis. This will be determined via respondent answering what will be Q1 (How far away from this station do you live?) and will be confirmed with geo-mapping postcode software. Those living within the chosen distance will be deemed suitable to represent persons living in the locality and they will be further questioned on purchasing habits. This will provide the research with its population of interest.

- <sup>5</sup> Materially disadvantaged or inconvenienced; the term materially disadvantaged is perhaps not in the general diction of the average respondent, and we would not expect it to be used by a respondent if asked to describe how they felt about a retail outlet closing. However, when it is combined with the word inconvenienced in the Q. "Would you consider yourself materially disadvantaged or inconvenienced were this premises to be unable to provide you with a) petrol (DERV) b) Groceries?") we would expect a good understanding. An open question asking why participants would feel materially disadvantaged or inconvenienced will be asked if 'yes' is coded at either a)petrol (DERV) or b) groceries.
- <sup>6</sup> **Representative sample;** in quantitative market research studies which are to be conclusive it is very important that the data collected and the findings and recommendations made from the data are representative of the given population. #### LICENSING OBJECTIVE - PROTECTING CHILDREN FROM HARM

- 28.1 The Board wishes to see child safe premises thriving in the city. It welcomes applications from those who wish to operate licensed premises which accommodate children and families. In determining any such application the risk of harm to children will be paramount.
- 28.2 Where applicants wish to operate such premises, the Board expects them to appreciate that this places additional responsibilities upon them at the same time as recognising that parents and other adults accompanying children also have responsibilities.
- 28.4 The following examples of control measures are given to assist applicants.
  - effective and responsible premises management
  - adoption of best practice guidance
  - imitations on the hours when children may be present, in all or parts of the premises

  - acceptance of accredited proof of age cards with photographs, or passports

- 19.1 The Board recognises a growing trend for outside seating areas in licensed premises. The Act allows the consumption of alcohol off the premises in these areas. However Aberdeen City Council has a byelaw prohibiting the consumption of alcohol in designated public places. This is part of the overall strategy to make safe all the public areas within the city. The text of the byelaw is available at Appendix 1 and on Aberdeen City Council website at: www.aberdeencity.gov.uk/licensing
- 19.2 The Board will expect any licence holder who intends to provide outside seating, tables, or other outside facilities to hold a licence which includes the outside area and to have the necessary planning permission. Where the premises do not currently include such an outside area the Board will expect licence holders to vary the licence. Applicants, who propose to provide outdoor areas, should ensure that their use will not cause disturbance or nuisance to the occupiers of other premises in the vicinity. The Board may impose where necessary local conditions such as the provision of CCTV camera(s) to assist in the management and control of such areas and in support of the licensing objectives. These areas should be shown on the layout plan.
- 19.3 Aberdeen City Council operates a scheme whereby a permit may be applied for to occupy the footway with tables and chairs. This scheme is operated under the Roads (Scotland) Act 1984. The Board expects that licence holders will not only comply with any conditions attached to such a permit but will also put into place effective management controls, supervision and other measures to ensure that the use of such areas by patrons or by any other persons does not have a negative impact in the vicinity.

It is our recommendation that the operating plan in its current form at Q5 is amended to state that the outdoor drinking area has a terminal hour of 2200 hours.



#### Dear Sir/Madam

I wish to object to the application from Dizzy's, 70 Carden Place, Aberdeen for a variation (major) of its licence. This variation is in relation to a roof terrace/balcony bar on the rear first floor of the above premises.

I believe my property at , Aberdeen may be the nearest residential property to Dizzy's. Since this additional facility was introduced earlier in June, there has been a significant degree of noise nuisance emanating from Dizzy's. This increase in noise has been exceptionally disruptive......bad language is common, noise of broken glass, music, shouting and laughing and the general sounds of people under the influence of alcohol.

The roof terrace/balcony bar is very spacious and accommodates a large number of tables and chairs and therefore a lot of people. This area is used regularly, week days as well as weekends, and customers can be there until very late at night and on occasion after midnight. One just has to look at the official Facebook page of Dizzy's to see how busy it is.

The main bedroom in my property is to the rear and as such is very close to the roof terrace/balcony bar at Dizzy's. I believe one is entitled to peace and quiet in one's home and to be able to retire to sleep with the window open and not have to close it to try to diminish noise intrusion. When customers are using the roof terrace/balcony bar there is no point in trying to sleep until beyond midnight.

In addition, there has been at least one barbecue held on the roof terrace/balcony bar where the food has been prepared and cooked there. The noise and smells were, again, intolerable.

This roof terrace/balcony bar opened in June and it has been a nuisance and disruptive to quality of life ever since. Can I point out that I have owned my property for 17 years, have lived in harmony with Dizzy's all that time and never had any cause to complain until now.

It is my understanding that there is a desire within the city and Aberdeen City Council for more of the properties in the Carden Place/ Queen's Cross area to be returned to residential use. I respectfully suggest that will not happen if licensed premises are allowed to create such areas, with the associated noise and nuisance. I believe this area of the city is already well served by licensed premises and there is no need for further capacity, especially of this type.

Rain is now welcomed in the hope it will deter people from using the roof terrace/balcony bar.

I urge you to consider these points and the impact this roof terrace/balcony bar is having when you decide on the application from Dizzy's.

Twice I have contacted Dizzy's to discuss this with the owner or manager. Both times my details were taken and I was told I would be contacted.....no one has been in touch.

Of course, the ones that were contacted were either vacant buildings, businesses that have a connection to the development or offices open Monday to Friday 9am – 5pm and will not be troubled with the late night open-air operating hours and therefore would not complain. "... the hereby approved roof terrace shall only be permitted for use between the 18.00hrs and 23.00hrs Monday to Friday, and 12.00hrs and 23.00hrs on Saturdays and Sundays"

Anyway, my concerns are, although it seems that this proposal has been rubber-stamped already, the noise.

What is the regulation about playing live amplified music outside?

Playing live music loudly inside with the doors open?

Open air cooking - BBQ's?

People congregating in the car park at closing time.

I have tried to contact the Aberdeen Council Antisocial Behaviour Investigation Team for clarification but have just reached an answering machine.

I am also apprehensive that proper controls and ongoing monitoring does not take place and it slowly expands covertly into a covered, brightly lit, heated area serving drinks to patrons from an upstairs bar.

I have lived in this street for at least 20 years and happily lived alongside the Restaurant/Bar without any concern until now. I too would like to appreciate the lovely summer weather we have been having without having to close all my windows to block out the sound of 'Mustang Sally' belting out for the third time!

We, Queens Cross/Harlaw Community Council wish to strongly object to a licence for the Balcony area as requested by Dizzy's.

The main concern is the noise which will likely be much worse than previously as drink will be consumed in an open area which will affect neighbours much more. I state MUCH more as the neighbours already have noticed an annoying increase in the disturbing noise coming from Dizzy's since June this year, which is presumably because Dizzy's has already been given a temporary licence for the new area. The additional noise from Dizzy's till 11 o'clock at night (the time designated as a restriction on the Planning application approval) does not seem to us a reasonable hour to try and stop noise. One neighbour in particular is already disturbed by drinking on the roof top terrace especially when a barbecue was in progress where food was being prepared there. The associated noise and smell was very unpleasant to the neighbours. Apparently this roof terrace can be very busy where often there are not enough seats and people are standing to have their drinks.

We have been told by another member of the Community Council not quite so nearby Dizzy's (and so not on the Neighbourhood list) that they were annoyed by the noise when walking along Fountainhall Road so obviously the noise can be heard some distance away.

I am trying to find out if Dizzy's has permission to have so many people on the roof terrace drinking as in my experience they have to have a licence to allow a certain number of people on a roof terrace especially when serving food and drink. I have had a response from a solicitor associated with the Licensing Dept. but unfortunately I am still not clear on this matter. Neither am I clear either on who and why the additional TEMPORARY licence was granted to Dizzy's. Certainly the Community Council was not made aware of the change in Licensing.

As well as noise neighbours have informed us that since the temporary licence was approved with an increase of the roof terrace bar activities that:-

"bad language is common, as is loud laughing and the general sounds associated with people under the influence of alcohol."

"This area is used regularly and customers can be there until midnight or even later."

"the value of my property will be reduced. It will represent a significant inhibitor to the resale of my property"

"I am also apprehensive that proper controls and ongoing monitoring does not take place"

"People congregating in the car park at closing time.

I have tried to contact the Aberdeen Council <u>Antisocial Behaviour Investigation Team for clarification but have just reached an answering machine."</u>

Regarding the car park it is noted that on the Planning approval for the number of parking spaces was queried and Dizzy's (I assume) put in a hand written list (which is difficult to read) of the number cars parked up to 9pm at night. Their numbers are much lower than the 13 cars that I saw almost filling the parking spaces at 7pm recently. However I have to accept mine was only a single check. Nevertheless the experience of residents in other areas where there have been queries over approval of an alcohol licence is the noise of car doors and indiscriminate parking late at night which is the problem. This should be checked out as a possible problem at Dizzy's where it was already noted that the number of car park spaces was low.

It is suggested that anyone considering whether Dizzy's Licence Application should be approved only needs to go to Dizzy's OWN Facebook page and look and listen to the video there of the highly amplified singer on the roof terrace and ask themselves if they would want to live anywhere near a venue making such a loud noise with people eating

and drinking. Note if the video is no longer available on Dizzy's Facebook site then an archived copy can be made available. Certainly present neighbours in the area are very unhappy at the noise.
Answers to whether there are or should be restrictions on numbers of seats and standing people being served food and drinks on the roof top terrace are still being clarified but it is suggested that decision makers take note (from the video) of the number of people standing (as there are no seats left presumably) as well as sitting on Dizzy's roof terrace.
For practical and safety reasons it would appear unwise to have that large number of people (seen in the video) assembled for drinking and eating (along with a Barbecue on occasions) on a <b>roof terrace</b> .

# **Hours of trading – General and extended**

20.3 In determining the hours of trading, the Board will give full consideration to the Scottish Government guidance under the Act and to the provisions of the Act itself. Each case will be dealt with according to its individual circumstances. The Board will deem up to a maximum of 14 hours continuous trading in any 24 hour period to be reasonable. This is in accordance with the aforementioned Government Guidance which further states that any application for licensed hours for more than 14 hours should require further consideration to the effect of granting extra operating hours.

20.8 Premises in the City that provide significant entertainment (to the satisfaction of the Board) may apply and be granted hours until 02.00 Sunday - Thursday and 03.00 on Fridays and Saturdays. The Board regards significant entertainment to be entertainment which is of such a nature to be the principal attraction for patrons to attend the premises and where alcohol is served to patrons only as an ancillary accompaniment to their attendance and /or participation in the entertainment provided. The Board considers in these cases that the entertainment is the principal reason for patrons attending the licensed premises and that the consumption of alcohol would therefore be ancillary to such entertainment.in order to be consistent with the licensing objectives. This would apply to premises such as nightclubs (with dance floor areas/facilities included in their operating plan and detailed in their layout plan) where recorded or live music for dancing is provided. Other examples of where significant entertainment may apply are discos, DJs, adult entertainment, and live music for concerts, cabaret and theatrical plays. Some examples where the Board does not consider there to be significant entertainment are pool, darts, dominoes, leisure facilities and background music. The Board are entitled to distinguish between premises of different descriptions offering different facilities or activities. e.g. Section 27(9) of the 2005 Act allows the Board to impose conditions in relation to the sale of alcohol on a premises to which a licence relates or any other activity carried on in such premises. In light of the evidence before the

Board on the levels of alcohol consumption in the city and the levels of alcohol related crime the Board wish to promote in terms of the objectives the types of premises which can operate where the service and sale of alcohol is not the primary objective thus contributing to the positive night time economy in the City but not adding to the health or crime related harms associated with are premises which focus wholly or mainly on alcohol consumption.

The variation requested consists of the following request, namely;

- Amend the core on sales hours from 1100-2300 hours on Sunday to Tuesday and from 1100-0000 hours Wednesday to Saturday to between 1000-0000 hours on Monday to Thursday, 1100-0100 hours on Friday and Saturday and between 1100-0000 hours on Sunday;
- 2. Amend the core off sales hours from 1100-2200 hours on Monday to Saturday and 1230-2200 hours on Sunday to between 1000-2200 hours Monday to Thursday, 1100-2200 hours Friday to Sunday;
- 3. Amend Q4 to remove the wording within Seasonal Variations;
- 4. Amend the wording with Q5 to state 'We can open our function room for meeting, funerals etc. without opening our bar which is a separate area';
- 5. Amend Q6 relating to the times in which Children and Young Persons are admitted from 1100 hours to 1000 hours.

In terms of Section 29(5) of the Act this request can be considered a variation.

In relation to points 2-5 I have no police objection.

In relation to point 1 relating to the core on sales hours and in terms of Section 22(1)(a) of the same Act, I make the following objection.

The application seeks to operate the bar area until a terminal hour of 0100 hours on Friday and Saturday.

The premises are situated outwith the city centre area, as defined in Appendix 3(a) of the Aberdeen City Licensing Board Statement of Licensing Policy 2013-2016 and are in the heart of a built up residential area.

The current policy states the Board will not normally grant hours beyond 0000 hours outwith the city centre. In addition, the application nor the operating plan that accompanies the application form provides any information to suggest that the premises be would entitled to extend their terminal hour.

Police Scotland also notes the operating plan that accompanied the application form at Question 5(f) removes all other activities, which also does not provide any justification for the premises seeking to extend the terminal hour on Friday and Saturday to 0100 hours.

If granted, I am of the opinion that this would set a precedent which other licensed premises outwith the 'city centre' area as defined, would be likely to seek to replicate.

Any extension to the operating hours for the applicant premises, or any other premises enjoying similar licensed hours, may exacerbate this and could result in an increase in crime and disorder and it is for this reason, in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005 and in support of the Preventing Crime and Disorder and Preventing Public Nuisance licensing objectives, that the Chief Constable objects to the grant of the variation.

This objection is submitted for your attention in considering this application.

TITLE OF REPORT Procedure for Determination of Occasional

Licence or Extended Hours Applications

#### PURPOSE OF REPORT

To establish a procedure for the determination of Occasional Licences or Extended Hours applications that require to be considered by a Sub-Committee of the Board in accordance with the Scheme of Delegation.

#### 2. RECOMMENDATION(S)

It is recommended that the Board agree on either Option ONE, Option TWO or Option THREE detailed below as the procedure for the determination of applications for Occasional Licences or Extended Hours that require to be considered by a Sub-Committee in terms of the approved Scheme of Delegation.

#### 3. BACKGROUND/MAIN ISSUES

In terms of the approved Scheme of Delegation, applications for Occasional Licences or Extended Hours which have attracted representations require to be determined by a Sub-Committee of the Board. Currently this is done on a rota basis, with 3 Board Members sitting at any one time. There have been isolated incidences where similar applications resulted in different outcomes under this system and accordingly it was suggested that alternative options be considered.

#### 4. OPTION ONE – STATUS QUO WITH LONGER ROTAS

This option would see the rota system continue as currently operated. Three Members would be placed on the rota at one time and those Members would be contacted by e-mail when an application or applications require to be determined. The application(s) would be placed in the Members Lounge for consideration along with a decision sheet for completion by the Members on the rota. The decision sheet would indicate whether or not the application(s) should be granted and the reasons for each decision.

#### Pros

- Flexibility which allows decisions to be reached in a short space of time.
- Applications can be viewed by Members when convenient to do so.

#### Cons

- Potential risk of inconsistency when the membership of the subcommittee is changing on a regular basis.
- Perceived lack of transparency and formality as no formal meeting

Should the status quo be the preferred option it is suggested that each rota should last a longer period of time to attempt to ensure that all applications for the same or similar events are dealt with by the same sub-committee. This would reduce the potential risk of inconsistency.

#### 5. OPTION TWO – INFORMAL SUB-COMMITTEE MEETINGS

This option retains the basis of option one but expands upon the concept to introduce greater scope for discussion when considering the applications. It would again involve a rota system where 3 Members would be notified when applications require to be considered. A mutually convenient date and time would then be fixed for the three Members to consider the applications together. Legal support would also be available if required but neither the applicant or consultee would be invited. The decision sheet would then be completed with the consensus of the 3 Members and the reasons for reaching that decision.

#### Pros

- Retains a degree of flexibility and efficiency.
- Allows Members on the rota scope for discussion when coming to a decision.
- Should allow greater transparency and formality and provides more robust reasons for decisions to be recorded.

#### Cons

- There would still be a risk of inconsistency although this should be lessened by the opportunity to discuss the applications thoroughly before coming to a decision.
- Potential delays if a mutually convenient date and time for all 3 Members cannot be arranged.
- Meetings would not be public so there could still be a perceived lack of transparency.

#### 6. OPTION 3 – FORMAL SUB-COMMITTEE MEETINGS

This option would be organised similarly to option 2 but would involve formal, public meetings. The applicant and any consultee who had submitted representations would be invited and a full formal hearing would be held.

#### Pros

- Complete transparency in decision making.
- Opportunity to question all relevant parties before coming to a decision.

#### Cons

- Notice periods would have to be adhered to which could risk a high number of applications being unable to be determined in time.
- Potential difficulties in finding appropriate accommodation and mutually convenient date/time for hearings.
- Increased staffing costs
- Lack of flexibility and convenience for Members and applicants.

It should be noted that the legislation specifically states that the Board does not require to hold a formal hearing in such circumstances, provided the applicant has been given the opportunity to comment upon any representation. The most likely reason for this is the fact that many such applications are time sensitive, and so to undergo the formal hearing procedure would mean applications would have to be submitted a considerable time in advance of the event to guarantee a decision being made on the application, something which is not always possible.

#### NEIGHBOURING BOARDS

As part of the exercise officers were requested to establish the procedure in neighbouring Board areas for comparison purposes. In all 3 Aberdeenshire Divisional Boards the decision is delegated to the Clerk following consultation with the Convenor and is largely carried out by email. In Moray, decisions are delegated to the Convenor and Vice-Convenor, with a third Member consulted if there is no consensus. If either the Convenor or Vice-Convenor is unavailable, then any other Board Member can substitute. Again, all correspondence is by e-mail.

#### 7. MISCELLANEOUS

In all 3 options, to reduce the risk of inconsistency it would be possible to establish a permanent membership of the Sub-Committee with the operation of substitutes in the case of unavailability.

TITLE OF REPORT GAMBLING POLICY STATEMENT

#### PURPOSE OF REPORT

To advise the Licensing Board that the three-year Statement of Policy in terms of Section 349(1) of the Gambling Act 2005 ('the Act') requires to be reviewed, revised and consulted upon.

- 2. RECOMMENDATION(S)
  - 2.1 That the Board notes the contents of the report; and
  - 2.2 Approves Appendix 1 for public consultation.

#### 3. BACKGROUND/MAIN ISSUES

3.1 Section 349 (1) of the Act requires all licensing authorities to prepare and publish every three years a statement of the principles that they propose to apply in exercising their function under the Act during the three-year period to which the policy applies.

The Licensing Authority Statement of Policy will last for a maximum of three years but can be reviewed at any time. The Board's current policy runs from January 2016 to January 2019. Members are invited to view the current policy on the Board's website at <a href="https://www.aberdeencity.gov.uk/services/business-and-licensing/licences-and-permits/gambling-act-2005">https://www.aberdeencity.gov.uk/services/business-and-licensing/licences-and-permits/gambling-act-2005</a>

The Policy requires to be reviewed, revised and published by 3 January 2019. Officers have carried out a review of the existing Policy and a draft Statement of Policy for 2019-2022 is attached ("Appendix 1").

- 3.2 Section 349 (3) of the Act requires the licensing authority to consult with the following on the Statement of Policy or any subsequent revision:
  - Chief Constable

- One or more persons who appear to the authority to represent the interests of persons carrying on gambling businesses in the authority's area
- One or more persons who appear to the authority to represent the interests of persons who are likely to be affected by the exercise of the authority's function under this Act.

The Gambling Commission's Guidance to Licensing Authorities recommends that licensing authorities may wish to consider consulting with a range of organisations including: faith groups, voluntary and community organisations working with children and young people, organisations working with people who are problem gamblers, medical practices or primary care trusts, and advocacy organisations, other tiers of local government, holders of gambling premises licences and responsible authorities named in the Act.

The Clerk to the Board will conduct a consultation with all statutory consultees and also with the consultees recommended by the Gambling Commission. The Board will allow 12 weeks for responses to the draft Statement of Policy 2019-2022. The results of the consultation will thereafter be reported back to the Board for its consideration.

TITLE OF REPORT LICENSING POLICY STATEMENT 2018

#### PURPOSE OF REPORT.

This report provides information on the procedures for the statutory triennial review of the Licensing Board's Statement of Licensing Policy and seeks approval of the draft Policy to be issued for consultation.

#### 2. RECOMMENDATION(S)

That the Licensing Board: -

- 2.1 notes the contents of this report;
- 2.2 approves the terms of the draft Statement of Policy (Appendix One);
- 2.3 allows Appendix One to be issued for consultation with interested parties until 31 October 2018;
- 2.4 agrees the locality or localities on which to consult in terms of the on-sales overprovision supplementary policy and instruct the Chief Officer of Governance to undertake the necessary consultation exercise; and
- 2.5 schedules a special meeting in the week beginning 5 November 2018 to analyse consultation responses in respect of items 2.3 and 2.4 and prepare a final draft Statement of Licensing Policy for approval at the Board Meeting on 13 November 2018.

#### 3. BACKGROUND/MAIN ISSUES

Section 6 of the Licensing (Scotland) Act 2005 ("the 2005 Act") places a duty on Licensing Boards to publish a licensing policy statement within 18 months after an ordinary election of councillors for the local government area. The current policy must be reviewed and published by 30 November 2018.

In preparing the statement, the Board must (a) ensure that the policy seeks to promote the licensing objectives, and (b) consult the Local Licensing Forum ("the Forum"), the relevant health board and such other persons as the Board thinks appropriate. It is intended to consult these parties and all other relevant parties.

Boards must have regard to any guidance issued to them by the Scottish ministers. The first guidance was published in April 2007 and has not been updated since.

As instructed by the Board the draft policy has been completely revamped in an effort to be user-friendly, concise and accessible. The Supplementary Policy on Off-Sales Overprovision and the Scheme of Delegation have already been approved by the Board, and so, although part of the document, will not be subject to the consultation exercise.

A similar consultation exercise to that carried out in respect of off-sales overprovision will be required for on-sale premises. Again, as a first step it is for the Board to identify the locality or localities in which to assess overprovision. Whilst the whole Board area was deemed appropriate in respect of off-sales it is considered that smaller areas are more apt for on-sales premises. It is suggested that Ward areas would be suitable, with the possible exception of the city centre areas which may benefit from being broken down further. Once the localities are agreed, a map indicating the location of all premises within the localities will be produced and the provision of such premises will be the subject of a consultation exercise.

It is recommended that a special meeting of the Board be convened in the week beginning 5 November 2018 to analyse the responses to both consultations and prepare the final Policy document for Approval at the scheduled Board Meeting on 13 November 2018.

The draft policy is attached as Appendix 1.
