Licensing (Scotland) Act 2005 – Application for a Provisional Premises License City of Aberdeen Distillery, Arch 10, Palmerston Road, Aberdeen, AB11 5RE

I refer to the above application and in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005, I make the following representation under the licensing objectives:

Protecting and Improving Public Health Protecting Children and Young People from Harm.

The applicant seeks a licence for the premises, which I do not object to.

Detailed in the operating plan it is also mentioned that they will distribute "to trade and public"

Although this is not a new concept and I am aware of a range of companies who accept orders and deliver in a similar manner, this poses a number of questions.

- 1. What controls will be in place to restrict inappropriate deliveries containing alcohol.
- 2. In Scotland we have robust practice in relation to Challenge 25. What controls will be in place around this. will this be implemented in other areas?
- 3. If successful this licence will be granted in Aberdeen. The Aberdeen City Licensing Board will have no means to monitor deliveries out with its licensing area. Where will complaints regarding any inappropriate deliveries be made, how will this be investigated and how will this process be conveyed to the public?

In response to Question 3 I would suggest that City of Aberdeen Distillery place a clear notice on their website and include this on any relevant paperwork thus informing the

public of the Aberdeen City Licensing Board details so that customers will know who and where to direct any complaints to.

For these reasons, and in terms of Section 22(1) (a) of the Licensing (Scotland) Act 2005, the Public Health Directorate of NHS Grampian submits this letter of representation as the granting of the application would be inconsistent with one or more of the licensing objectives, namely Protecting and Improving Public Health.

We refer to the above application and in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005, I make the following representation under the licensing objective:

Protecting and Improving Public Health

The applicant seeks a license for a new Lidl Store at the above address. Data provided within this letter will focus on the evidenced health harms. The Licensing Board should be aware that there is also a high concentration of student accommodation within this area with blocks at Causwayend, Spring Garden and George Street. The Lidl store would be an additional resource to this community but we need to be mindful of the additional harm this could pose with the increased availability of alcohol. The purpose of this representation is to consider measures which could be incorporated into the design of the store which could help mitigate future harms.

This representation will focus on the following points:

- 1. Traffic Light Health Data
- 2. Referrals to Integrated Alcohol Service
- 3. Hospital admission rates for wholly attributable alcohol- related conditions.
- 4. Alcohol related deaths by neighbourhood areas.
- 5. Alcohol related hospital admissions by neighbourhood areas.
- 6. Distance between existing off sales premises in the area.
- 7. Information from the Centre for Research on Environment, Society and Health (CRESH)

8. Health Impact Assessment commissioned by Aberdeen City Licensing Forum

1. Traffic Lights Data

Scottish Public Health Observatory Data has been used to compile The Health Traffic Lights document for Aberdeen City¹. Post code data from sector **AB25 3** has been extracted from this document and is illustrated below using health indicator areas for this community:

Across the IZ024 area it is clear to see that the health harms attributed to alcohol are clearly higher than the Scottish Average. The population from this area will be the target footfall customers for this Lidl store although we also anticipate that customers will also travel by car and public transport to access the facility. Although further away from the location of the store, across the IZ026 area 4 out of the 6 alcohol related health indicators are higher than the Scottish Average. Areas IZ029 and IZ033 comprise less that 13% of the total area population

Regularly drinking alcohol raises blood pressure and significantly increases the chance of people developing heart disease in the future².

Depression shares a complex, mutually reinforcing relationship with excessive alcohol consumption². Regardless of whether heavy alcohol consumption or mental health issues came first, having one condition increases the chances of developing and likely complexity of the other.





3. Hospital admission rates for wholly attributable alcohol- related conditions.

Trends in wholly-attributable alcohol-related hospital admissions in Grampian have been generally consistent with those seen nationally. The absolute numbers of people admitted to hospital each year as a result of alcohol rose since the late 1990s and in recent years, has fallen slightly. This fall is largely accounted for by young adults being admitted because they are intoxicated after a one off heavy drinking episode which was the most common cause of hospital admission. The decrease in admissions of intoxicated young adults hid the fact that over the same period, the number of middle aged and older people admitted to hospital with chronic health conditions caused by exceeding sensible drinking guidelines over weeks, months and years has increased. The change in patterns of harm are compatible with the context of people purchasing alcohol from off sales to drink at home and regularly exceeding low risk drinking guidelines.


The types of chronic health harms include liver cirrhosis, pancreatitis and alcoholic gastritis. How much alcohol and how often it needs to be drunk to cause this type of long term damage vary from person to person. As many as a third of people with liver cirrhosis do not have alcohol dependency.



Although alcohol related hospital stays appear to be on a decreasing trend there is evidence of an increasing trend in alcoholic liver disease stays – see graph above. This figure is currently over double the rate recorded in 1997/98³.

7. Information from the Centre for Research on Environment, Society and Health (CRESH).

Using the CRESH⁴ database the following figures have been provided and are based on the Off Alcohol Sales for 2016 using the buffer distance of 800m from the centre of this datazone, which equates to an approximate 10 minute walk. The statistics detailed below are based on the IZ024 (40.6%) George Street area and are compared to the Scottish Average.


Outlet Count

The number of outlets around the population centre is 30 which is 550% of the Scottish average.

This datazone is in the top 10% of neighbourhoods in Scotland.

Health

• The standardised mortality ratio for alcohol related deaths is between 180 and 587, which is in the top 10% of neighbourhoods in Scotland.



As you can see from the snapshot taken of the CRESH mapping tool, the AB25 3TB post code area is ranked among the highest in Scotland for alcohol off sales outlets. Across the whole of Scotland, neighbourhoods with the highest alcohol outlet availability had significantly higher rates of alcohol-related health harm and crime⁵.

8. Health Impact Assessment commissioned by Aberdeen City Licensing Forum

The impact assessment spoke with individuals in recovery from alcohol dependence.

People in recovery described the path to dependence

"I just think the way growing up, I grew up on drink. See my parents there. I seen everyone there. Ken, when you turn 13, you want to be an adult. You think, let's just do what adults do. I think it's how you feel as well. If you're emotional or stressed, you're much more likely to go looking for a drink"

Drinking to cope was a core feature of the impact assessment, people in Aberdeen City who were experiencing emotional, financial, physical, relationship difficulties in life told us how they used alcohol to cope.

The path to dependence was described as something that "crept up on you"

"From an early age, I never thought I was going to be an alcoholic. No, I truthfully didn't. I started to drink very early but, if someone had of said to me at 18, 19 xxx, you're an alcoholic. No way! No way, I'm an alcoholic at my age? So kids, we get that denial. We denied that we were drinking so much"

People in recovery also described their experiences at their lowest moments

"it's not pubs because pubs are too dear. You only go to a pub for a special event. So, problem drinking is done from supermarkets, local shops. If you're only needing a bit of milk and a loaf of bread you cannae get it without passing alcohol"

Whilst it might be an individual's choice to buy a drink and relapse, it is very difficult to try and rebuild lives whilst simultaneously faced with the prospect of relapse.

"the script is, you know: you go in, I'm nae buying, I'm nae buying, I'm nae buying; you're paying for what you bought you're being really good. You bought everything that you need, you bought food: bingo! Here's a bottle of vodka"

The proximity of shops does make a difference. Some people in recovery would walk whatever distance it took until they were able to buy a drink, others said that having fewer shops in the local area would act as a disincentive.

"Well, I used to like liquor myself, ken and... at the end of the day at 5 when you're knackered with whatever you're working on and you think cool. If I had to go walk a few miles to go get it to the big supermarket I'd be like no, ken?"

On the basis of the high levels of health harm, and close proximity of numerous other premises, we conclude that additional provision would further contribute to the already high levels of harm in this area.

Actions that limit the availability and access to alcohol can only assist in improving health outcomes for the Aberdeen City population. We would request that Lidl give consideration to:

- Reducing the capacity figure to between 35 and 49 square metres for this store to be consistent with other Lidl stores in Aberdeen City.
- Not positioning alcohol on the end of isles
- Placing the display of alcohol in a part of the store whereby it is possible to enter the store, purchase other items and pay without having to pass through the alcohol section.
- Not using island gondolas for the display of alcohol products
- Not positioning alcohol near products aimed at children, or for use by children (e.g. baby products, etc)

For these reasons, and in terms of Section 22(1) (a) of the Licensing (Scotland) Act 2005, the Public Health Directorate of NHS Grampian submits this representation to the application as the granting of it would be inconsistent with one or more of the licensing objectives, namely Protecting and Improving Public Health.

applies, I request the variation be granted subject to the conditions that CCTV, Door Supervisors and Radiolink are in effect from 0100 hours.





The above variation application has been assessed by this Service in respect of potential for noise impact on neighbouring residences and disturbance.

The assessment focussed on extension of the core hours terminal hour from midnight to 02:00 Hours from Sunday to Thursday nights and from 01:00 Hours to 02:00 Hours on Friday and Saturday nights and the proposed inclusion of live performances with music to exceed '85dB' during core hours. This significant change is considered to have increased risk of adverse impact on neighbouring residences.

It is naturally desirable to avoid a situation that would result in this Service serving formal notices to abate activities that have caused statutory nuisance. Having carefully considered the matter based on the information submitted this Service is unable to support the proposals in the interests of protecting amenity of neighbouring residential properties from noise.

Should however, a detailed noise impact assessment produced to the satisfaction of this Service and by a suitably qualified independent noise consultant be submitted to support the proposals, this Service can review the application and provide a response.

This assessment should identify the likely sources and levels of noise arising from the premises and any noise attenuation measures required to ensure music noise is inaudible (essentially 10 dB(A) below background L_{A90} noise levels) in the closest neighbouring residential properties during the periods in question. Any required noise attenuation measures identified must be installed prior to the proposed activities being undertaken.

Licensing (Scotland) Act 2005 – Variation of a Premises License Coopers Bar, 43 John Street, Aberdeen, AB25 1LN

I refer to the above application and in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005, I make the following objection under the licensing objectives:

Protecting and Improving Public Health


The applicant seeks to extend the terminal hour of the premises from 2200 to 2300 on a Tuesday and Thursday. As the premises are already trading from 0800 on both of these days, extending the terminal hour means that they will be exceeding the reasonable trading times recommended by the Licensing Board of 14 hours.

The Aberdeen City Licensing Board Statement of Licensing policy, 2013 – 2016 states at Section 20.3, paragraph 1:

"The Board will deem up to a maximum of 14 hours continuous trading in any 24 hour period to be reasonable. This is in accordance with the aforementioned Government Guidance which further states that any application for licensed hours for more than 14 hours should require further consideration to the effect of granting extra operating hours."

The Board has already stated that the "14 hour maximum trading period is not exceeded in order to help reduce alcohol related crime and health harms."

The health harms of alcohol in Aberdeen City are both substantial and increasing. Since 1997, a five-fold increase in the rates of hospital stays as a result of the harmful use of alcohol has been recorded for Aberdeen City Council residents.



Although alcohol related hospital stays appear to be on a decreasing trend there is evidence of an increasing trend in alcoholic liver disease stays – see graph above. This figure is currently over double the rate recorded in 1997/98¹.

Recently published data on Alcohol Related Deaths for Aberdeen suggest an upward trend in the numbers of people dying as a result of alcohol².

When consideration is given to the health harms caused by alcohol for Aberdeen City Council residents I would request that this application for trading in excess of the reasonable 14 hours is not granted.

Actions that limit the availability and access to alcohol can only assist in improving health outcomes for the Aberdeen City population.

LICENSING OBJECTIVE - PROTECTING CHILDREN FROM HARM

- 28.1 The Board wishes to see child safe premises thriving in the city. It welcomes applications from those who wish to operate licensed premises which accommodate children and families. In determining any such application the risk of harm to children will be paramount.
- 28.2 Where applicants wish to operate such premises, the Board expects them to appreciate that this places additional responsibilities upon them at the same time as recognising that parents and other adults accompanying children also have responsibilities.
- 28.4 The following examples of control measures are given to assist applicants.
 - effective and responsible premises management
 - adoption of best practice guidance
 - imitations on the hours when children may be present, in all or parts of the premises
 - imitations or exclusions by age when certain activities are taking place
 - imposition of requirements for children to be accompanied by an adult
 - acceptance of accredited proof of age cards with photographs, or passports

I refer to the above application for the variation of a premises licence under terms of Section 29(5) of the Licensing (Scotland) Act 2005.

The variation requested consists of the following requests, namely:

- 1. Amending Q5 to include the provision of outdoor drinking during and outwith core hours;
- 2. Amending the wording within Q5 to include the provision of 'parent and child groups, parties and private dining';
- Amending Q6 relating to the terms in which children and young persons are permitted from only being permitted if accompanied by an adult whilst consuming food to only being permitted whilst accompanied by an adult;
- 4. Amending Q6 relating to the times in which children and young persons are permitted from being the restaurant until 2300 hours to all public parts until 2300 hours. Children and young persons will only have access to the public bar area from opening until 1800 hours.
- 5. Amending Q6 relating to the parts in which children and young persons are permitted, removing the wording of 'restaurant' and replacing it with 'all other public parts'

In terms of Section 29(5) of the Act this request can be considered a variation.

In relation to point 2, I have no adverse comment to make.

In terms of Section 22(1)(b)(ii) and (iii) of the same Act, I make the following representation.

I relation to point 1, I recommend that the operating plan and layout plan that accompanies the application form are modified to show clear delineation and is subject to a terminal hour of 2200 hours.

In relation to points 3-5, the applicant was contacted and he advised that the changes requested were to facilitate the activities as detailed within point 2 where the activities would be age appropriate and in a family friendly environment.

Having regard for this, I recommend the existing operating plan is modified to state that 'Children and Young Persons are permitted access accompanied by an adult for the purposes of consuming food or attending a child friendly event, where alcohol is not permitted. Child friendly events are not permitted to take place within the bar area of the premises'.

This representation is submitted for your attention in considering this application.

I refer to the above application and in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005, I make the following representation under the licensing objectives:

Protecting and Improving Public Health Protecting Children and Young People from Harm.

The premises seek a number of amendments to the operating plan but those that concern us most are:

- Q6(b) Please remove the words "consuming food"
- Q6(e) The proposed amendment "Allow children and young persons access to the public bar area between the daily opening of the premises and 1800."

We are concerned that children and young people could be exposed to a drinking environment where no food is consumed under the current wording of the variation. We also have concerns about children and young people being present in an environment that could become quite rowdy or loud if patrons are watching televised sport or playing pool. We suggest it would be more appropriate to amend the statement provided in paragraph 6(d) of the Operating Plan to give more clarity to staff and patrons. As a result we suggest that the following statements could be considered.

Proposed change of wording:

"Children and young people are only allowed in the Bar area between 1100 and 1700 Monday through to Friday. Children and young people will not be allowed entry during public holidays and/or televised sporting events should they fall on any of these week days." Children and young people must be accompanied by an adult ordering food from the restaurant/bar menu".

In making this statement we wish to convey the preferred option of eating food with drinking alcohol and setting a good example to children and young people.

I understand that the Licensee has also discussed with my colleague, Heather Wilson, the possibility of developing a "Responsible Parenting Policy" which would restrict adults with children to 2 drinks. We would welcome the introduction of such a policy and would be happy to assist in developing this further.

I also understand that dedicated mother and toddler events, Halloween parties, Christmas parties and other events primarily involving children will be restricted to the Conservatory area of the premises which is separate from the Restaurant and Bar.

Actions that limit the availability and access to alcohol can only assist in improving health outcomes for the Aberdeen City population.

For this reason, and in terms of Section 22(1) (a) of the Licensing (Scotland) Act 2005, the Public Health Directorate of NHS Grampian submits this letter of representation as the granting of the application would be inconsistent with one or more of the licensing objectives, namely Protecting and Improving Public Health and Protecting Children and Young People from Harm.

In terms of Section 22 (1)(b) (iii), I make the following representation to the Licensing Board as to the conditions which the Licensing Standards Officer considers should be imposed with this variation.

In regards to the licensing objective - Protecting Children from Harm:

The Licensing Standards Officer (LSO) and a representative from the NHS met with the management team at the Premises. At the meeting a discussion was held in regards to children's access to the bar and the proposal for the removal of the 'consuming food' element to the access terms.

The outcomes of the meeting are listed below;

- 1. The management team suggested that accompanied children will have access to the bar Monday to Friday from 11am to 5pm. The LSO is satisfied with the times suggested, however, we understand that this has to be agreed upon by the agent and the Licence Holder also. If no agreement is reached, the LSO will revert back to her representation and appeal to the Licensing Board for the modification to be agreed upon or explored further in order to protect children from harm.
- 2. We agreed that during these type of events, the bar would have the potential to be a more adult orientated environment and that it is not an appropriate time for children to have access. I am satisfied that management will take responsibility in determining whether children will have access to the premises prior to the event.
- 3. It was also agreed by the management team, that the adult who has the responsibility for looking after the child during the visit will have no more than 2 drinks containing 'alcohol' and the adult will be required to consume a meal. The Licensing Standards Officer supports this suggestion by the management team, this will lead to the child being exposed to alcohol in a more social and family friendly environment; by seeing the adult partake in a meal whilst restricting the amount of alcohol the parent or guardian will consume.
- 4. Whilst the bar is predominately 'alcohol sales' led, it was also agreed that children will not approach the bar. Children will always be accompanied by an adult.

In regards to the licensing objective - <u>Preventing Public Nuisance:</u>

The applicant wishes to operate an external licensed area at the Premises. The Premises is adjacent to residential properties and for this reason I have the following

points that should be incorporated into their Operating plan, in order to reduce the potential for a public nuisance concern for residents nearby.

- 1. Music will not be played within the external area.
- 2. The external area will not be in operation after 2200 hours.

The management team informed us that they would discuss the outcomes of the meeting with the Licence Holder and the agent and if all parties agreed they would therefore amend the application.

If the application is amended to include the points raised above, the LSO will have no further concern in regards to variation of Q5 and Q6 of their Operating plan.

CHIEF CONSTABLE'S REPORT TO THE ABERDEEN CITY LICENSING BOARD FOR THE PERIOD 1ST APRIL 2017 to 31ST MARCH 2018

Foreword

It gives me great pleasure to provide the Annual Licensing Report for 2017/18, in accordance with Section 12(A) Licensing (Scotland) Act 2005.

I would like to acknowledge the contributions made to effective licensing regulation in the past year. Working in partnership is vital to ensure a fair and consistent approach to licensing whilst maintaining a focus on preventing alcohol fuelled violence, disorder and antisocial behaviour. Police Scotland is committed to continuing to work with partners in the 32 Local Authorities across Scotland to achieve positive outcomes.

Over the past year, Police Scotland has continued to achieve success with a focus on prevention, underpinned by early intervention and enforcement. This has only been possible with the support of the many active partnerships that exist in local areas. I will ensure that all officers and staff continue to work with the licensed trade and other key partners, utilising the range of options available to them to achieve improved licensing standards, reducing violence, disorder and antisocial behaviour across Scotland.

On 1st May 2018, Minimum Unit Pricing of Alcohol was introduced in Scotland. We will work through the Evaluation Advisory Group to assess the impact of this legislation. The coming year will present many challenges but I am confident that through collaborative working, we will meet these challenges and continue to improve licensing standards and deliver a service to the communities of Scotland.

POLICE SCOTLAND LICENSING OVERVIEW

The National Licensing Policy Unit (NLPU) sits within the Specialist Crime Division – Safer Communities, based at Dalmarnock Police Office, Glasgow.

The NLPU is responsible for the two tier structure for licensing which supports both national and local priorities. They have overall responsibility for determining and delivering national licensing strategy and policy, by providing advice, guidance and support to divisional licensing teams.

Each of the 13 Local Policing divisions have locally based officers dedicated to the day to day management of licensing administration, complying with statutory requirements as well as addressing any issues that may arise within licensed premises in their local area.

Police Scotland Licensing is supported and governed by a National IT solution known as 'InnKeeper'.

The NLPU and Licensing practitioners within Police Scotland develop partnerships and identify best practice which assist in a better understanding of the challenges faced by the Licensed Trade. This approach enables us to continue to work with local communities and key partners to prevent alcohol related crime and offences.

The NLPU seek to ensure that legislation governing the sale and supply of alcohol is applied consistently across the country and all opportunities are taken to stop the illegal or irresponsible sale, supply or consumption of alcohol with the intention of preventing and reducing crime and disorder.

NATIONAL PERSPECTIVE

Our Priorities and Policing Plans continue to be shaped by the objectives contained within Scottish Government's Strategic Objectives and National Outcomes and the Strategic Policing Plans that are delivered locally through single outcome agreements.

Consultation and engagement is combined with our own analysis of the issues that impact on the safety of the public to provide a firm evidence base for local policing teams to prevent crime and disorder and Keep People Safe.

Our National Priorities are

- Violence, disorder and antisocial behaviour
- Serious organised crime
- Counter terrorism and domestic extremism
- Protecting people at risk of harm
- Road safety and road crime
- Acquisitive crime

LICENSING BOARD AREA

The Aberdeen City Licensing Board area is policed by North East Division.

Chief Superintendent Campbell Thomson is the Local Police Commander who has the responsibility for all day-to-day policing functions.

LOCAL POLICING PRIORITIES

Following our public consultation process, the policing priorities for North East Division, as set out in our Local Policing Plan are as follows;

- Antisocial Behaviour, Violence and Disorder
- Acquisitive Crime
- Protecting People at Risk of Harm
- Road Safety and Road Crime
- Serious Organised Crime
- Counter Terrorism and Domestic Extremism

SENIOR OFFICERS

The senior officer who holds responsibility for licensing within the area of North East Division is Temporary Superintendent Richard Craig.

OPERATION OF THE LICENSING (SCOTLAND) ACT 2005

The North East Division Licensing Team is led by Inspector Kenny McGeough who is based at Queen Street Police Office, Aberdeen. He is supported by Sergeants Gill Flett and Kim Wood, based at Queen Street and Stonehaven offices respectively. Licensing enquiry officers and administrative staff are located across the Division in Elgin, Inverurie, Aberdeen and Stonehaven. All staff have a division wide remit and a working knowledge of all the areas covered.

PARTNERSHIPS

The North East Division Licensing team, supported by Community Policing Officers, has promoted the Police Service of Scotland's force priorities alongside the five licensing objectives, the overarching principles and aims of the Licensing (Scotland) Act 2005.

The team enjoys a strong working relationship with the Local Authority Licensing Standards Officers. Both teams meet on a regular basis to share information. Over the reporting period there were a large number of inspections carried out jointly to licensed premises in the Board area. Specific areas of concern which often prompts

such visits can be information about a lack of robust management of premises or lack of compliance with conditions relating to CCTV.

The reporting period has a focus on inspections of licensed premises through Local Days of Action, which were led by the North East Division Licensing Team, supported by the Licensing Standards Officers.

This approach has seen a more pro-active and operational role of the Divisional Licensing Team working more closely with Community Policing Teams and has reinforced the direct partnership working required for the meaningful policing of licensed premises.

North East Division Licensing Team is represented on the Local Licensing Forum and Aberdeen Alcohol and Drugs Partnership and works alongside the following groups and organisations to jointly improve local licensing issues:

- Licensing Standards Officers;
- Unight;
- Weekend Partnership;
- Torry Alcohol Action Group;
- Purple Flag;
- Community Safety Partnership;
- Local Pubwatch initiatives;
- Local Security Industry companies;
- Best Bar None;
- Street Pastors.

PROBLEM SOLVING

Incident management is a critical aspect of our ongoing monitoring of licensed premises.

Community based Police Officers are encouraged and expected to routinely visit licensed premises within their area. Aberdeen city centre benefits from a dedicated Policing Plan to support the night time economy. Within the reporting period, there were 3450 inspections (visits) to licensed premises within Aberdeen recorded on the InnKeeper system.

Any Police Officer who attends an incident at any licensed premises is expected to submit a concise report via the Innkeeper system, particularly when the incident involves violence, disorder, anti-social behaviour, drunkenness, drug misuse, underage drinking, breaches of licensing legislation or any other matter that might impact on the safety of the public. Within the reporting period, there were 1058 incidents connected to licensed premises within Aberdeen recorded on the InnKeeper system.

The information obtained may show a causal link between the operation of the premises and the incident. An incremental intervention process allows for issues to be addressed quickly and effectively at an early stage. This includes a low level 'interaction' which may involve a discussion between the Police and the premises

management and/or licence holder. The level of engagement from within the Aberdeen licensed trade is very good and in many instances, this approach reduces recurrence or escalation.

Premises may become 'monitored' with closer attention being paid to any incidents occurring there. This is often undertaken in conjunction with tasked, supportive visits to the premises by uniformed Police Officers.

However, where necessary, the staged process allows for more formal intervention to support premises where a need has been identified. A premises licence holder and the premises management may be asked to attend a meeting with the Police, where concerns will be discussed. This will often involve an agreed Action Plan being put in place, with a reasonable time scale for completion. The most common example of an agreed 'action' is refresher training of staff covering their responsibilities including the sale of alcohol to underage or intoxicated persons, 'Challenge 25' and the general terms and conditions of the licence held.

Should the intervention stage not bring about the necessary changes, or be otherwise unsuccessful, the next stage is the submission of a premises licence review application for the consideration of the Licensing Board.

Over the reporting period there have been eight licensed premises in Aberdeen subject to a period of monitoring or intervention. Of these eight, three were late opening venues, three were 'wet sales' led premises, one was a restaurant and one was an 'off sales' premises. The issues that were addressed ranged from sale of alcohol outwith licensed hours to duty of care concerns towards highly intoxicated patrons.

All of these 'interventions' were concluded successfully, thus negating the need to bring to the Board's attention issues which may previously have been brought before them by premises licence review application.

In the reporting period there were no premises licence review applications submitted to the Board.

The North East Division Licensing Team has a system in place which monitors certain conduct of Personal Licence holders. Should such a licence holder be charged with any offence, this is brought to the attention of the team. Should the circumstances appear to be inconsistent with any of the five licensing objectives, consideration will be given to bringing this to the attention of the Board by way of a personal licence review. In addition, should an individual be convicted of a relevant offence, this will undergo the same scrutiny.

SUMMARY

In relation to the city centre of Aberdeen, many of the most common alcohol-related crimes and offences have dropped in the past three years. However, the number of serious assaults which occurred within the city centre during the late night and early morning has not decreased. A significant number of the people who were subsequently identified as being responsible had, in most cases, come from licensed

premises and the peak time when these crimes occur are the hours from 0100 to 0400 on weekends.

The prevention of crime is not a strategy owned exclusively by the Police and we seek the co-operation, commitment and invested involvement of our of external partners, including the Licensing Board and licensed trade to explore all avenues and options to reduce alcohol-related crime, the impact of which extends beyond economic factors.

PREVENTING THE SALE OR SUPPLY OF ALCOHOL TO CHILDREN OR YOUNG PEOPLE

Aberdeen City attracts a relatively low number of reports of underage drinking or youth congregation involving alcohol when considering other towns and cities across Scotland.

Where a person under 18 years of age is found to be either under the influence of alcohol, drinking alcohol in a public place or in possession of alcohol, the Police Officer involved will take all appropriate steps to ascertain the source of the alcohol.

Where information that cannot be fully evidenced is received regarding the sale of alcohol to children and young persons, in accordance with the national guidance contained within the 'Alcohol Toolkit', letters will be sent to licensed premises in the area reminding them of their responsibilities and requesting extra vigilance.

If such concerns were to continue in respect of specific premises, then other operational strategies would be considered.

One way in which North East Division delivers our commitment to the community is through our School Liaison Officers and School Based Officers. These Officers attend schools and other educational establishments seeking to equip our young people with the appropriate information and understanding that will allow them to make better informed decisions in key areas of their lives, both now and in the future. To this end they deliver lessons, linked to the Curriculum for Excellence, on a range of subjects including alcohol, controlled drugs and anti-social behaviour — particularly alcohol fuelled anti-social behaviour and the potential for related safety issues and consequences.

In support to the Protection of Children from Harm licensing objective, applications for premises licences and variations to premises licences come under close scrutiny often resulting in the submission of letters of objection, or more commonly, of representation, in which the imposition of conditions in respect of on sales, with regard to the times and terms in which children can be on such premises, will be recommended by the Chief Constable.

TACKLING SERIOUS AND ORGANISED CRIME

Many of the processes and procedures involved in licensing applications are carried out to guard against Serious Organised Crime Groups (SOCG) infiltrating the

licensed trade in any way. This scrutiny is further enhanced with the nation-wide InnKeeper system. This database contains details of all liquor and civic licences for every Division in Scotland, and enhances our information sharing in respect of premises and people in the licensed trade as they move about the country and work in multiple venues.

If such an SOCG were able to gain a foothold in licensed premises this would afford the criminal group a seemingly legitimate income stream, which could be no more than a veneer for other criminal activities such as money laundering, tax evasion, drug and people trafficking and other dishonest activities.

Many of the procedures currently carried out by the North East Divisional Licensing Team, particularly in relation to new premises licences and the transfer of premises licences are done to ensure complete financial transparency and to ensure there are no business related irregularities which may be indicative of SOCG involvement.

Frequent and directed Police attendance and contact with licensed premises also increases the opportunity for irregularities to be identified or reported.

As part of this, the North East Division Licensing Team regularly liaise with Police Interventions staff who are aware of SOCG activity within the Division to ensure that applicants are not affiliated in any way to such groups, before responding to the Licensing Board.

The consistent high profile approach and interaction with licensed premises in direct correlation with the aforementioned close scrutiny in the application process should reinforce the work carried out to maintain this position.

PROPOSED ACTIVITY FOR THE YEAR AHEAD

Over the forthcoming year, North East Division Licensing Team, in conjunction with Community Policing Teams, will work alongside licensed premises, to ensure that these premises are adhering to the spirit of the legislation and operate in a manner that supports the five licensing objectives.

The North East Division Licensing Team is fully engaged in the consultation process as we move towards the publication of a new Statement of Licensing Policy and will continue to provide the Board with relevant data in respect of key times and locations to assist inform policy on guideline hours in relation to certain activities taking place within licensed premises, to continue working to reduce alcohol related violence.

This aspect of our future work should build upon the success of other areas within North East Division alongside an increased focus upon the use of analytical evidence to support direct, yet proportionate reasons for requesting that short and long term public safety orientated conditions are considered for one off events and established licensed premises.

We intend to continue carrying out Local Days of Action and other associated initiatives involving activity at and around licensed premises, with a view to further reducing the numbers of adverse incidents at such premises and to support premises licence holders and their staff too, who make a positive contribution to Aberdeen's economy and creditable reputation. These operations will be carried out in support of and in conjunction with Community Policing Teams. We will carry out this activity in partnership with other agencies, particularly the Licensing Standards Officers, ultimately to uphold the five licensing objectives to ensure the safety and wellbeing of the people of and visitors to the city of Aberdeen.

To conclude we would like to thank you for your continued support and stress the importance of this collaborative, problem solving approach which ensures that Police, licence holders and licensed premises staff have a secure understanding of their responsibilities to preserve order, reduce violence and promote safety.
