## **Preventing Public Nuisance**

The Board believes that licensed premises have the potential to have a significant impact on communities. It wishes to maintain and protect the amenity of the surrounding neighbourhoods whilst recognising the valuable cultural and social aspects of such premises.

Whilst licensing powers are not the main statutory mechanism for dealing with public nuisance in general the Board will interpret public nuisance in a wider sense where it relates to the operation of licensed premises, and in particular issues such as noise and litter.

Again, a number of factors should be considered including, but not limited to:

- Location of premises. In particular the proximity to residential or noise sensitive premises such as medical facilities, sheltered housing, schools, places of worship, nurseries and suchlike.
- Hours of operation. Closely related to the location of the premises, the hours
  of operation should reflect what is appropriate for the surrounding
  neighbourhood. The terminal hours indicated in the Supplementary Policy
  on Licensed Hours are the maximum available and will not be suitable for all
  premises.
- Nature of activities. Any activities carried on in the licensed premises should not be detrimental to the ambience of the locality.
- Outdoor areas. The Board will include a Supplementary Policy on this issue, but applicants will require to ensure that the inclusion of an outdoor licensed area in any premises is appropriate and will not contravene the licensing objective of preventing public nuisance.
- Smoking areas. These should be designed to minimise public nuisance and regularly monitored to cut down on noise and litter.
- Noise from patrons entering and exiting the premises.

## What the Board Will Do:

- Consider the proximity of proposed licensed premises to noise sensitive premises when considering applications.
- Ensure that licensed hours and activities are appropriate for the type of premises and locality. The terminal hours indicated in the Supplementary Policy on Licensed Hours are the maximum available and will not be suitable for all premises.
- Improve communication between the trade, partners and local communities.
- Impose additional licence conditions where appropriate to prevent public nuisance.
- Highlight best practice where available and increase awareness and education on potential areas of risk.

## What the Board Will Expect of Licence Holders/Applicants:

- Take a proactive approach to public nuisance with a risk-based approach.
- Be mindful of the location of the premises, hours of operation and activities.
- Comply with all conditions of the premises licence.
- Ensure appropriate control measures are in place and staff training is up to date and relevant.
- Consider public nuisance when establishing the design and layout of the premises.
- Adequate supervision of any outdoor area, smoking area and patrons entering/exiting the premises.
- Sharing of best practice via trade groups.
- Participation in communication to resolve any issues that may arise.
- Co-operation with Police Scotland and Licensing Standards Officers including access to all relevant policies and procedures such as dispersal policies and incident management.

#### Good afternoon

The above application has been assessed by this Service in relation to any music noise breakout from live music played/performed at the premises. Consideration has been given to the risk of noise impact on local residences at the proposed times listed in the application.

As with any such matter it is naturally desirable to avoid a situation that would result in this Service serving formal notices to abate activities that have caused nuisance.

This application for variation of premises licence will increase the number of hours the premises is open during early morning hours. As a result there is likely to be a significant impact from noise emitting from the premises from live and amplified music on local residences. Complaints concerning loud music breakout from Paramount have previously been investigated by this service. According to the Supplementary Policy - Licensed hours, the licence holder is responsible for demonstrating that the premises are suitable for the hours sought. It is therefore recommended that a noise impact assessment be undertaken to identify what impact, if any, music noise may have on the nearest residents during the hours the premises is open and the identify noise mitigation measures, if required, to ensure that the nearest residences will not be affected by the proposed extension of opening hours.

The methodology that would be required is noted below:

A detailed assessment of noise levels within the flats above the licensed premises should be undertaken when the premises are typically at their noisiest (including any cumulative noise impact). The assessment must consider the LAmax, LAeq over specified measurement periods, 1/3 octave frequency analysis and background levels when the licensed premises are not operational. The assessment should also identify the noise breakout areas.

The noise assessment should demonstrate inaudibility within the residential properties. The scheme must contain noise calculations to demonstrate how this will be achieved.

**Note**: Inaudible is considered to mean the LAeq should not exceed 10dB below the existing background noise (LA90).

# **Protecting Children and Young Persons from Harm**

The Board recognises that the question of access to licensed premises by children and young persons is not one that can be answered with a one size fits all type of approach. The suitability of premises will depend on a number of factors including layout of the premises, activities or services available, and typical customer demographic.

Applicants and licence holders should also be aware that access for children and young persons will bring with it additional responsibilities and may result in additional conditions being attached to the licence.

#### What the Board Will Do:

- Assess all applications for suitability of access for children and young persons.
- Impose additional conditions where necessary to protect children and young persons from harm.
- Limit the hours during which children and young persons have access if appropriate.
- Limit activities which may take place on the licensed premises during hours in which children and young persons have access if appropriate.

# **Preventing Public Nuisance**

The Board believes that licensed premises have the potential to have a significant impact on communities. It wishes to maintain and protect the amenity of the surrounding neighbourhoods whilst recognising the valuable cultural and social aspects of such premises.

Whilst licensing powers are not the main statutory mechanism for dealing with public nuisance in general the Board will interpret public nuisance in a wider sense where it relates to the operation of licensed premises, and in particular issues such as noise and litter.

Again, a number of factors should be considered including, but not limited to:

- Location of premises. In particular the proximity to residential or noise sensitive premises such as medical facilities, sheltered housing, schools, places of worship, nurseries and suchlike.
- Hours of operation. Closely related to the location of the premises, the hours
  of operation should reflect what is appropriate for the surrounding
  neighbourhood. The terminal hours indicated in the Supplementary Policy
  on Licensed Hours are the maximum available and will not be suitable for all
  premises.
- Nature of activities. Any activities carried on in the licensed premises should not be detrimental to the ambience of the locality.
- Outdoor areas. The Board will include a Supplementary Policy on this issue, but applicants will require to ensure that the inclusion of an outdoor licensed area in any premises is appropriate and will not contravene the licensing objective of preventing public nuisance.

- Smoking areas. These should be designed to minimise public nuisance and regularly monitored to cut down on noise and litter.
- Noise from patrons entering and exiting the premises.

### What the Board Will Do:

- Consider the proximity of proposed licensed premises to noise sensitive premises when considering applications.
- Ensure that licensed hours and activities are appropriate for the type of premises and locality. The terminal hours indicated in the Supplementary Policy on Licensed Hours are the maximum available and will not be suitable for all premises.
- Improve communication between the trade, partners and local communities.
- Impose additional licence conditions where appropriate to prevent public nuisance.
- Highlight best practice where available and increase awareness and education on potential areas of risk.

# What the Board Will Expect of Licence Holders/Applicants:

- Take a proactive approach to public nuisance with a risk-based approach.
- Be mindful of the location of the premises, hours of operation and activities.
- Comply with all conditions of the premises licence.
- Ensure appropriate control measures are in place and staff training is up to date and relevant.
- Consider public nuisance when establishing the design and layout of the premises.
- Adequate supervision of any outdoor area, smoking area and patrons entering/exiting the premises.
- Sharing of best practice via trade groups.
- Participation in communication to resolve any issues that may arise.
- Co-operation with Police Scotland and Licensing Standards Officers including access to all relevant policies and procedures such as dispersal policies and incident management.

**Environmental Noise (Recommended Conditions)** 

The diagram entitled Proposed Plan - G.A. Plan (Reference. Licence drawings 01.11.18 revision C Drawing 1728lb - 102) indicates a licensed area which includes the external pergola garden area and central garden area at the rear of the extended function suite 59 Queens Road. Additionally, a new 'Rear External Licensed Terrace Area' to the rear of 55 - 57 Queens Road is evident.

The Ground floor diagram entitled Proposed Plan – G.A. Plan (Reference. Licence drawings 01.11.18 revision C Drawing 1728lb – 101) indicates a licensed area which includes the 'External terrace Area (to private dining)' and the 'Front External Licenced Terraced Area'.

To protect the amenity of residential property near to the proposed location from noise I recommend a condition prohibiting amplified music on the outdoor areas and that the outdoor areas are not used after 22:00 Hours. The use of bagpipes or harps (or other such unamplified solo instruments), which may be played at weddings or other such functions should not be beyond 22:00 hours.

Additionally, in the course of the expansion project, this Service has been advised a music noise level limiting device is proposed within the extended function suite to help control music noise breakout. This Service would therefore recommend a condition requiring the installation of an effective control system for limiting amplified music noise levels within the function suite to an appropriate maximum level. This should be established through a suitable noise level limit setting exercise and to the satisfaction of the Environmental Health Service.
