Licensing (Scotland) Act 2005 – New Premises License Woodside Post Office, 429 Great Northern Road, Aberdeen

We refer to the above application and in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005, I make the following representation under the licensing objectives:

Protecting and Improving Public Health

In creating the new Statement of Licensing Policy, the Licensing Board recognised that excessive consumption of alcohol can cause or exacerbate a number of health problems. They set guidance within the policy to help address these concerns and included details within page 10 of the document that would assist applicants to comply with the Licensing Objective of Protecting and Improving Public Health.

Applicants are asked to consider a number of points when submitting their application for a license. We would be interested in comment on the following points:

• Proactive layout of off-sales premises to discourage impulse buying – The Woodside area has higher than average statistics for alcohol related issues. We are aware that many people in recovery find it difficult to avoid alcohol as it is so readily available and visible as they go about their daily living. We appreciate that the alcohol display will be limited to two specific areas within the shop; behind the counter and within the general shop provision area. In order to restrict the visibility of the alcohol we would suggest that the behind the counter display to placed to the furthurst possible area from the till points so that it is not within immediate eye contact of customers approaching the post office counter. It is appreciated that the

- behind the counter alcohol will not be immediately visible from the main service point for the shop and this will help to discourage impulse purchasing.
- Availability of low/non alcoholic products and soft drinks The range of low and non alcoholic products is growing along with their popularity among customers. We would suggest that the shop stock a selection of these products to give customers the option of purchasing. A selection of brands and reviews can be found at:

Additional suggestions that would help address some of the harms created by alcohol would be to consider additional control measures that could be considered as conditions to the license such as:

- No single cans of alcohol displayed or sold at the premises (multi pack sales permitted)
- No beers or ciders will be sold with an ABV in excess of 6.5%

For this reason, and in terms of Section 22(1) (a) of the Licensing (Scotland) Act 2005, the Public Health Directorate of NHS Grampian submits this letter of representation as the granting of the application would be inconsistent with one or more of the licensing objectives, namely Protecting and Improving Public Health.

We refer to the above application and in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005, I make the following objection under the licensing objectives:

Protecting and Improving Public Health

The applicant seeks to trade on the following terms

- Sunday through to Thursday, 1000 until 0200 = 16 hours continuous trading
- Friday and Saturday, 1000 until 0300 = 17 hours continuous trading

The Licensing Board have already stated on page 12 of the Aberdeen City Statement of Licensing Policy that they consider 15 hours continuous trading to be reasonable within any 24 hour period and that opening or terminal hours should be adjusted accordingly to comply with this requirement.

In creating the new Statement of Licensing Policy, the Licensing Board recognised that excessive consumption of alcohol can cause or exacerbate a number of health problems. They set guidance within the policy to help address these concerns with trading hours being a key component of their strategy to address alcohol related harm within the city.

These premises are also out with the city centre boundry and would normally be subject to terminal hours of midnight Sunday to Thursday and 0100 Friday & Saturday.

We see nothing in this application that would justify these additional hours trading and suggest that the applicant adjust the licensing hours of the premises to comply with the Statement of Licensing Policy.

Premises have the option to apply for an extension to their trading times for special events and we suggest that this is the approach taken by the applicant.

For this reason, and in terms of Section 22(1) (a) of the Licensing (Scotland) Act 2005, the Public Health Directorate of NHS Grampian submits this letter of objection as the granting of the application would be inconsistent with one or more of the licensing objectives, namely Protecting and Improving Public Health.

the Protecting Children and Young Persons from harm licensing objective would have concerns should the application in its current form be granted.

In terms of Section 22(1)(b)(ii) and (iii) of the Licensing (Scotland) Act 2005, I am of the opinion that the variation in its current form should be modified to reflect the following changes in relation to the terms and times during which Children and Young Persons are permitted:

Children aged 14 and 15 are permitted to attend the premises, at the manager's discretion, whilst accompanied by a responsible adult aged 18 years or over, for the purposes of attending an age appropriate concert or music event and are only permitted to remain on the premises until the conclusion of the performance and no later than 2230 hours.

Young persons are permitted to attend the premises, at the manager's discretion whilst accompanied by a responsible adult aged 18 years or over for the purposes of watching an age appropriate concert or music event. Young Persons are only permitted to remain on the premises until the conclusion of the performance and no later than 2330 hours.

POLICY

Supplementary Policy – Licensed Hours

Whilst all applications will be dealt with on their own merits the Board considers it necessary for the promotion of the licensing objectives to set parameters with respect to licensed hours. Any application seeking hours outwith those detailed below will be expected to satisfy the Board that there are legitimate grounds for departing from policy and demonstrate that the granting of such hours would not be contrary to the licensing objectives.

Off-Sale Premises

Maximum trading hours for off-sale premises are set by statute. The Board have no power to grant off-sales hours prior to 1000 or after 2200 hours. It should be noted that these are the maximum permitted hours and the Board may restrict these hours if it can be shown to be necessary for the promotion of the licensing objectives.

On-Sale Premises

The Board considers it appropriate to distinguish hours within the city centre from outlying areas. The city centre area is that shown delineated on the undernoted map.

The hours stated below are the earliest acceptable opening hour and latest acceptable terminal hour, and not the maximum permissible hours. The terminal hours stated below are the latest permissible and will not be appropriate for all premises. It will be the responsibility of the licence holder or applicant to demonstrate that the premises is suitable for the hours sought. We refer to the above application and in terms of Section 22(1)(a) of the Licensing (Scotland) Act 2005, I make the following objection under the licensing objectives:

Protecting and Improving Public Health

The applicant seeks to extend the terminal hour of the premises to enable trading on the following times:

- Sunday through to Thursday, 1000 until 0100 = 15 hours continuous trading
- Friday and Saturday, 1000 until 0200 = 16 hours continuous trading

The Licensing Board have already stated on page 12 of the Aberdeen City Statement of Licensing Policy that they consider 15 hours continuous trading to be reasonable within any 24 hour period and that opening or terminal hours should be adjusted accordingly to comply with this requirement.

In creating the new Statement of Licensing Policy, the Licensing Board recognised that excessive consumption of alcohol can cause or exacerbate a number of health problems. They set guidance within the policy to help address these concerns with trading hours being a key component of their strategy to address alcohol related harm within the city.

We see nothing in this application that would justify additional hours trading and suggest that the applicant adjust the licensing hours of the premises on Friday and Saturday to

comply with the Statement of Licensing Policy. The premises could still be open for breakfast, teas, coffees etc but restrict the sale of alcohol until 1100.

For this reason, and in terms of Section 22(1) (a) of the Licensing (Scotland) Act 2005, the Public Health Directorate of NHS Grampian submits this letter of objection as the granting of the application would be inconsistent with one or more of the licensing objectives, namely Protecting and Improving Public Health.

I am writing on behalf of myself and my parents (Ian & Christine Lakin,

Aberdeen) the owners of flats

regarding the major variation(extension) to the terminal hours for alcohol sales on Fridays and Saturdays to 01.00 (your ref AC0412). For the avoidance of any doubt we own the nine 1, 2 and 3 bedroom apartments directly above the Hawthorn Bar and Adam Lounge, 143 Holburn Street,

Aberdeen AB10 6BN. Our objective in writing this letter is to hopefully minimise the loss of any residential amenity through effective management to minimise any increase in crime, disorder and public nuisance. We wish to make our objections known in a constructive manor in the hope that there can be a pragmatic outcome to what would be a major change for the local neighbourhood at weekends.

BACKGROUND:

The location of the Adams Lounge and Hawthorn bar is in densely populated residential area with flatted properties located to either side and above the premises. There are currently no provisions for council/police monitored CCTV on Howburn Place and limited coverage on this part of Holburn Street - unlike the city centre (Union Street, Langstane place etc) where there is high visibility policing late at night to act as a deterrent to violent and antisocial behaviour. Permitting even one more hour of drinking time for circa 30% of the year will only make the above more of an issue. Indeed, increasing the terminal hour until 01.00 will clearly not improve the quality of life of residents which is contrary to the statement of the licensing policy. Currently the 12-Midnight closure of the premises appears appropriate for the heavily residential local area as there is nothing else open that late, meaning that after the licenced premises closes there are no other local activities to increase the potential for public nuisance. As per the statement of licencing policy the terminal hours are a maximum and are not suitable for all premises and one can only surmise that this particular case is a prime example of where this guidance should apply. For example, one of the key issues regarding our nine properties (in the same building) are the two entrances into the premises which are also the outside smoking areas used by patrons during opening hours. Under these circumstances it is an unfortunate fact that staying open until 01.00 will increase the likelihood of public nuisance to the persons residing in the properties above and around the premises - especially when the smoking areas are only a matter of a couple of metres from some bedroom windows. Furthermore, the more alcohol patrons consume the louder they become and instead of people having their last cigarette at just after midnight they will be

loitering outside until after 01.00 at two separate entrances, opening and closing the outside doors for the proposed additional hour. Unfortunately, the door to the public bar (on Howburn place) when opening and closing can be heard from inside the bedroom of the property above - even after installing acoustic matts and soundproofing. As there are no other designated smoking areas it is impossible to manage or minimise this public nuisance – other than by controlling the closing time.

SUMMARY:

Preferably we would rather not be in the situation of having to contest the application as the present arrangements for a Midnight closure of the bar and lounge have been accepted by the residents of the area for the past several decades. If on the other hand the board is of the mind that regardless of the above objections that some form of extension should be granted, we would urge the board to consider a compromise such as suggested below:

The terminal hour to be limited to 00.30 for the lounge part of the premises but the public bar (Howburn Place entrance) would close at Midnight. This would permit the lounge part to remain open (although still undesirable for residents) which should at least minimise the impact on the much more residential Howburn Place as the door to the lounge bar (with the entrance on Holburn street) is below the living rooms of the apartments unlike the bedrooms situated in Howburn Place.

Finally, a closing time of 00.30 for the lounge and 00.00 for the bar would also be helpful to mitigate against the potential increase in public nuisance and disorder in such a densely populated residential street such as Howburn place - not forgetting the access to our properties are very close to the bar door (Howburn Place) and can be intimidating for residents returning home late at night.

POLICY

Supplementary Policy – Licensed Hours

Whilst all applications will be dealt with on their own merits the Board considers it necessary for the promotion of the licensing objectives to set parameters with respect to licensed hours. Any application seeking hours outwith those detailed below will be expected to satisfy the Board that there are legitimate grounds for departing from policy and demonstrate that the granting of such hours would not be contrary to the licensing objectives.

Off-Sale Premises

Maximum trading hours for off-sale premises are set by statute. The Board have no power to grant off-sales hours prior to 1000 or after 2200 hours. It should be noted that these are the maximum permitted hours and the Board may restrict these hours if it can be shown to be necessary for the promotion of the licensing objectives.

On-Sale Premises

All off-sales premises

The Board considers it appropriate to distinguish hours within the city centre from outlying areas. The city centre area is that shown delineated on the undernoted map.

The hours stated below are the earliest acceptable opening hour and latest acceptable terminal hour, and not the maximum permissible hours. The terminal hours stated below are the latest permissible and will not be appropriate for all premises. It will be the responsibility of the licence holder or applicant to demonstrate that the premises is suitable for the hours sought. Additional

conditions will normally be added to all premises seeking licensed hours after 1am including but not limited to CCTV, door stewards and radiolink. A link to examples of the standard local conditions can be found in the Supplementary Policy on General Licensing Matters.

The Board considers 15 hours continuous trading to be reasonable within any 24-hour period and so the opening or terminal hour should be adjusted accordingly to comply with this requirement.

The opening hours for casinos remains in line with the statutory hours in terms of the Gambling Act 2005, namely 1200 – 0600 daily.

Preventing Public Nuisance

The Board believes that licensed premises have the potential to have a significant impact on communities. It wishes to maintain and protect the amenity of the surrounding neighbourhoods whilst recognising the valuable cultural and social aspects of such premises.

Whilst licensing powers are not the main statutory mechanism for dealing with public nuisance in general the Board will interpret public nuisance in a wider sense where it relates to the operation of licensed premises, and in particular issues such as noise and litter.

Again, a number of factors should be considered including, but not limited to:

- Location of premises. In particular the proximity to residential or noise sensitive premises such as medical facilities, sheltered housing, schools, places of worship, nurseries and suchlike.
- Hours of operation. Closely related to the location of the premises, the hours
 of operation should reflect what is appropriate for the surrounding
 neighbourhood. The terminal hours indicated in the Supplementary Policy
 on Licensed Hours are the maximum available and will not be suitable for all
 premises.
- Nature of activities. Any activities carried on in the licensed premises should not be detrimental to the ambience of the locality.
- Outdoor areas. The Board will include a Supplementary Policy on this issue, but applicants will require to ensure that the inclusion of an outdoor licensed area in any premises is appropriate and will not contravene the licensing objective of preventing public nuisance.

- Smoking areas. These should be designed to minimise public nuisance and regularly monitored to cut down on noise and litter.
- Noise from patrons entering and exiting the premises.

What the Board Will Do:

- Consider the proximity of proposed licensed premises to noise sensitive premises when considering applications.
- Ensure that licensed hours and activities are appropriate for the type of premises and locality. The terminal hours indicated in the Supplementary Policy on Licensed Hours are the maximum available and will not be suitable for all premises.
- Improve communication between the trade, partners and local communities.
- Impose additional licence conditions where appropriate to prevent public nuisance.
- Highlight best practice where available and increase awareness and education on potential areas of risk.

What the Board Will Expect of Licence Holders/Applicants:

- Take a proactive approach to public nuisance with a risk-based approach.
- Be mindful of the location of the premises, hours of operation and activities.
- Comply with all conditions of the premises licence.
- Ensure appropriate control measures are in place and staff training is up to date and relevant.
- Consider public nuisance when establishing the design and layout of the premises.
- Adequate supervision of any outdoor area, smoking area and patrons entering/exiting the premises.
- Sharing of best practice via trade groups.
- Participation in communication to resolve any issues that may arise.
- Co-operation with Police Scotland and Licensing Standards Officers including access to all relevant policies and procedures such as dispersal policies and incident management.

In the event the premises are not considered premises to which the Licensing Conditions (Late Opening Premises)(Scotland) Regulations 2007, Section 3(2) applies, I request the application be granted subject to the conditions specified within the Board's Statement of Licensing Policy in respect Door Stewards, Radiolink and CCTV remaining attached and Duty of Care being applied. I also request that a condition which states that a person who is the holder of a Personal

Licence under the Licensing (Scotland) Act 2005 is on duty for any time the premises operates after 0100 hours, is similarly applied.

The above application has been assessed by this Service in relation to any music noise breakout from amplified / non-amplified music played / performed at the premises. Consideration has been given to the risk of noise impact on local residences at the proposed times listed in the application.

As with any such matter it is naturally desirable to avoid a situation that would result in this Service serving formal notices to abate activities that have caused nuisance.

Having carefully considered the application I am not objecting to this application.

However, there is an expectation that management at the premises would establish and apply suitable and robust noise control measures associated with music noise to protect the amenity of local residents and <u>reduce the risk</u> of adverse noise impact constituting a statutory nuisance.

I would recommend these noise control measures are formalised in writing to demonstrate and convey to staff for training purposes the specific detail of the required noise controls. A copy of these noise control measures should be submitted to this Service for approval.
