Preventing Crime & Disorder

The Board is committed to improving the quality of life for the people of the city by adopting and enforcing policies designed to increase community safety and reduce the threats of crime and disorder.

In terms of this licensing objective the Board considers there to be a number of factors including, but not limited to:

- Underage drinking
- Drunkenness
- Illegal substances
- Violent behaviour
- Anti-social behaviour
- Vulnerability

In order to combat the risks inherent with the sale of alcohol the Board will seek to operate a partnership approach with licence holders, applicants and partner agencies.

What the Board Will Do:

- Apply appropriate conditions to licences to mitigate the risk of potential crime or disorder, including but not limited to a local condition on duty of care on all on-sales premises.
- Ensure all polices are up to date and fit for purpose.
- Work closely with all stakeholders to ensure all relevant information is kept up to date and accessible.
- Endorse initiatives designed to prevent crime and disorder.
- Consider the review of licences where a breach of the licensing objective cannot be rectified by other means.

What the Board Will Expect of Licence Holders

- Effective and responsible management of premises including evidence of written procedures for managing incidents.
- Up to date training and supervision of staff.
- Provision of effective CCTV in and around premises.
- Provision of external lighting and security measures.
- Employment of SIA registered door supervisors when appropriate.
- Use of radiolink or other such scheme.
- Adherence to the Board's Drugs Policy.
- Enforcement of Challenge 25.
- Adoption of best practice guidance where available.
- Evidence of a relevant dispersal policy where appropriate.
- Co-operation with police and Licensing Standards Officers.

What the Board Will Expect of Partner Agencies

- Provision of all relevant up to date information as the Board requires.
- Involvement in mediation/intervention procedures to rectify any problem areas
- Involvement in Premises Licence Review as a last resort.

Preventing Public Nuisance

The Board believes that licensed premises have the potential to have a significant impact on communities. It wishes to maintain and protect the amenity of the surrounding neighbourhoods whilst recognising the valuable cultural and social aspects of such premises.

Whilst licensing powers are not the main statutory mechanism for dealing with public nuisance in general the Board will interpret public nuisance in a wider sense where it relates to the operation of licensed premises, and in particular issues such as noise and litter.

Again, a number of factors should be considered including, but not limited to:

- Location of premises. In particular the proximity to residential or noise sensitive premises such as medical facilities, sheltered housing, schools, places of worship, nurseries and suchlike.
- Hours of operation. Closely related to the location of the premises, the hours
 of operation should reflect what is appropriate for the surrounding
 neighbourhood. The terminal hours indicated in the Supplementary Policy
 on Licensed Hours are the maximum available and will not be suitable for all
 premises.
- Nature of activities. Any activities carried on in the licensed premises should not be detrimental to the ambience of the locality.

- Outdoor areas. The Board will include a Supplementary Policy on this issue, but applicants will require to ensure that the inclusion of an outdoor licensed area in any premises is appropriate and will not contravene the licensing objective of preventing public nuisance.
- Smoking areas. These should be designed to minimise public nuisance and regularly monitored to cut down on noise and litter.
- Noise from patrons entering and exiting the premises.

What the Board Will Do:

- Consider the proximity of proposed licensed premises to noise sensitive premises when considering applications.
- Ensure that licensed hours and activities are appropriate for the type of premises and locality. The terminal hours indicated in the Supplementary Policy on Licensed Hours are the maximum available and will not be suitable for all premises.
- Improve communication between the trade, partners and local communities.
- Impose additional licence conditions where appropriate to prevent public nuisance.
- Highlight best practice where available and increase awareness and education on potential areas of risk.

What the Board Will Expect of Licence Holders/Applicants:

- Take a proactive approach to public nuisance with a risk-based approach.
- Be mindful of the location of the premises, hours of operation and activities.
- Comply with all conditions of the premises licence.
- Ensure appropriate control measures are in place and staff training is up to date and relevant.
- Consider public nuisance when establishing the design and layout of the premises.
- Adequate supervision of any outdoor area, smoking area and patrons entering/exiting the premises.
- Sharing of best practice via trade groups.
- Participation in communication to resolve any issues that may arise.
- Co-operation with Police Scotland and Licensing Standards Officers including access to all relevant policies and procedures such as dispersal policies and incident management.

The applicant seeks to extend the outside drinking area to provide an additional 10 tables, allowing capacity for approximately 60 more patrons. Given the increase in capacity and the close

proximity to residential properties, in respect of this additional area I recommend that should the Board be minded to grant this element of the variation, then the area be reduced in size to only include the area to the front of the premise and not the area to the east side of the building as indicated in the layout plan. I further recommend that conditions are attached providing a terminal hour of 2200 for both the existing and additional outside areas; that some form of physical barrier is used as a demarcation for the new area, similar to that already in existence; that no amplified music is played and that appropriate signage is displayed advising patrons that no alcohol is to be taken beyond the licensed area.

The above points were discussed with a representative of the applicant company, David McNair, who advised he would be agreeable to these recommendations.

<u>Supplementary Policy – Licensed Hours</u>

Whilst all applications will be dealt with on their own merits the Board considers it necessary for the promotion of the licensing objectives to set parameters with respect to licensed hours. Any application seeking hours outwith those detailed below will be expected to satisfy the Board that there are legitimate grounds for departing from policy and demonstrate that the granting of such hours would not be contrary to the licensing objectives.

Off-Sale Premises

Maximum trading hours for off-sale premises are set by statute. The Board have no power to grant off-sales hours prior to 1000 or after 2200 hours. It should be noted that these are the maximum permitted hours and the Board may restrict these hours if it can be shown to be necessary for the promotion of the licensing objectives.

On-Sale Premises

The Board considers it appropriate to distinguish hours within the city centre from outlying areas. The city centre area is that shown delineated on the undernoted map.

The hours stated below are the earliest acceptable opening hour and latest acceptable terminal hour, and not the maximum permissible hours. The terminal

hours stated below are the latest permissible and will not be appropriate for all premises. It will be the responsibility of the licence holder or applicant to demonstrate that the premises is suitable for the hours sought. Additional conditions will normally be added to all premises seeking licensed hours after 1am including but not limited to CCTV, door stewards and radiolink. A link to examples of the standard local conditions can be found in the Supplementary Policy on General Licensing Matters.

The Board considers 15 hours continuous trading to be reasonable within any 24hour period and so the opening or terminal hour should be adjusted accordingly to comply with this requirement.

Whilst all applications will be dealt with on their own merits the Board considers it necessary for the promotion of the licensing objectives to set parameters with respect to licensed hours. Any application seeking hours outwith those detailed below will be expected to satisfy the Board that there are legitimate grounds for departing from policy and demonstrate that the granting of such hours would not be contrary to the licensing objectives.

In addition, the application seeks to offer the provision of the delivery of alcohol. I request that should the Board be minded to grant this element of the variation, consideration be given to attaching a condition that the licence holder will ensure that adequate training, particularly in respect of Challenge 25, is in place for persons delivering alcohol. Should such delivery be contracted to a third party, I recommend that the licence holder is satisfied that the contracted party has such measures in place.

In respect of point 8, the variation seeks to amend the terms, times and parts in which children and young persons are permitted access.

The variation requested consists of the following requests, namely:

- 1. Amending Q5 to include the provision of restaurant facilities, films and outdoor drinking during core hours but no late than 2200;
- Amend the terms within Q6 to indicate that Children and Young Persons are permitted access for the purposes of a reception or show, in addition to consuming a meal;
- 3. Amend the times within Q6 to state Young Persons are permitted until 2100 hours, thereafter until 0100 hours for the purposes of having a meal or attending a show.
- 4. Amend the layout plan and capacity of the premises.

In terms of Section 29(5) of the Act this request can be considered a variation.

In terms of Section 22(1)(b)(ii) and (iii) of the same Act, I make the following representation.

In relation to the outdoor drinking aspect of the application and in support of the Preventing Crime and Disorder licensing objective, it is my recommendation that the outdoor area is subject to delineation by way of a physical barrier.

In addition, the wording within the operating plan at Q5 be amended to take into account the intended use of the area prior to core hours.

In relation to Q6 on the operating plan, the premises currently allows access to Children and Young Persons until 2100 hours, for the purposes of consuming a meal and children must be accompanied by an adult.

The application in its current form seeks to amend this to allow Children and Young Persons on the premises for the purposes of 'attending a show or reception' in addition to consuming a meal. Young Persons would also have accompanied access from 2100-0100 hours under the same terms.

A member of North East Division Licensing Team spoke with the Designated Premises Manager regarding the requested changes and it was established that what is meant by 'a show or reception' would include a show or reception held elsewhere, i.e. the theatre. This element should be clarified as I am of the view a show taking place elsewhere would not justify such terms of access.

The premises currently comprises two areas under the same licence. It is our understanding that the upper floor area of the premises will be a food led area until 2100 hours, thereafter this would become a bar type environment, which, if the variation in its current form is granted, would allow access by young persons until 0100 hours.

It is also our understanding that the lower ground floor area is to be used for private functions, meals and other performance-related activities.

Having regard for the Protecting Children and Young Persons from Harm licensing objective and how the premises intends to operate, I recommend that the wording within the existing operating plan remains, however additional wording is added to reflect that young persons will be permitted unaccompanied access within the lower ground floor until 2300 hours, for the purpose of attending or participating in an age appropriate performance or show. If the lower ground floor is being used for a private, pre-booked function, children are permitted access until the terminal hour, when accompanied by a responsible adult aged 18 years or over.

Again, a number of factors should be considered including, but not limited to:

- Location of premises. In particular the proximity to residential or noise sensitive premises such as medical facilities, sheltered housing, schools, places of worship, nurseries and suchlike.
- Hours of operation. Closely related to the location of the premises, the hours
 of operation should reflect what is appropriate for the surrounding
 neighbourhood. The terminal hours indicated in the Supplementary Policy
 on Licensed Hours are the maximum available and will not be suitable for all
 premises.

What the Board Will Expect of Licence Holders/Applicants:

- Take a proactive approach to public nuisance with a risk-based approach.
- Be mindful of the location of the premises, hours of operation and activities.
- Comply with all conditions of the premises licence.
- Ensure appropriate control measures are in place and staff training is up to date and relevant.
- Consider public nuisance when establishing the design and layout of the premises.
- Adequate supervision of any outdoor area, smoking area and patrons entering/exiting the premises.
- Sharing of best practice via trade groups.
- Participation in communication to resolve any issues that may arise.
- Co-operation with Police Scotland and Licensing Standards Officers including access to all relevant policies and procedures such as dispersal policies and incident management.

Following this visit, it was established that there is a pathway named 'Blackburn Lane' that runs along the side of the premises, affording access to the side entrance/exit of the premises and the proposed outdoor drinking area. Within this lane there is a residential property, which is in close proximity to the point at which patrons would exit the premises to access the outdoor area.

It is my recommendation that in support of the Preventing Crime and Disorder and Preventing Public Nuisance licensing objectives that the area is subject to a terminal hour of 2200 hours, as per the Board policy and that the shared lane is delineated (as per the 'red line' on the layout plan) by way of a physical barrier which would deter patrons leaving the licensed area in possession of alcohol and ensures the neighbouring property remains unaffected by the traffic of patrons who are accessing the outdoor area.

Dear members of the Licensing Board,

We would hereby like object to the application for variation of a premises license submitted by Two Ten Bistro (Aberdeen) Ltd, as per the reference number above. Specifically, we only object to the last point – to permit live music and televised sport. We believe granting this request would lead to the exacerbation of already existing issues for us as the direct neighbours of the Bistro and residents of the area to an unacceptable level by causing the following:

- Public nuisance both live music and televised sport would cause intolerable levels of noise at late hours, resulting both from the event itself and from the increased number of inebriated customers, who gather on the pavement directly outside the Bistro and to the side of the building adjacent to the back lane in order to smoke. This would result in increased litter (i.e. cigarette butts) in the area. It would also result in increased amounts of glass waste, which is already causing a problem, as there is often smashed glass on the pavement directly in front of the Bistro's entrance, as well as at the side of the building, where the glass bin is located. Regarding increased levels of noise, the staff already on occasion empty their glass waste into the glass bin late at night (i.e. after 11pm), which causes significant noise. Further noise is caused by the Bistro's freezer fan, which is located on the outside of the building in the back lane (close to our windows). We already cannot open our windows at night due to the amount of noise; we are afraid that permitting live music and televised sport would only increase the noise levels. We have also witnessed that unfortunately sometimes the Bistro's customers use the back lane to urinate.
- Furthermore, there is the matter of public safety. As already mentioned, customers who gather at the Bistro's front door block a narrow pavement, made narrower by the Bistro's advertising boards, and there is a danger of pedestrians being forced into the road.

As someone who has two jobs with irregular hours and working six days a week, it is important to be able to have a good night's sleep and I am concerned that granting the Bistro's live music and televised sport would lead to the exacerbation of all of the issues described above.

Supplementary Policy – Licensed Hours

Whilst all applications will be dealt with on their own merits the Board considers it necessary for the promotion of the licensing objectives to set parameters with respect to licensed hours. Any application seeking hours outwith those detailed below will be expected to satisfy the Board that there are legitimate grounds for departing from policy and demonstrate that the granting of such hours would not be contrary to the licensing objectives.

Off-Sale Premises

Maximum trading hours for off-sale premises are set by statute. The Board have no power to grant off-sales hours prior to 1000 or after 2200 hours. It should be noted that these are the maximum permitted hours and the Board may restrict these hours if it can be shown to be necessary for the promotion of the licensing objectives.

On-Sale Premises

The Board considers it appropriate to distinguish hours within the city centre from outlying areas. The city centre area is that shown delineated on the undernoted map.

The hours stated below are the earliest acceptable opening hour and latest acceptable terminal hour, and not the maximum permissible hours. The terminal hours stated below are the latest permissible and will not be appropriate for all premises. It will be the responsibility of the licence holder or applicant to demonstrate that the premises is suitable for the hours sought. Additional conditions will normally be added to all premises seeking licensed hours after 1am including but not limited to CCTV, door stewards and radiolink. A link to examples of the standard local conditions can be found in the Supplementary Policy on General Licensing Matters.

The Board considers 15 hours continuous trading to be reasonable within any 24-hour period and so the opening or terminal hour should be adjusted accordingly to comply with this requirement.

The opening hours for casinos remains in line with the statutory hours in terms of the Gambling Act 2005, namely 1200 – 0600 daily.

I would like to express my objection to the above mentioned application for Variation of premises.

As my husband and I regularly work on Saturdays and sometimes Sundays we already have problems getting a decent rest when the bar is open and plays loud music until midnight. Especially since their patrons usually linger in the street after closing hours until much later, engaging in shouting matches. Allowing the bar to leave their door open even longer will mean that we have to listen to their music longer – we can actually hear every song, including karaoke, and feel the bass in our flat, despite there being one floor of flats in between the bar and us during peak hours – which will in the end keep us awake until 2-3am. This would be bad enough if we didn't have to work.

Due to drunken behaviour by the bar's patrons during all hours we already have to keep our doorbell unplugged. Otherwise we do get disturbed a lot by them ringing our bell continuously. Also, they do leave empty bottles and cigarettes in our door way. While the bar was refurbished, this litter had almost stopped completely. Now that it reopened it is back. With longer opening hours and possibly a higher intoxication level of people who frequent the bar, I am afraid this, and the attempts of breaking down the front door, will only increase.

As much as I am all for a lively bar scene in town, I cannot approve of longer opening hours or the addition of dance facilities to Victoria Bar.

CHIEF CONSTABLE'S REPORT TO THE ABERDEEN CITY LICENSING BOARD FOR THE PERIOD 1ST APRIL 2018 to 31ST MARCH 2019

Foreword

It gives me great pleasure to provide the Annual Licensing Report for 2018/19, in accordance with Section 12(A) Licensing (Scotland) Act 2005. During this year the Minimum Unit Pricing of Alcohol was introduced in Scotland. We will work through the Evaluation Advisory Group to assess the impact of this legislation.

Working in partnership is key to effective regulation in liquor licensing. Police Scotland remains committed to working closely with partners in the 32 Local Authorities across Scotland to ensure a fair and consistent approach. Preventing alcohol fuelled violence, disorder and antisocial behaviour is a priority and I believe that working together to achieve effective early intervention and enforcement is vital to this.

I would like to acknowledge the many active local partnerships that provide continued support, enabling Police Scotland and partners to drive improvement in licensing. I will ensure that all officers and staff continue to recognise the importance of working closely with key partners, including the Licensed Trade, to improve licensing standards nationally utilising the range of options available to them.

I am confident that through strong partnerships and collaborative working, we will meet any challenges that may arise and will continue to improve licensing standards for the communities of Scotland.

Police Scotland Licensing Overview

The Violence Prevention and Licensing Co-ordination Unit (VPLCU) sits within Safer Communities based at Dalmarnock Police Station, Glasgow.

The VPLCU upholds the two tier structure for licensing which supports both national and local priorities through service delivery. They have overall responsibility for determining and delivering national licensing strategy and policy, by providing advice, guidance and support to divisional licensing teams as well as undertaking other specialist functions.

The Violence Prevention and Licensing Co-ordination Unit is a specialist department which consists of a small team of officers, based in Glasgow. The officers within the unit work with divisional licensing teams and partner agencies to help shape policy and strategy around the police licensing function. They provide practical and tactical advice to police licensing practitioners, operational officers, supervisors and policing commanders.

The VPLCU seek to ensure that legislation governing the sale and supply of alcohol is applied consistently across the country and all opportunities are taken to stop the illegal or irresponsible sale, supply or consumption of alcohol with the intention of preventing and reducing crime and disorder.

During 2018/2019, from a licensing perspective, our particular focus will be on the following;

- Scrutiny of the serious incidents of violence, disorder and antisocial behaviour linked to licensed premises.
- Continuous professional development training and guidance for staff to harmonise licensing practice across the country.
- Working closely with statutory partners within a National Licensing Trade Forum to identify licensing related issues and prevent/reduce associated crimes.
- Governance and ongoing development of the National ICT Licensing System, known as "Inn Keeper", to increase the efficiency and effectiveness of liquor and civic licensing administration and management.
- The implementation and ongoing development of the Licensing Admin tool
 provides divisional licensing officers with a single ICT product negating the
 need to research police systems independently. Through accurate recording,
 the licensing admin tool assists Police Scotland in deploying our resources to
 the right places and the right time to keep people safe.

Each of the 13 Local Policing Divisions have a licensing team responsible for the day to day management of licensing administration, complying with statutory requirements as well as addressing any issues that may arise within licensed premises in their local area.

LICENSING BOARD AREA

The Aberdeen City Licensing Board area is policed by North East Division.

Chief Superintendent Campbell Thomson is the Local Police Commander who has the responsibility for all day-to-day policing functions.

Local Policing Priorities

Following our public consultation process, the policing priorities for North East Division, as set out in our Local Policing Plans are as follows:

- Anti-social Behaviour, Violence and Disorder;
- Acquisitive Crime;
- Road Safety and Road Crime;
- Protecting People at Risk of Harm;
- Serious Organised Crime;
- Counter Terrorism and Domestic Extremism.

The North East Division Licensing Team is located across the division in Aberdeen, Inverurie, Elgin and Stonehaven. All staff have a division wide remit and a working knowledge of all the areas covered.

The North East Division Licensing Team, supported by Community Policing Officers, has promoted the Police Service of Scotland's force priorities alongside the five licensing objectives, the overarching principles and aims of the Licensing (Scotland) Act 2005.

In the reporting period, as statutory consultees, the team responded to the Board regarding 351 applications for occasional licences or extended hours, 7 premises or provisional premises applications, 391 personal licence applications and 128 premises variations or premises licence transfer applications.

Where any query arises from any such application, a member of the team will seek to discuss the application with the applicant, or the applicant's agent, to ensure that responses to the Board by means of representation or objection are considered, reasonable and proportionate.

The team enjoys a strong working relationship with the Local Authority Licensing Standards Officers. Both teams meet on a regular basis to share information and regularly conduct joint visits to licensed premises, on both a pro-active and reactive basis.

The North East Division Licensing Team is represented on the Local Licensing Forum and Aberdeen Alcohol and Drugs Partnership and works alongside the following groups and organisations to jointly improve local licensing issues:

• Unight;

- Weekend Partnership;
- · Community Safety Partnership;
- Local Pubwatch initiatives;
- Local Security Industry companies;
- Best Bar None:
- Street Pastors;
- Alcohol and Drugs Partnership.

Reviewing incidents on, or connected to, licensed premises is a key part of our day-to-day business.

Community based Police Officers are encouraged and expected to routinely visit licensed premises within their area. Aberdeen city centre benefits from a dedicated Weekend Policing Plan to support the night time economy.

Within the reporting period, there were 3077 inspections (visits) to licensed premises within Aberdeen recorded on the InnKeeper system.

Any Police Officer who attends an incident at a licensed premises is expected to submit a concise report via the InnKeeper system, particularly when the incident involves violence, disorder, anti-social behaviour, drunkenness, drug misuse, underage drinking, breaches of licensing legislation or any other matter that might impact on public safety.

Within the reporting period, there were 775 incidents connected to licensed premises within Aberdeen recorded on the InnKeeper system. This is a significant reduction from 1058 the previous reporting year and we view this positively.

The information obtained may show a causal link between the operation of the premises and the incident. An incremental intervention process allows for issues to be addressed quickly and effectively at an early stage. This includes a low level 'interaction' which may involve a discussion between the Police and the premises management and/or licence holder. The level of engagement from within the Aberdeen licensed trade is very good and in many instances, this approach reduces recurrence or escalation.

Premises may become 'monitored' with closer attention being paid to any incidents occurring there. This is often undertaken in conjunction with tasked, supportive visits to the premises by uniformed Police Officers.

However, where necessary, the staged process allows for more formal intervention to support premises where the need for support has been identified. A premises licence holder and the premises management may be asked to meet with the Police, when concerns will be discussed. This will often involve an agreed action plan being put in place, with a reasonable time scale for completion.

The most common example of an agreed 'action' is refresher training of staff covering their responsibilities including the sale of alcohol to underage or intoxicated persons, 'Challenge 25' and the general terms and conditions of the licence held.

Should the intervention stage not bring about the necessary changes, or be otherwise unsuccessful, the next stage is the submission of a premises licence review application for the consideration of the Licensing Board.

Over the reporting period there have been three licensed premises in Aberdeen subject to a period of monitoring or intervention, a reduction from eight the previous year. Of these, all were late opening venues. The issues that were addressed related either to significantly high incidences of violence on the premises or perceived management shortcomings following serious incidents.

Partnership working between the Police, the Licensing Standards Officers and the premises licence holders and premises' management teams continues to hopefully fully resolve the issues and prevent bringing the matters to the Licensing Board by premises licence review application.

In the reporting period there were no premises licence review applications submitted to the Board and one Closure Order application was submitted.

The North East Division Licensing Team also has a system in place which monitors certain conduct of Personal Licence holders. Should such a licence holder be charged with any offence, this is brought to the attention of the team. Should the circumstances appear to be inconsistent with any of the five licensing objectives, consideration will be given to bringing this to the attention of the Board by way of a personal licence review. In addition, should an individual be convicted of a relevant offence, this will undergo the same scrutiny.

During the reporting period the North East Division Licensing Team was actively engaged in the consultation process for the Boards' new Statement of Licensing Policy.

We are very pleased to see the inclusion into the new Statement of Licensing Policy of a condition relating to vulnerability through intoxication training and a duty of care policy, following a request for this measure by the North East Division Licensing Team. The team will continue to work alongside the LSOs to assist premises complying with this new condition.

The team will be happy to report back to Board at any stage in the future any impact on policing which may relate to any change in the Board's policy.

PREVENTING THE SALE OR SUPPLY OF ALCOHOL TO CHILDREN OR YOUNG PEOPLE

Aberdeen City attracts a relatively low number of reports of underage drinking or youth congregation involving alcohol when considering other towns and cities across Scotland.

Where a person under 18 years of age is found to be either under the influence of alcohol, drinking alcohol in a public place or in possession of alcohol, the Police Officer involved will take all appropriate steps to ascertain the source of the alcohol.

Where information that cannot be fully evidenced is received regarding the sale of alcohol to children and young persons, in accordance with the national guidance contained within the 'Alcohol Toolkit', letters will be sent to licensed premises in the area reminding them of their responsibilities and requesting extra vigilance.

If such concerns were to continue in respect of specific premises, then other operational strategies would be considered.

One way in which North East Division delivers our commitment to the community is through our School Liaison Officers and School Based Officers. These Officers attend schools and other educational establishments seeking to equip our young people with the appropriate information and understanding that will allow them to make better informed decisions in key areas of their lives, both now and in the future. To this end they deliver lessons, linked to the Curriculum for Excellence, on a range of subjects including alcohol, controlled drugs and anti-social behaviour — particularly alcohol fuelled anti-social behaviour and the potential for related safety issues and consequences.

During the reporting period, the team was actively engaged in promoting the national 'You're Asking for It' campaign aimed at deterring proxy sales of alcohol for supply to children and young persons.

In support to the Protection of Children from Harm licensing objective, applications for premises licences and variations to premises licences come under close scrutiny often resulting in the submission of letters of objection, or more commonly, of representation, in which the imposition of conditions in respect of on sales, with regard to the times and terms in which children can be on such premises, will be recommended by the Chief Constable.

TACKLING SERIOUS AND ORGANISED CRIME

Many of the processes and procedures involved in licensing applications are carried out to guard against Serious Organised Crime Groups (SOCG) infiltrating the licensed trade in any way. This scrutiny is further enhanced with the nation-wide InnKeeper system. This database contains details of all liquor and civic licences for every Division in Scotland, and enhances our information sharing in respect of premises and people in the licensed trade as they move about the country and work in multiple venues.

If such an SOCG were able to gain a foothold in licensed premises this would afford the criminal group a seemingly legitimate income stream, which could be no more than a veneer for other criminal activities such as money laundering, tax evasion, drug and people trafficking and other dishonest activities.

Many of the procedures currently carried out by the North East Divisional Licensing Team, particularly in relation to new premises licences and the transfer of premises

licences are done to ensure complete financial transparency and to ensure there are no business related irregularities which may be indicative of SOCG involvement.

Frequent and directed Police attendance and contact with licensed premises also increases the opportunity for irregularities to be identified or reported.

As part of this, the North East Division Licensing Team regularly liaise with Police Interventions staff who are aware of SOCG activity within the Division to ensure that applicants are not affiliated in any way to such groups, before responding to the Licensing Board.

The consistent high profile approach and interaction with licensed premises in direct correlation with the aforementioned close scrutiny in the application process should reinforce the work carried out to maintain this position.

PROPOSED ACTIVITY FOR THE YEAR AHEAD

Over the forthcoming year, North East Division Licensing Team, in conjunction with Community Policing Teams, will work alongside licensed premises, to ensure that these premises are adhering to the spirit of the legislation and operate in a manner that supports the five licensing objectives. We aspire to maintain our number of supportive visits to licensed premises and hope to see a continued reduction in the number of incidents taking place on licensed premises.

It is intended that our involvement and participation in public safety campaigns will continue, such as the 'Ask for Angela' personal safety campaign and the 'One Punch' campaign which highlights consequences for both victims and perpetrators of spontaneous acts of violence.

Working with established partnerships but particularly with the licensed trade, we hope to continue to see a reduction in alcohol-related crime, particularly violence, whether perpetrated within licensed premises, public places or private spaces.

To conclude we would like to thank you for your continued support and stress the importance of this collaborative problem solving approach. This ensures that police, licence holders and licensed premises staff have a better understanding of their responsibilities. We look forward to furthering this partnership over the coming year.
