DECLARATIONS OF INTEREST

You must consider at the earliest stage possible whether you have an interest to declare in relation to any matter which is to be considered. You should consider whether reports for meetings raise any issue of declaration of interest. Your declaration of interest must be made under the standing item on the agenda, however if you do identify the need for a declaration of interest only when a particular matter is being discussed then you must declare the interest as soon as you realise it is necessary. The following wording may be helpful for you in making your declaration.

I declare an interest in item (x) for the following reasons

For example, I know the applicant / I am a member of the Board of X / I am employed by... and I will therefore withdraw from the meeting room during any discussion and voting on that item.

OR

I have considered whether I require to declare an interest in item (x) for the following reasons however, having applied the objective test, I consider that my interest is so remote / insignificant that it does not require me to remove myself from consideration of the item.

OR

I declare an interest in item (x) for the following reasons however I consider that a specific exclusion applies as my interest is as a member of xxxx, which is

- (a) a devolved public body as defined in Schedule 3 to the Act;
- (b) a public body established by enactment or in pursuance of statutory powers or by the authority of statute or a statutory scheme;
- (c) a body with whom there is in force an agreement which has been made in pursuance of Section 19 of the Enterprise and New Towns (Scotland) Act 1990 by Scottish Enterprise or Highlands and Islands Enterprise for the discharge by that body of any of the functions of Scottish Enterprise or, as the case may be, Highlands and Islands Enterprise; or
- (d) a body being a company:
 - i. established wholly or mainly for the purpose of providing services to the Councillor's local authority; and
 - ii. which has entered into a contractual arrangement with that local authority for the supply of goods and/or services to that local authority.

OR

I declare an interest in item (x) for the following reasons.....and although the body is covered by a specific exclusion, the matter before the Committee is one that is quasi-judicial / regulatory in nature where the body I am a member of:

- is applying for a licence, a consent or an approval
- is making an objection or representation
- has a material interest concerning a licence consent or approval

•	is the subject of a statutory order of a regulatory nature made or proposed to be made by the local authority and I will therefore withdraw from the meeting room during any discussion and voting on that item.

1. The Convener proposed that the Sub Committee consider item 5.1 (Pittodrie Capacity Exemption Application - Exempt Appendices) with the press and public excluded from the meeting.

The Sub Committee resolved:-

PITTODRIE CAPACITY EXEMPTION APPLICATION - COM/21/164

3. The Sub Committee had before it a report by the Director of Commissioning, which sought the determination of an application received from Aberdeen Football Club to increase the capacity of Pittodrie Stadium more than the capacity limits contained in the COVID Protection Levels.

The report recommended:-

that the Sub Committee:-

- (a) note the content of the report;
- (b) approve the application received from Aberdeen Football Club for 5,665 supporters; and
- (c) if minded to approve the application, to instruct the Chief Officer Governance to amend the Safety Certificate for Pittodrie Stadium as appropriate.

Councillor Delaney moved as an amendment:-

that the Sub Committee note the report, but to refuse the application received from Aberdeen Football Club for 5,665 supporters due to public health concerns.

Councillor Delaney's amendment however was not seconded, therefore in terms of Standing Order 29.12, the amendment fell.

The Sub Committee resolved:-

- (i) to approve the recommendations contained within the report; and
- (ii) to request Aberdeen Football Club to make paper copies of the code of conduct available to attendees without computer/internet access.
