## PRIMARY CARE UPDATE

**4.** The Board had before it a report from Sandra MacLeod, Chief Officer, regarding Carden Medical Centre – Options Appraisal and Recommendations.

UB Members asked a wide range of questions and scrutinised the transition plans in order to provide assurance from a patient safety perspective.

# The report recommended:-

- (a) agree the recommended option to stop delivering General Medical Services at Carden Medical Centre by 1 February 2022;

- (c) instruct the Chief Officer to implement the above recommendations with immediate effect;
- (d) make the direction (as per Appendix C) to NHS Grampian and instruct the Chief Officer to issue the Direction to NHS Grampian; and
- (e) receive an update on progress at the meeting of JB on 25 January 2022.
