LICENSING (SCOTLAND) ACT 2005 APPLICATION FOR THE VARIATION OF A PREMISES LICENCE BUCKIE FARM, THE PARKWAY, DANESTONE, ABERDEEN, AB22 8AL

I refer to the above application for the variation of a premises licence under terms of Section 29(5) of the Licensing (Scotland) Act 2005.

The variation requested consists of the following, namely:

- 1. Amend Q.1 to include both 'on sales' and 'off sales' within the Operating Plan:
- 2. Amend Q.2 in respect of core 'on sales' hours from 1000 to 0000 hours to 1000 to 0100 hours on Friday and Saturday;
- 3. Amend Q.3 in respect of core 'off sales' operating hours to 1000 to 2200 hours daily;
- 4. Amend Q.5(d) to include outdoor drinking facilities as described in layout plan;
- 5. Amend Q.5(f) to include takeaways and home deliveries;
- Amend Q.6 with the wording provided in respect of the terms, ages, times and parts of premises for which children and young persons have access;
- 7. Amend Q.7 to show an increased capacity from 675 to 689 to accommodate the proposed permanent outdoor drinking facilities.

In terms of Section 29(5) this request can be considered a variation.

In terms of points 1, 2, 3, 6 and 7 above I have no adverse comment to make regarding the variation proposed.

In terms of Section 22(1)(b)(ii) and (iii) of the Licensing (Scotland) Act 2005, I make the following representation.

In respect of point 4, I recommend that the outdoor drinking facilities are subject to the following conditions:

- 1. The areas are delineated by a physical barrier or similar;
- 2. The areas are subject to a terminal hour of 2200 hours daily;
- 3. Signage to be displayed indicating that no alcohol is to be removed beyond the delineated areas:
- 4. Children and young persons to be accompanied by a responsible person aged 18 years or over;
- 5. No amplified music to be played within.

In respect of point 5, the addition of home deliveries, I recommend that there is a recorded age verification system in place in respect of remote/online sales and that 'Challenge 25' is carried out at any point of collection or delivery of alcohol.

This response is subject to government guidance or measures in place at the time of the event, in respect of COVID-19.
