1. PURPOSE OF REPORT

1.1 To seek appointments or nominations (as appropriate) to various outside bodies; to seek appointments for Convener and Vice Convener of the Urgent Business Committee; and to note the appointments of the Convener and Vice Convener of the Audit, Risk and Scrutiny Committee.

2. **RECOMMENDATIONS**

That the Council:-

- 2.1 appoint a Convener and Vice Convener of the Urgent Business Committee;
- 2.2 note the appointment of Councillors Macdonald and Houghton as Convener and Vice Convener respectively of the Audit, Risk and Scrutiny Committee, and agree that their remuneration as Senior Councillors be backdated to 18 May 2022;
- 2.3 consider the appointment or nomination (as appropriate) of members to the outside bodies listed in Appendix A, and appoint or nominate members on the basis that names can be provided to the Chief Officer Governance after the meeting and that he be authorised to finalise the appointments, nominations and memberships where required; and
- 2.4 note that Robert Gordon's College Board of Governors and Enterprise North East Trust Limited (trading as Elevator) no longer require elected member representation from Aberdeen City Council.

3. CURRENT SITUATION

3.1 **Conveners and Vice Conveners**

- 3.1.1 At the Statutory Council meeting on 18 May 2022, a number of appointments were made with regard to Conveners and Vice Conveners of the relevant committees. However, a Convener and Vice Convener for the Urgent Business Committee still require to be appointed, and the Council is recommended to make these appointments.
- 3.1.2 Standing Order 2.7 stipulates that the Convener and Vice Convener of the Audit, Risk and Scrutiny Committee must be members of the opposition. Following the Statutory Council meeting, Councillors Macdonald and Houghton confirmed that they would be Convener and Vice Convener respectively of the Audit, Risk and Scrutiny Committee. The Council is therefore recommended to note these appointments and agree that their remuneration as Senior Councillors be backdated to 18 May 2022.

3.2 **Outside Bodies**

- 3.2.1 The Council is requested to consider making appointments or nominations (as appropriate) to the various outside bodies listed within Appendix A, noting that other outside body appointments or nominations were dealt with at the Statutory Council meeting on 18 May 2022. An appointment or nomination is described as mandatory where it is either a statutory requirement or a requirement of the relevant governance documentation, for example Trust Deed. Appointments/nominations described as discretionary do not carry the same stipulation.
- 3.2.2 A review of outside bodies was undertaken in 2017 which resulted in a number of outside bodies being removed from the list of bodies that the Council appoints or nominates to. A further review was undertaken in 2021 and reported to Council in December 2021, alongside the updated policy which set the criteria on which Aberdeen City Council will appoint or nominate Elected Members to Outside Bodies, as well as guidance on Elected Members' roles and responsibilities once appointed; and this policy was approved.
- 3.2.3 The Council has previously appointed members to Robert Gordon's College Board of Governors and Enterprise North East Trust Limited (trading as Elevator), however following a review of their governance arrangements, both organisations have advised that they no longer require elected member representation from Aberdeen City Council.
- 3.2.4 The Council has previously appointed two elected members to Aberdeen Science Centre, however following a review of their governance arrangements, representatives of Aberdeen Science Centre have advised that they now require one elected member appointment only.
- 3.2.5 The Council has previously nominated 3 elected members to be appointed as Directors of Sport Aberdeen, however Sport Aberdeen has indicated a desire

to reduce the number of elected members appointed to the Board to further increase the field of potential candidates that meet the organisation's role specification for Directors. Accordingly, Sport Aberdeen are proposing that the Council co-opt one elected member to the Board. This would allow the elected member to have an active involvement on the Board, contributing to all aspects of business without the requirement to meet the duties and responsibilities of being a Company Director.

3.3 **Possible Compositions**

3.3.1 The table below provides examples of potential compositions for the Council's appointments or nominations to outside bodies. This is not an exact exercise in proportionality because of the varying numbers of members on each body. This report treats each body individually and the principles agreed by the Council would be applied to each group on an individual basis.
