UPDATE:

On 22 February 2022, officers were instructed to response to provide a Service Update within two committee cycles outlining progress made with reconciling items recorded as 'missing' from the collections at Aberdeen Art Gallery and Museums service (COM/22/028).

1. Summary

Since February 2022, the items recorded as missing has reduced by 93. Tables 1 and 2 below summarise the progress made to date.

Officers have focussed on physical audits of the stored collection, reviewing every item in specific locations (progress as in Tables 2.1 and 2.3).

19,262 of 150,000 items in the collection have been physically checked in stores over 30 weeks and 93 items previously recorded as missing have had their status updated. The number of items updated reflects the requirement for thorough, detailed checks and verification.

Since July 2021, a total of 339 items previously recorded as missing have been resolved, which include the 93 items since February 2022.

The status of 93 items previously recorded as missing is now resolved as follows:

- 86 items have been found and their status and location have been updated.
- Six items have been confirmed as having been recorded incorrectly and were duplicate records for objects already in the collection.
- One item has been confirmed as removed from our records and disposed of, likely due to earlier irreparable damage before digital records began.

As detailed in the report to Committee in February 2022, 92 items were lost through theft and are highly unlikely to be recovered.

2. Review of progress

The Committee was provided with a work programme to undertake the reconciliation of missing items (Appendix 6 of COM/22/028). To date, officers have reviewed and checked the location of approximately 19,000 items. Progress is broadly as planned and more information is provided in tables 2.1 - 2.3 below.

The Committee noted the resource implications of accelerating the work required for the audits and the potential to lever in any additional funding to support this work. Additional support has been available through the Department for Work & Pensions Kickstart and Long-term Unemployed six-month intern schemes delivered by the Council. As these temporary positions come to an end, officers will seek funding to secure further additional resources.

Work to catalogue the institutional paper archive has been brought forward, and the physical audit of the collection continues. Both activities will assist in reconciling the remaining historical losses and missing items, or will confirm their status as no longer in the collection due to disposal, theft or transfer to another organisation.

Progress in identifying missing items is slow but steady, and highly variable:

- Where an item is found, and the location has been misrecorded, the record is updated. Once identified through audit, resolution is swift.
- Where an item is found disassociated from its identification number or with the number partly obscured, research and review of historic documentation is required to confirm that an object record matches the object with no identification number. Where this cannot be done with a high level of certainty, the object is set aside until further research can be undertaken. This can often occur if the record of an object is sparse: such as "vase" instead of "earthenware ceramic, bulbous yellow vase, with incised decoration". Once identified through audit, resolution is variable depending on information held.
- Where an item is recorded as an historic loss, extensive research is required to discover the whereabouts of the item, and prove ownership still resides with Aberdeen City Council. Satisfactory resolution may not be possible.
- Where an item is identified as being stolen, officers will update
 existing records on the Art Loss Register and continue to check
 auction catalogues in case items find their way back to the open
 market. The status of an item will be viewed as resolved if its
 status is confirmed as stolen.

To aid with the resolution of historic losses and items lost due to theft, officers have published digital "packages" of items missing in these categories.

Officers expect all collection records to be published by the end of December 2022 with a clear indication of their current status in the collection.

Officers will also participate in an Internal Audit review of collection management processes in October 2022 led by Chief Internal Auditor.
