Even without being disorderly, inebriated people can be very loud and disturb sleep.
-	Protecti	ing and improving public health	Two of the bedrooms in my house face directly on to Nox nightclub, less than 20 yards away, and when the venue is ppen, are unable to be used because of excessive noise generated by large queues, well in excess of 100 people, from around 2200-2430 and again when exiting the premises. BSS 8233:2014 recommends that ambient noise levels for bedrooms does not exceed 30dB from 2300 to 0700. I have made measurements myself with a dB meter in excess of 60dB during these hours, at double the acceptable level. It is totally unacceptable that they are seeking to extend this from the current 2-3 to 7 days a week. Expansion of the night time economy should not come at the expense of affecting people's health and well-being. There are other adjacent venues all looking to extend licensing that are totally incompatible with residential areas, making life intolerable in our residential area.
