If, after consideration of the representation/objection, the Committee is minded to grant the Short Term Let licence, it may do so under delegated powers since at the time of drafting this information note, the necessary certification has not been completed.

#### DESCRIPTION

The property at 30 Albury Road, Aberdeen, is the subject of this new Short Term Let licence application and its accommodation comprises of a Ground Floor, flatted property, providing accommodation of 2 letting bedrooms, kitchen, lounge, and shower room. The applicant wishes to accommodate a maximum of 4 guests, which is acceptable in terms of space and layout. The location of the premises is shown on the plan attached as Appendix A.

Short term lets - licensing scheme part 2: supplementary guidance for licensing authorities, letting agencies and platforms

#### **GROUNDS FOR REFUSAL**

This application is being dealt with under the provisions of '<u>Civic Government</u> (Scotland) Act 1982 (Licensing of Short Term Lets) Order 2022' (the 2022 Order)

Available grounds of refusal are as follows:

A licensing authority shall refuse an application to grant or renew a licence if, in their opinion-

(a)the applicant or, where the applicant is not a natural person, any director of it or partner in it or any other person responsible for its management, is either—

(i) for the time being disqualified under section 7(6) of this Act, or

(ii)not a fit and proper person to be the holder of the licence;

(b)the activity to which it relates would be managed by or carried on for the benefit of a person, other than the applicant, who would be refused the grant or renewal of such a licence if he made the application himself;

(c)where the licence applied for relates to an activity consisting of or including the use of premises or a vehicle or vessel, those premises are not or, as the case may be, that vehicle or vessel is not suitable or convenient for the conduct of the activity having regard to—

(i)the location, character or condition of the premises or the character or condition of the vehicle or vessel;

(ii)the nature and extent of the proposed activity;

(iii)the kind of persons likely to be in the premises, vehicle or vessel;

(iv)the possibility of undue public nuisance; or

(v)public order or public safety; or

(d)there is other good reason for refusing the application;

- Landlord Registration is not a requirement of Short Term Let licensing.
- The Council's Community Safety Team has 2 records of noise complaints in respect of 30 Albury Road, Aberdeen:

9th May 2023 - Loud music and shouting reported.06 August 2023 - Loud music reported along with the smell of drugs.

- There no Granted Short Term Let licenses on Albury Road.
- The property is currently unlicensed. However as the applicant was an existing operator before 01 October 2022, the property is currently operating as a Short Term Let until the Licence application is determined.
