# 1. PURPOSE OF REPORT

1.1 The purpose of this report is to report the uptake of the Property Level Protection Scheme and seek Committee approval to expand the current grant support in relation to increasing the percentage of costs and maximum amounts to be claimed. The scheme will reduce the impact on properties vulnerable to internal flooding.

## 2. RECOMMENDATIONS

That the Committee: -

2.1 Notes as of 12/08/2024 the uptake of the grant since 01/03/2023 is as follows.

- 2.2 Approves that the existing Property Level Protection Grant Scheme be changed to allow an increase in the percentage to be claimed back for the installation of Flood Protection schemes to property, from 50% to 75% with effect from the date of the Committee decision.
- 2.3 Notes that costs will be covered from the remaining amount of the original £500,000 budget, recorded in the General Fund Capital Programme and standing at £451,000.

- 2.4 Authorises the Chief Officer Operations Services to make grants of
  - i) 75% of the cost of installing Property Level Protection up to a maximum of £7500 per commercial property over 200m<sup>2</sup> ground floor area; and
  - ii) 75% of the cost of installing Property Level Protection up to a maximum of £3750 per commercial property less than 200m<sup>2</sup> ground floor area
  - iii) 75% of the cost of installing Property Level Protection up to a maximum of £3750 per domestic property

to eligible property owners on receipt of proof of expenditure.

2.5 Instructs the Chief Officer – Operations Services to monitor take up of the grant and to report back to the Committee in the form of a service update in Spring 2026 ahead of the Council Budget meeting.

#### 3. CURRENT SITUATION

- 3.1 Aberdeen City Council currently offers a Property Level Protection Grant Scheme to help owners protect their property from flooding. Domestic properties that meet the criteria can receive a grant for a Flood Protection survey of £150 and a grant up to 50% of the installation cost up to a maximum of £2,500. Commercial Properties that meet the criteria can receive a grant for a Flood Protection survey of £150 and a grant up to 50% of the cost of installing Property Level Protection up to a maximum of £5000 per property over 200m² ground floor area; and 50% of the cost of installing Property Level Protection up to a maximum of £2500 per property less than 200m² ground floor area. The approved budget from 2016/17 to 2020/21 was £500,000.
- 3.2 Over the previous years the uptake of the grant has been very slow and less than 20% of the budget has been spent.
- 3.3 Given the significant remaining budget and the low uptake, it is thought that increasing the percentage to be claimed back may encourage applications while costs have increased due to price rises.
- 3.4 All properties must meet at least one of the following criteria to be eligible for the grants; 1) The property has been internally flooded previously and actual damage has been sustained 2) The property is located on an area in risk of flooding shown on the SEPA flooding maps. 3) The property is located on an area in risk of flooding shown on the Integrated Catchment Model.
- 3.5 The installation grant will be paid out retrospectively based on proof of expenditure.
- 3.6 The grants will be a first come first served basis up to the budget allocated.

## 4. FINANCIAL IMPLICATIONS

4.1 While there will be financial implications arising from the recommendations of this report due to increasing the percentage of total cost to be claimed, the cost will be covered from the remaining amount of the original £500,000 budget. The remaining budget is recorded in the General Fund Capital Programme and stands at £451,000.

## 5. LEGAL IMPLICATIONS

5.1 Appropriate grant documentation will be entered into.

## 6. ENVIRONMENTAL IMPLICATIONS

- 6.1 The installation of Property Level Protection to residential and commercial properties will increase resilience and support climate change adaptation.
- 6.2 The installation of Property Level Protection to residential and commercial properties will reduce internal flood risk to these properties.
