UPDATE:

At their meeting in November 2024, the Anti-Poverty and Inequality Committee considered a report covering the regulations governing those deemed to have "No Recourse to Public Funds" and giving an overview of the measures in place to support this group of people in Aberdeen. As part of this report, the author included the 2022/23 return of the annual survey "Understanding Migrant Destitution: Local Authority support to those with No Recourse to Public Funds". At the time of considering the report, the Committee noted that the 2023/24 return for Aberdeen City had yet to be finalised and the Committee requested that a Service Update be provided giving further detail on (1) changes in local demographic data with regard to those subject to No Recourse to Public Funds and (2) the 2023/24 CoSLA return on the extent of Aberdeen City Council's support to those with No Recourse to Public Funds.
