PURPOSE OF REPORT

The purpose of this report is to assist elected members in making appointments to (a) certain sub-committees, working groups and task groups; (b) Council supported Trusts; and (c) other organisations which require elected members to be appointed to them.

A separate report on this agenda deals with appointments to outside bodies.

2. RECOMMENDATION(S)

The Council is recommended:-

- (a) to consider appointing members to the sub-committees, working groups and other groups shaded grey and in bold text within Appendix 1 to the report, by virtue of them requiring to be appointed by Council, or that they have meetings scheduled prior to the next meeting of the relevant committee;
- (b) to refer the remaining sub-committees, working groups and other groups within Appendix 1 to first meeting of the relevant committee as detailed in the far right hand column;
- (c) to consider appointing members to the Trusts listed in Appendix 2 to the report, noting the meeting dates detailed; and
- (d) to consider appointing members to the Boards listed in Appendix 3 to the report, noting the meeting dates detailed.

BACKGROUND/MAIN ISSUES

The Council is requested to consider the attached appendices and appoint members to the appropriate sub-committees, working groups and task groups of the Council, Council supported Trusts, Joint Boards and other miscellaneous bodies.

Each appendix lists the name of the group/organisation, the number of members required to be appointed by the Council and any further information relevant to each appointment.

The majority of sub-committees, working groups and task groups listed are relatively current, some of which have meetings fixed shortly. Sub-committees, working groups and task groups which have been in abeyance for some time have been omitted. If any sub-committee, working group or task group which has been omitted requires to be reconvened then the appointment of elected members to those groups can be considered by the appropriate committee in due course.

The previous Council in considering the potential composition of appointments of members to sub-committees, working groups, Council supported Trusts and organisations applied the following principles:-

- that no party shall hold half or more of the places on any subcommittee or working group; and
- (2) that the allocation of places on all sub-committees and working groups to each party reflect the make-up of the Council.

This guidance endeavours to assist the Council, if it so wishes, to apply the principles of the Local Government and Housing Act 1989 regarding political balance, although the statute itself is not in force.

The appointment of representatives to Trusts (Appendix 2) is fixed by the terms of the Trust Deed. If the Council was of a mind to amend its representation on Trusts, it would be necessary to ask those bodies if they will accept the Council's proposed amendments.

The appointment of representatives to outside bodies (as detailed at item 7 on the agenda) is fixed by the terms/rules of the outside body. If the Council was of a mind to amend its representation on outside bodies it would be necessary to ask those bodies if they will accept the Council's proposed amendments. This guidance on potential compositions can also be used by the Council in its consideration of item 7.

The appointment of representatives to Boards (Appendix 3) is fixed by statute and is not open to amendment.

Appendix 1 to the report sets out the number of Council representatives required and any additional information which affects the Council's appointments. Bearing this in mind, the table below provides examples

of potential compositions for the Council's appointments to these groups.

This is not an exact exercise in proportionality because of the varying number of members on these groups. It is not possible to carry out this exercise in the same way as the composition of committees is determined by the Council at item 5 on the agenda which results in a more exact mathematical approach. This report treats each group individually and the principles agreed by the Council would be applied to each group on an individual basis.
