Aberdeen Local Licensing Forum – 19 June, 2013

Forum Membership

1. PURPOSE OF REPORT

- 1.1 To set out the current issues relating to Forum membership and to suggest ways in which these can be addressed.
- 1.2 The paper also flags up some of the issues raised with regard to the purpose and direction of the Forum, based on responses to the questionnaire issued after the last meeting.

2. MAIN ISSUES/BACKGROUND

- 2.1 The Licensing (Scotland) Act 2005 sets out the requirement for local licensing forums to be established. An extract of the relevant provisions is attached at appendix A, and the Forum will note that membership can vary between 5 and 21 (the maximum was increased from 20 by the statutory instrument dated September 2011). The Forum currently has a membership of 18 and the quorum of the group is therefore 9. The requirement to have a quorum of half is set out in the 2005 Act and is therefore not a locally set provision. Membership of the Forum has been delegated by the Council to the Forum to determine, but any differences of opinion which cannot be resolved would be referred back to the Council to make a final decision.
- 2.2 Membership should include, insofar as is possible, representatives of the undernoted categories. The current representatives are listed:-
 - Holders of premises licences and personal licences George Wyatt, Craig Adams, Shelly Wall and Gerard Rattray (4)
 - Chief Constable Inspector Barry Skinner/David Paterson (1)
 - Persons having functions relating to health, education or social work David Wright (Education), Linda Smith and Sandy Kelman (Health), Kay Dunn (Social Work), Craig Cole (Samaritans), Mike Saint and Garry Burnett (Community Safety) (7)
 - Young People Barry Black and Callum Martin (2)
 - <u>Persons resident in the Forum's area</u> Ken Eddie, Allan McIntosh, Councillor Martin Greig (3)
 - <u>Licensing Standards Officer</u> Diane Sande/Raymond Morrison (1)
- 2.3 The last two meetings (13 February and 24 April) were not fully quorate. The meeting on 13 February was quorate at points of the meeting, but when those in attendance dipped below 9 as members left to attend other meetings, it became inquorate. The meeting on 24 April was attended by 6 members only.
- 2.4 Those present on both occasions expressed their concern at the low numbers, and asked that the clerk write to all members reminding them of the need for a quorum, of the facility to send substitutes, and of the provision in the constitution (also attached at appendix B) to permanently exclude members who miss three meetings consecutively. The views of Forum members were also sought on the following:-

- 1. Which groups/organisations do you feel are crucial to the membership of the Local Licensing Forum?
- 2. Do you see any scope for reduction of the Forum's membership?
- 3. Are there any current obstacles to you attending Forum meetings which could be removed by the Forum?
- 4. What is your understanding of your role on the Forum?
- 5. Do you wish to continue as a member of the Forum?
- 6. Would you support the idea of a smaller membership with additional observers attending meetings?

2.5 Responses are summarised below:-

- Mixed support for reducing numbers, the majority of which was in favour of reducing membership.
- One suggestion was to reduce the core members to one representative of each of those groups listed at paragraph 2.2 above. Another was to reduce membership to 12, consisting of one representative of each of the following –
 - 1. Licensing Standards Officer
 - 2. NHS Grampian
 - Education
 - 4. Children's Services
 - Police Scotland
 - 6. Licensed Trade
 - 7. Community/Civic Forum
 - 8. Aberdeen City Alcohol and Drugs Partnership
 - 9. Scottish Fire and Rescue
 - Third Sector
 - 11. Community Safety Partnership
 - 12. Young People

In this scenario, people could attend as 'associate' members in their own right and be copied into the papers. These 'associate' members could also act as substitutes for 'core' members as and when appropriate. The Forum seldom has a vote (other than for the chair / vice chair) and as such these 'associate' members would not be missing out on anything and would be allowed to contribute at the meeting. The meetings after all, are all open to members of the public. The 'associate' members could form part of the LLF when joint meetings are held with the Licensing Board.

- Further suggestion that the representatives of residents and the representative of the Samaritans become observers and that only one youth or student representative have full membership.
- Two members said the meeting time (2.00pm) was an obstacle. One expressed a preference for a morning meeting (10.00am or 11.00am). Other members stated that with the advance notice provided (up to 12 months, as meetings are agreed at the end of the calendar year) this was not a problem.
- Roles on the Forum were queried, both in terms of the ability of some groups to represent others, and the training required to be a Forum member which could be increased, particularly around legislative changes and the ability of the Forum to monitor the Board around the five licensing objectives.
- Information received within the Forum to inform its work was felt to be crucial to its effectiveness moving forward.
- The role of the Door Supervisors Working Group was felt to be a crucial one which seemed to have been forgotten about.

- Discussion is needed on the role of the Forum in the future, particularly around the five licensing objectives and what can be achieved in terms of these.
- Understanding of role as per section 11 of the Act to keep under review
 the operation of the Act in this area, and the performance etc of the Board,
 and to give advice and recommendations to the Board.
- Forum has become overwhelmed by the amount of focus being placed on two of the licensing objectives, Protecting Children From Harm and Protecting and Improving Public Health.
- Too much pressure placed on Board about how it will uphold the licensing objectives.
- Wish to improve relationship with Board, including more joint meetings and feedback from Board on performance of Forum.
- Clearer direction and broader agenda required, to assist members to make a contribution. It was felt that this would improve attendance.
- One respondent, Mike Saint, indicated that he would be happy to withdraw from the Forum (email attached at Appendix A).
- 2.6 To address some of these points, there is scope within the terms of the legislation to reduce the number of members, on the proviso that there is representation of those groups and persons listed at 2.2. Whether these groups/persons would need to be voting members if one of the above suggestions were to be followed needs to be looked into further. Meeting times can of course be moved to accommodate the majority of members.
- 2.7 It would appear from the submissions above that, as well as membership, the main issues are focused around training and information for Forum members to assist them in their role, clarifying the purpose and focus of the Forum, and representation. As well as addressing issues of membership, the Forum may also wish to consider revising its workplan to address any issues of lack of clarity. It seems that there also needs to be a discussion around training.
- 2.8 The Forum is also asked to note that there are some members who have missed three consecutive meetings (attendance record attached at appendix B), and so decisions should be taken on whether they should continue as members. As well as this, there are two further applications for consideration when the Forum is quorate (appendix C).
- 2.9 The Forum is now asked to determine whether it wishes to reduce its membership, and if so, how it would like to tackle this.

3. THE WAY FORWARD

3.1 Whilst it is a matter for the Forum to make decisions on its membership, this power has been delegated from the Council, and if agreement cannot be reached, the Council will be asked to make a determination. It is suggested that the Forum has a discussion around the issues raised and works towards an agreed position moving forward.


