MINUTE OF PREVIOUS MEETING OF 28 JANUARY 2014

2. The Committee had before it the minute of its previous meeting of 28 January, 2014.

The Committee resolved:-

CCTV - TAXIS AND PRIVATE HIRE CARS - CG/14/003

5. As agreed at the start of the meeting (Article 1 of this minute refers), the Committee received a deputation from Graeme McColl, on behalf of Aberdeen Taxi Group.

Mr McColl advised that there was a need to undertake proper consultation with the taxi trade in relation to CCTV in taxis and private hire cars. He made reference to the Council's proposed enforcement powers which in his view, would require training for the officer concerned to ensure that the appropriate type of CCTV was installed. He also indicated that guidance for the taxi trade would need to be prepared by the Council and that the trade would have to be very careful of a 'big brother' situation occurring. He concluded by advising that he was in support of taxi drivers being able to prove what happened in a particular situation, but explained that he was wary of the potential hazards within the proposal.

In response Paul Connolly, Solicitor, Litigation and Licensing advised that the Taxi Consultation Group had been consulted twice on CCTV in taxis private hire cars. Furthermore, full consultation with all licence holders was already inbuilt into the process and would be undertaken prior to a further report being submitted to the Committee for its consideration.

The Committee had before it a report on behalf of the Director of Corporate Governance on the recent developments towards CCTV in relation to taxis and private hire cars and proposed an appropriate legal and policy response.

The report recommended:-

that the Committee -

- (a) notes the draft policy on CCTV in taxis and private hire cars;
- (b) instructs officers to write to the Information Commissioner's Office Scotland (Data Protection), the Equality and Human Right Commission Scotland (Human Rights) and Police Scotland, Aberdeen City Division (Crime Prevention/Detection) to seek their views on the draft policy and thereafter to report back; and
- (c) agrees in principle to the proposed new CCTV licence conditions for taxi and private hire car licences.

The Committee resolved:-

- (i) to approve the recommendations;
- (ii) in relation to recommendation (b) above, to ensure full consultation with affected licence holders would be undertaken; and

(iii) to ensure that officers also take into account the use of rear facing cameras and how access to the recorded data will be dealt with and include details of these considerations within the report.

LICENCE APPLICATION FEES - APRIL TO MARCH 2015 - CG/14/039

6. As agreed at the start of the meeting (Article 1 of this minute refers), the Committee received a deputation from Graeme McColl, on behalf of Aberdeen Taxi Group.

Mr McColl advised that the taxi trade could see the benefit to every driver if the proposed reduction of fees were to be approved, however he indicated that if the fees were to be increased in a few years to take into account any future commissioning of surveys, for example the forthcoming Taxi Demand Survey, then this would give a false reduction. He indicated that if the 2014 budget included costs for a Taxi Demand Survey, then he suggested that the fees for 2014 should remain at the current level. He explained that the surplus could be used to look at increasing enforcement work, with the possibility of employing another Enforcement Officer which would benefit the trade and the Council.

The Committee had before it a report by the Director of Corporate Governance, which outlined the proposed level of application fees for licences administered through the Civic Government (Scotland) Act 1982 and other miscellaneous statutes and to obtain the Committee's approval for the fees to come into affect on 1 April 2014.

The report recommended:-

- (a) that the Committee approves the fees set out in appendices 1 and 2B of the report; and;
- (b) that all other existing fees were to remain at their current level.

The Committee resolved:-

- (i) to approve the fees set out in appendix 1; and
- (ii) to accept Aberdeen Taxi Group's request that all other existing fees remain at their current level and that further consideration be given to the use of any surplus in the budget.

Mr Ally Thain, Private Sector Housing Manager, advised that upgrading works on the premises had been completed, however the safety work instructed by the Scottish Fire and Rescue Service had not been completed, although this was not the reason it was before the Committee today.

The Committee heard from the respondent. The respondent alleged that there had been anti-social behaviour at the applicant premises and on occasion the Police had been called out.

Members inquired whether or not there had been Police had been consulted in this regard as per the Committee's standing request for them to check if there had been Police involvement with the applicant premises.

The Police representative explained that their records had not been checked on this occasion. He highlighted that the Committee had not made a formal request to Police Scotland and as such no procedure was in place. The Police had not been made aware of the parameters of the request or its legal basis. Furthermore, he wished to know if the request was in addition to the standard criminal background inquiry on applicants.

The legal adviser explained that the Committee may make inquiries about the application as it thinks fit. If they make such inquires they would then make a report of any matter arising therefrom which they consider relevant to the determination of the application. In those circumstances, the Committee must give the applicant a copy of any such report, which then must be accompanied by a notice specifying the period (of not less than 7 days from the date on which the notice is given) during which the applicant may give a written response to the Committee on any matter set out in the copy report. This procedure would require to be completed before the application was considered. The Committee thereafter must consider the report at the hearing to determine the application. It was suggested that the Committee clarify the parameters of their request and thereafter a formal letter of request could be issued to the Police.

Members clarified that these inquiries would be separate to the standard Police inquiry on each application. Where a respondent alleges Police involvement at the applicant premises they wished the Police to be asked whether or not and such complaints had been made to them and if they had been required to attend

the premises to resolve matters. The Committee did not seek details of the incidents only whether or not they had occurred.

The Committee resolved:-

- that their request be made formally to Police Scotland, Aberdeen City Division;
- (ii) that the main circumstances in which such an inquiry would be made to the Police would be where a respondent alleged in their letter of representation that the Police had been called out to the applicant premises; and
- (iii) that the Private Sector Housing Manager would highlight the allegation to the Police when he submits the application in the ordinary course of submitting the application to them to make their standard inquiries.

The Committee then heard from the applicant, Ursula George, in support of the application.

Councillor Townson, seconded by Councillor Kiddie moved: that the application be granted.

Councillor Delaney, seconded by Councillor Corall moved as an amendment:that the application be granted for a period of 12 months, during which
time the premises be monitored in terms of any anti social behaviour
incidences.
