An Equalities and Human Rights Impact Assessment was carried out into the proposal to meet the costs of refurbishing the Skyline restaurant for ShopMobility, and reconfiguring the revenue support grant for ShopMobility and Aberdeen Action on Disability from Social Care and Well Being to the Disability Strategy Action Plan budget. Following a review of commissioning, the Director/Head of Service has advised that Social Care and Wellbeing grants are under review as part of the budget process and it is likely that funding for these organisations will not be available for the year 2010/2011. Funding for the costs to refurbish the Skyline restaurant for ShopMobility and future funding support for ShopMobility and Aberdeen Action on Disability would be reconfigured to the Disability Strategy Action Plan budget, as an appropriate funding source. This would secure the short to medium term future of both organisations and help the Council meet its obligations under the General Duty on disability to promote positive attitudes towards people with disabilities and promoting equality of opportunity. The impact assessment found no negative impacts with this proposal.

ShopMobility is a well-used and important service to people with disabilities and the retail sector in Aberdeen. Over the past three years, use of the wheelchairs and electric scooters has increased each year. Locating the facility within the Bon Accord shopping centre will enhance its visibility and encourage even more use. Aberdeen Action on Disability is the only user led organisation working for people with sensory and physical disabilities in Aberdeen. Their active involvement with the community encourages independence and gives hope to many that someone cares.
