#### RENEWAL OF A TAXI DRIVER'S LICENCE

1. With reference to article 6 of Appendix B of the minute of the meeting of the Licensing Committee of 19 January 2016, the Sub Committee had before it (1) an information sheet prepared by the Head of Legal and Democratic Services; (2) judgement by the Sheriff; (3) correspondence from the Chief Constable, Police Scotland, c/o Aberdeen City Division; and (4) a range of documents submitted by the applicant.

As a preliminary matter, the applicant's Counsel referred to the Sheriff's judgement that a differently constituted committee should reconsider the application and therefore objected to the current membership of the Sub Committee.
