#### 6. REPORT

## 6.1 Future Jobs Fund

The Fund was announced in 2009 and the money is to be spent between October 2009 and March 2011. As the Future Jobs Fund is a challenge fund, not all organisations that submit bids will be successful. The fund is run by the Department for Work and Pensions (DWP) in partnership with the Department for Communities and Local Government (CLG) and with input from Jobcentre Plus Regional Government Offices in England and Devolved Administrations in Scotland and Wales.

The Fund aims to create 170,000 additional jobs, primarily aimed at 18-24 year olds who have been out of work for nearly a year to deliver real benefits to communities. The Future Jobs Fund is a part of the Young Person's Guarantee. From early 2010, everyone in between the ages of 18 and 24 who has been looking for work for a year will get an offer of a job, work experience, or training lasting at least 6 months, specifically targeting 50,000 jobs in unemployment hotspots and expect around 10,000 of the 170,000 jobs created to be green jobs.

Bids are made from organisations with the capability to create real jobs that deliver community and/or environmental benefit and are suitable for young people who have been claiming Jobseeker's Allowance for approaching a year.

The Future Jobs Fund is open to any organisation from the public, private or third sector from across Great Britain (England Scotland and Wales). In the majority of cases bids are expected to come from partnerships led by upper tier Local Authorities or Third Sector organisation but this does not exclude other organisations from applying.

As part of the 2010 Budget the Chancellor has extended the Future Job Fund initiative for another year.

#### 6.2 Environment Services Bid

There are criteria set down by the bid that Environment Services must follow -

- Jobs created must be additional jobs, lasting at least 6 months for each individual.
- Job must deliver work that benefits local communities.
- Job must include support for employees to move into long-term sustained employment.
- The jobs must not replace existing vacancies and must not lead to another individual losing or reducing their paid employment.
- The work must be for at least 25 hours a week paid at least the national minimum wage.

Environment Services have made a long term commitment to their bid and will look to support as many jobs as possible through the scheme.

The jobs created within Environment Services will be a job defined in the fund as a 'green job'. This type of job provides a good or service that leads to environmental improvement.

The jobs will be involved in work including green space projects, clean ups, grass cutting, graffiti removal, street sweeping, tree squad works, winter gardens and partnership working with voluntary groups i.e. Aberdeen Greenspace.

The jobs created through the bid will deliver work that provides direct benefit to the local community.
