**Description of services/functions:-** Testing Buurtzorg Principles within Neighbourhood Care. A high level description of this project is set out in the attached Project Summary and a detailed Business Case is also attached.

**Reference to the integration scheme:-** This project will contribute to the evidence that the Partnership will be obliged to demonstrate how well the nine National Health and Wellbeing outcomes are being met (section 2). The project will contribute to the requirement in Annex 2, Part 1 in relation to Section 12, General Social Welfare Services of Local Authorities, Section 13ZA Provision of services to incapable adults, Section 13B Provision of care or aftercare. The project will contribute to the following services provided by the Local Authority which are integrated: social work services for adults and older people, services and support for adults with physical disabilities and learning disabilities, Carers support services, Community Care Assessment teams, support services, health improvement services, aspects of housing support, re-ablement services.
