1: Purpose of the Report

- 1.1. The purpose of this report is to seek IJB approval for the publication of the four Locality Plans for Aberdeen City Health and Social Care Partnership which are a requirement of the Public Bodies (Joint Working) (Scotland) Act (2014).

2: Summary of Key Information

- 2.1. The Public Bodies (Joint Working) (Scotland) Act 2014 requires that the Strategic Plan prepared by the IJB must cover at least two localities, and it is for the IJB to determine these areas. In addition, Scottish Government released informal guidance outlining their expectations with regard to working at a locality level and in particular the levels of engagement with practitioners, service users, carers and the community.
- 2.2. Aberdeen City HSCP has four localities, a map of these can be found within each plan. The Localities, under the direction of the Locality Leadership Groups (LLG) have undertaken a process over the course of this year to engage with stakeholders in the production of its first locality plans. Details of engagement strategies are included within each plan. Each of the LLGs have representation from a broad range of stakeholder including the 3rd and Independent Sectors and a range of professionals and providers, including GP practices, pharmacists, dentists, AHP"s, nurses, social work and community members.

- 2.3. Initially work was progressed to develop Locality Profiles to give an overview of the current situation within these defined areas with the support of the national LIST team (Local Intelligence Support Team) within the Information and Statistics Division (ISD) of the Scottish Government. This along with engagement with local communities and survey information set out a baseline from which the four Leadership Locality Groups (LLGs) could identify particular challenges for their area, relevant high level priorities as well as measurement of impact.
- 2.4. The plans are living, iterative documents which will be continually worked on within the health and social care locality groups. They look to work with the strengths and assets of each area to enable better health and wellbeing for its citizens who live or work in the area. The Community Planning Partnership Aberdeen is also implementing locality planning in light of separate statutory obligations but linkages to and from both have been made. Locality plans will also reflect future reviews of the Integration Joint Board's (IJB's) own Strategic Plan to ensure alignment.
- 2.5. The next phase will be focused on the high level priorities being developed into programmes of work by the LLG, the timescale for completion of which is April 2019 in line with the strategic plan refresh. Transformation projects have also been included in relevant plans to reflect the city-wide learning and potential spread across the city from each piece of work. For example, link workers and acute care at home.



