### 1. PURPOSE OF REPORT

To provide an update on progress to date in relation to the proposed amalgamating of charitable trusts with assets below £20,000 into one charitable trust for the benefit of the Citizens of Aberdeen, as instructed by Finance and Resources Committee of 17 September 2009

#### 2. RECOMMENDATION(S)

It is recommended that the Committee:-

- (a) Notes the actions taken by officers to date.
- (b) Approves the outline proposals for a new charitable trust to be established with the elected members who are members of the Finance and Resources committee as trustees.
- (c) Approve the proposal that charitable trusts with assets of less than £20,000 are to be transferred into the new trust.
- (d) Notes the likely timescales for completion of the work.
- (e) Approves the outline of actions proposed by officers to take matters forward

#### 3. FINANCIAL IMPLICATIONS

There are no specific financial implications at this time, however OSCR can apply fines of up to £2,500 on charities failing to comply with their regulations.

4. SERVICE & COMMUNITY IMPACT

It is essential that the charitable Trusts are managed in such a way that they continue to support the aims within the community for which they were established.

# 5. OTHER IMPLICATIONS

Failure to comply with the requirements of the regulator OSCR could result in action against the Council, which could include fines as well as loss of reputation.

## 6. REPORT

# **Background**

- 6.1 The report to Finance and Resources Committee of 17 September 2009 outlined the implications for the various charitable trusts controlled and administered by the Council and the procedures which required to be brought into force to comply with the requirements of OSCR.
- 6.2 In approving the recommendations within the report, the Committee additionally instructed officers to write to OSCR seeking approval for the amalgamating of charitable trusts with assets below £20,000 into one charitable trust for the benefit of the citizens of Aberdeen, and for a further report to be presented to this committee to provide an update on progress to date.
- 6.3 A further report to Finance and Resources Committee of 10 December 2009 presented financial information and a Trustees Annual Report relating to the charitable trusts administered by the Council to Committee for approval. This information was required for presentation to OSCR to comply with their requirements.

### **Proposals and Actions**

- 6.4 In accordance with the Committee's instructions a letter was sent to OSCR outlining the proposals for amalgamation. A response was received advising that in principal the proposal was acceptable and advising that the first step would be top establish a new charitable trust to which the assets of the other charitable trusts could be transferred.
- 6.5 It is proposed that a new charitable trust be established with the elected members who are members of the Aberdeen City Council Finance and Resources Committee as the trustees. The trust would be established for the benefit of the citizens of Aberdeen with its specific charitable purposes matching those of the existing charitable trusts which are to be transferred into it.
- 6.6 Once the new charitable trust is established it will be necessary to submit a request to OSCR to wind up each of the existing charitable trusts with assets below £20,000 and to transfer their assets to the new one. On receipt of each approval the necessary financial adjustments will be carried out.
- 6.7 OSCR has asked that the work be undertaken in separate batches to take account of their own staff's workload. Taking account of this and uncertainties as to how long the different processes will take it is unlikely that the reorganisation will be completed before March 2011 at the earliest.

- 6.8 Returns for the charitable trusts will require to be presented to OSCR for the year to 31 March 2010.As the amalgamation process will only get under way now these will be in a similar form to those presented last year. However it is intended that individual Trustee reports will be presented for those charitable trust where amalgamation is not being considered. A single Trustee Report will be provided to cover charitable trusts due to be amalgamated.
- 6.9 In addition to ensure compliance with OSCR requirements it is proposed that the status of all of the charitable trusts be reviewed as part of this process. If thought appropriate proposals would be put to committee for approval to remove them from the charity register, or to transfer their assets to another more relevant external charitable body.
- 6.10 A further update to Committee on how this exercise is progressing will be provided to Committee along with the proposed returns to OSCR before the end of the year.
- 6.11 Attached at Appendix 1 are details of the assets of all the charitable trusts under review showing the value of their assets as at 31 March 2010. It should be noted that these figures are subject to audit. Those with assets of less than £20,000 have been grouped in broad categories which is the suggested basis of allocation of income from the new trust.
