1. PURPOSE OF REPORT

The purpose of this report is to seek delegated authority from Committee to submit a response on behalf of Aberdeen City Council to the Scottish Government on the Review of Part 1 of the Children (Scotland) Act 1995 and creation of a Family Justice Modernisation Strategy by 7 August 2018.

2. RECOMMENDATIONS

It is recommended that Committee:

- 2.1 Provide delegated authority to the Chief Operating Officer to submit a response to the consultation on the above paper by 7 August 2018; and
- 2.2 Agree that the Convenor be consulted on the proposed response prior to its submission.

3. BACKGROUND

- 3.1.1 The Children (Scotland) Act 1995 has been a central piece of legislation in relation to private and public law in respect of children for over two decades. With the passage of time there are a number of aspects of this Act which require to be updated and this consultation sets out how the Scottish Government intend to do so.
- 3.1.2 This is a significant consultation paper and covers a number of areas including the following:

- 12. Domicile of persons under the age of 16
- 3.1.3 The Chief Officer Integrated Children and Family Services with the involvement of relevant staff from across the Council, particularly Legal Services, has begun to coordinate a response to this consultation paper.
