1. PURPOSE OF REPORT

1.1 To seek appointments to sub committees, partnerships, joint boards and working groups; and nominate members to be appointed to a small number of outside bodes.

2. **RECOMMENDATIONS**

That the Council:-

- 2.1 note that the membership number and composition of the sub committees detailed in Appendix A will be determined by the respective committees;
- 2.2 approve the membership number for each working group as detailed in Appendix B; set a composition for each and appoint members on the basis that names can be provided to the Chief Officer Governance after the meeting and that he be authorised to finalise membership where required;
- 2.3 set a composition for each of the joint committees/partnerships as detailed at Appendix C, and appoint members and substitutes (where applicable) on the basis that names can be provided to the Chief Officer Governance after the meeting and that he be authorised to finalise membership where required;
- 2.4 appoint 9 members to the Appointment Panel, agree the composition of the Panel and appoint members on the basis that names can be provided to the Chief Officer Governance after the meeting and that he be authorised to finalise membership where required;
- 2.5 consider the appointment or nomination (as appropriate) of members to the outside bodies listed in Appendix D, and appoint members on the basis that names can be provided to the Chief Officer Governance after the meeting and that he be authorised to finalise the membership where required; and

2.6 note that the remaining outside body appointments, or nominations, will be reported to the Council meeting on 29 June 2022 for determination.

3. CURRENT SITUATION

3.1 **Sub Committees/Working Groups**

- 3.1.1 Appendix A to the report details the Council's current sub committees. Please note that in accordance with Standing Order 47.10, the respective parent committee will set the membership of the sub committee.
- 3.1.2 Appendix B to the report details working groups and sets out the current representatives required and any additional information which affects the Council's appointments. Working groups have no delegated powers and support the Council for any function deemed necessary and it is proposed that the Council be supported by the working groups as detailed in Appendix B. The Council is asked to approve the membership number for each working group as detailed in Appendix B; set a composition for each and appoint members on the basis that names can be provided to the Chief Officer Governance after the meeting and that he be authorised to finalise membership where required.

3.2 Joint Committees/Partnerships

3.2.1 Appendix C details other joint committees and partnerships and sets out the current representatives required and any additional information which affects the Council's appointments. The Council is asked to set a political composition for each and appoint members on the basis that names can be provided to the Chief Officer - Governance after the meeting and that he be authorised to finalise membership where required.

3.3 Appointment Panel

3.3.1 The Council is requested to re-establish the Appointment Panel of elected members which is responsible for the appointment of Chief Officers in terms of Appendix 3 to the Council's Standing Orders. The Appointment Panel previously comprised 9 elected members and is chaired by the Convener of the City Growth and Resources Committee, unless otherwise agreed by the Members on the Appointment Panel.

3.4 Appointments to Outside Bodies

- 3.4.1 The Council is requested to consider making appointments or nominations to the small number of outside bodies listed within Appendix D, noting that all other outside body appointments or nominations will be reported to the Council meeting on 29 June 2022 for determination.
- 3.4.2 A review of outside bodies was undertaken in 2021 and reported to Council in December 2021, alongside the updated policy which set the criteria on which Aberdeen City Council will appoint or nominate Elected Members to Outside

Bodies, as well as guidance on Elected Members' roles and responsibilities once appointed; and this policy was approved.

3.5 **Possible Compositions**

3.5.1 The table below provides examples of potential compositions for the Council's appointments to working groups, joint committees/partnerships and outside bodies. This is not an exact exercise in proportionality because of the varying number of members on each body. This report treats each group/body individually and the principles agreed by the Council would be applied to each group on an individual basis.
