1. PURPOSE OF REPORT

1.1 To provide a report on the formation of a Working Group to support the work of the Committee.

2. RECOMMENDATIONS

That the Committee:

- 2.1 Note the approach taken to obtaining nominations for the working group;
- 2.2 Agree that all respondents be invited to an information session on the work of the Committee and that officers subsequently confirm the respondent's commitment for the initial twelve month period;
- 2.3 Instruct the Chief Officer Early Intervention and Community Empowerment to thereafter appoint twelve of the respondents to the working group for an initial period of twelve months;
- 2.4 Request that members of the working group identify a member to take the currently vacant position of external adviser to the Anti-Poverty and Inequality Committee starting in May 2023, and

2.5 Request that the working group, with support from the Chief Officer – Early Intervention and Community Empowerment and the External Advisers, submit a report to the Anti-Poverty and Inequality Committee in June 2023 detailing their thoughts on anti-poverty and inequality issues in Aberdeen and making recommendations on actions believed necessary to tackle these issues.

3. BACKGROUND

- 3.1 At the meeting of Aberdeen City Council on 13 October 2022, the Council agreed to the appointment of five external advisers to the Anti-Poverty Committee, leaving one seat vacant, and to the formation of a working group of partner agencies and lived experience to support the ongoing work of the Committee.
- 3.2 On 20 January 2023 an online survey was published on the Council's Citizen Space site, promoted through our communications team and online media, to encourage participation in the working group. The communications messages were promoted again during the survey period.
- 3.3 The survey, accessible here, was open to residents of Aberdeen; those who work for an organisation in Aberdeen who support people experiencing poverty, and to those who volunteer for an organisation in Aberdeen who support people experiencing poverty.
- 3.4 The question set relates to firstly the six households categories identified through the Child Poverty (Scotland) Act 2017 and Bright Start Best Futures policy issued by the Scottish Government; and the demographics identified through the Population Needs Assessment and the External Adviser's report to the Anti-Poverty and Inequality Committee on 23 November 2022.
- 3.5 The online survey closed on 3 February 2023, and at that point 21 responses had been received. Appendix 1 contains anonymised data reflecting the responses.
- 3.6 It is proposed that these respondents be invited to an information session to provide further information about the Committee, External Advisers and the role of the working group, and to confirm each respondent's commitment to the working group for the initial twelve-month period.
- 3.7 Following this session, it is proposed that the Chief Officer Early Intervention and Community Empowerment appoint twelve of the respondents to form the working group, with a report to be submitted to the June Committee meeting identifying the appointees.










