#### 1. PURPOSE OF REPORT

1.1 To seek approval for a visit to Rome in May 2024.

## 2. RECOMMENDATION(S)

That the Committee:

2.1 Approves the Lord Provost plus one officer to attend the Vatican Summit: From Climate Crisis to Climate Resilience, in Rome between 15-17 May 2024.

#### 3. CURRENT SITUATION

- 3.1 In response to Pope Francis' call for urgent action in relation to climate change, the Pontifical Academy of Sciences and the Pontifical Academy of Social Sciences (of the Vatican) have organised a 3-day summit at the historic Casina Pio IV in the Vatican Gardens. Invited are a range of experts and scholars including city mayors from around the world to provide examples and highlight best practice in relation to climate adaption and resilience.
- 3.2 The summit will focus the three pillars of mitigation, adaptation and societal transformation, with discussion around the following themes:
  - Impact on energy, food, air, water,
  - governance
  - · addressing climate change
  - financial resilience
  - equity and a just transition
- 3.3 Through the World Energy City Partnership (WECP), of which Aberdeen is a founding member, the council has been invited to attend, this recognises the involvement of cities in leading the responses to climate change around the world.

- 3.4 This is an excellent opportunity, in a global context, for Aberdeen to reinforce its Net Zero Vision and accompanying reputation as a global leader in the development of renewable green energy, highlight the opportunities for investment in the city and region, the delivery of the city's Vision through its Net Zero Aberdeen Routemap, Climate Adaptation Framework and allied place-based strategies, including the drive for a Just Transition.
- 3.5 At the committee meeting on 30 January 2024, members adopted the following criteria to appraise the benefits of international engagement and activities, including the overseas travel and conference attendance proposed to support these activities, the following criteria are considered:
  - 1. Engagement aligns with and reflects relevant aspects of the Regional Economic Strategy. This may be through the opportunity to promote regional strengths (energy, skills, entrepreneurship and innovation); to address regional challenges (economy diversification, skills and labour supply, city centre redevelopment); to support delivery of objectives; or to progress growth and internationalisation of key and nascent North East industries (energy, food and drink, finance and business services, tourism, creative, digital and life sciences).
  - 2. Engagement creates opportunities to attract inward investment to Aberdeen, again in line with the Regional Economic Strategy.
  - Where appropriate, overseas travel is supported by SDI, DBT, Scottish or Aberdeen and Grampian Chambers of Commerce, and/or city stakeholders (e.g. Opportunity North East, Net Zero Technology Centre, Energy Transition Zone Ltd).
  - 4. WECP attendance at AGM and Board meetings.
  - 5. Activity with MoU partners where attendance by Elected Members is requested and has been discussed with Co-leaders.
- 3.6 Based on these criteria, the overseas travel proposed in 2.1, aligns to criteria 1 and 2.

### 4. FINANCIAL IMPLICATIONS

4.1 As this trip is additional to those approved by committee in January 2024 approval is required in relation to the proposed travel to Rome which is estimated at up to £2,000. The costs for will be met via a mix of Civic and Climate & Environment Policy Service budgets.

### 5. LEGAL IMPLICATIONS

5.1 Scottish Government guidance details that travel and subsistence expenses may be claimed by Elected Members for approved duties, including "the carrying out of any other duty approved by the local authority, or anything of a class so approved for the purposes of, or in connection with, the discharge of functions of the local authority or any of its committees of sub-committees."

5.2 Local authorities have a statutory duty to secure best value as per section 1 of the Local Government in Scotland Act 2003. The Council has travel policies for both members and officers. All travel should be booked in accordance with these policies to ensure cost-effective travel arrangements.

## 6. ENVIRONMENTAL IMPLICATIONS

6.1 The report recommendations have a negative environmental impact, namely an increase in carbon emissions due to air travel. To minimise this we will look to book 'green' airfares only.
