1. PURPOSE OF REPORT

This report presents the 2025 Population Needs Assessment (PNA) for Aberdeen City. The Population Needs Assessment is a key source of evidence which informs the key priorities for Community Planning Aberdeen and Aberdeen City Council and provides an updated evidence base for the development of the Local Outcome Improvement Plan 2026-36 and Locality Plans.

2. RECOMMENDATION

That Council:-

2.1 note the Population Needs Assessment 2025 as contained at appendix 1.

3. CURRENT SITUATION

- 3.1 In 2023, Community Planning Aberdeen published a Population Needs Assessment to provide a comprehensive picture of Aberdeen City as seen through a broad range of data sets. The document was used as the evidence base for identifying the shared priorities for public services in Aberdeen and updating the Local Outcome Improvement Plan 2016-26 approved in April 2024 for the last time before 2026 which marks the end of the current plans' 10 year timeframe of 2016-2026. A new Local Outcome Improvement Plan and Locality Plans are to be developed for 2026-2036 in order to continue to meet the requirements of the Community Empowerment (Scotland) Act 2015.
- 3.2 Over the last year the Community Planning Partnership has been working towards the improvement aims within the Local Outcome Improvement Plan with a view to improve outcomes for the people of Aberdeen.

POPULATION NEEDS ASSESSMENT 2025

- 3.3 The revised Population Needs Assessment for 2025, appendix 1, provides an updated evidence base for the refresh of the Local Outcome Improvement Plan 2026-36 and underpinning Locality Plans.
- 3.4 The Population Needs Assessment is a systematic process for gathering and analysing data and information about the wellbeing and needs of people and communities across Aberdeen. It helps determine the gaps between current and desired outcomes and is used to identify priorities for Community Planning Aberdeen that are included in the Local Outcome Improvement Plan.
- 3.5 The layout of the Population Needs Assessment has been updated and is structured around 5 themes which reflect the Social Determinants of Health. The Social Determinants of Health contribute to the unfair and avoidable differences in outcomes seen across the city of Aberdeen. Social and economic factors, health behaviours, access to health services and the physical environment in which people live all contribute to shaping people's health. Each section covers data relating to the themes as follows:

Children, families and lifelong learning

- Give every child the best start in life
- Enable all children, young people and adults to maximise their capabilities and have control over their lives

• Economic stability

· Create fair employment and good work for all

Communities and housing

• Create and develop healthy and sustainable places and communities

Neighbourhood and environment

Pursue environmental sustainability and health equity together

Health and Social Care

- Ensure healthy standard of living for all
- Strengthen the role and impact of health prevention
- 3.6 Public Health Grampian in partnership with the Health Determinants Research Collaboration and Collaboration for Health Equity in Scotland have reviewed the data sets included to increase understanding of the levels of inequality that exist and provide a common descriptor of vulnerability across the City.
- 3.7 As in previous years, the Population Needs Assessment has been aligned to the Sustainable Development Goals (SDGs). The Sustainable Development Goals recognise that ending poverty and other deprivations must go hand-in-hand with strategies that improve health and education, reduce inequality and support economic growth which doesn't compromise the climate and nature issues at the core of our Local Outcome Improvement Plan.

NEXT STEPS

3.8 The revised Population Needs Assessment for 2025 provides an updated evidence base for the development of the Local Outcome Improvement Plan and Locality Plans 2026-36. The Population Needs Assessment (PNA) is a key source of data for all community planning partners to utilise in their own organisations to inform their individual strategic plans. This includes the Council's Corporate Delivery Plan.
